2. **Review and approve minutes of last meeting** – Moved by Todd to approve the amended minutes. Second by Girard. Motion Passed.
3. **Highway District 4** – Bruce Bayne (HD4) stated that ITD is emphatic that there will not be an intersection at Highway 16 and Floating Feather and that from a technical perspective he agreed with this position. He also stated that ITD is putting their resources into the completion of Highway 16 south of Highway 20/26 to the freeway. No overpass will be installed at the 20/26 intersection or the highway 44 intersection in the near future. Improvements to Highway 16 to the north have been pushed out 5 years. Bruce also reported that Highway 20/26 improvements have been abbreviated to include the highway between 16 and Star Road and would not improve Hwy 20/26 between Star Road and Middleton Road at this time. Bruce reported that HD4 will continue with designs for stop lights at intersections on Highway 44 at Blessinger, Kingsbury, Lansing, and Duff Lane. Current funding has been pushed out by ITD, but if a development is approved and a traffic study justifies installation of stop lights then that development will be required to initiate the funding and construct the intersection improvements prior to issuance of a building permit. Bruce supports a late-comer's fee to developments after the primary developer pays for the infrastructure. (A primary developer must have 100 or more lots.) Shawn added that impact fees do not cover stop lights on the highways.
4. **ACHD Update** – Kristi reported that they have hired a new person as Transportation Planner. That person will be attending next month's committee meeting. New Concept plans and Neighborhood plans are being worked on. The Star Road Concept study is getting attention and the Committee is welcome to add comments. This study has a place holder for \$5M for design and construction. Most likely this amount will increase due to rising costs of design, purchase of right-of-ways and construction. A request by Ryan was made to have ACHD look at their design for speed bumps. The ones installed on MainStreet do not accommodate emergency vehicles.
5. **Pathway Master Plan Update** – Tim Nicholson of Kimley Horn (KH) discussed the project using the recently issued Master Plan and CIP dated August 6, 2024. The open houses conducted for public comment yielded only 12 people in June. Members of the Committee should review the Master Plan and be prepared to discuss

at a meeting at 1:00 pm on August 21. The Master plan will be presented to the City Council on September 4 with final approval targeting mid-October. The committee recommended to Tim that the path widths for the Greenbelt sections be 12 feet and the Community pathways be 10 feet. The Committee suggested that the Master Plan include recommendations for who should maintain pathways.
