Public comment must remain on topic, and free from abusive language or unsupported allegations.

During any council meeting you have two opportunities to comment:

1. During the public comment period near the beginning of a meeting.
2. Before any decision-making vote of the council on an agenda item.

Comment made outside of these times may not be allowed.

Citizens wishing to speak during any public comment period should come forward to the podium and state their name and address for the record. Comment may be time limited, as determined by the chair, to allow as many people as possible to comment. Comment prior to a decision-making vote must remain on the motion before the council.

On September 23, 2021, by Resolution No. 491, Swimming Pool Fees were not increased in this revised master fee schedule.

On February 13, 2020, by Resolution No. 469 shows the same current rates to the pool fees.

On April 23, 2018, by Resolution No. 424 (included) pool fees were set at the rate that is currently showing.

RESOLUTION NO. 519

A RESOLUTION ESTABLISHING USER FEES FOR THE STEVENSVILLE SWIMMING POOL

WHEREAS, the Town of Stevensville maintains and operates a municipal swimming pool for the benefit of the public; and

WHEREAS, the Town of Stevensville relies upon some income from the public users of the pool to support the operation and maintenance of the pool; and

WHEREAS, Article III, Section 18-53 of the Stevensville Municipal Code authorizes the Town Council to set fees for the use of the pool by resolution;

NOW THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Stevensville, the following proposed increase to pool fees shall be changed for use of the pool for the 2023 season:
