# **Guidelines for Public Comment**

Public Comment ensures an opportunity for citizens to meaningfully participate in the decisions of its elected officials. It is one of several ways your voice is heard by your local government. During public comment we ask that all participants respect the right of others to make their comment uninterrupted. The council's goal is to receive as much comment as time reasonably allows. All public comment should be directed to the chair (Mayor or designee). Comment made to the audience or individual council members may be ruled out of order. Public comment must remain on topic, and free from abusive language or unsupported allegations.

During any council meeting you have two opportunities to comment:

- 1. During the public comment period near the beginning of a meeting.
- 2. Before any decision-making vote of the council on an agenda item.

Comment made outside of these times may not be allowed.

Citizens wishing to speak during the official public comment period should come forward to the podium and state their name and address for the record. Comment during this time maybe time limited, as determined by the chair, to allow as many people as possible to comment. Citizens wishing to comment on a motion for decision before any vote can come forward or stand in place as they wish. Comment must remain on the motion before the council.

If the Town is going to shut it off, they need to make sure it gets updated with the proper number.

William - That was a struggle for me last year, it took me a while to get ahold of Tim.

# e. Discussion/Decision: Town Clerk and Finance Officer to Attend Airport Board Meetings

Craig - Both the Town Clerk and Finance Officer are gone today. I had a long chat with them about a week ago and we learned a lot of stuff about them, and they learned a lot about us. I think it would be important for them.

Cindy - We don't currently have a finance manager.

Craig - But Robert will be there 10 hours a week.

Cindy - I don't know Robert's status.

Rich - So we would pay them to be here?

Kelli - What about quarterly?

Dusty - We're paying them to be here and they haven't been here for like 10 months. I think they need to be involved, we can talk with them, they can learn what's going on.

William - We're already paying 10% of their salary.

Rich- They should be here for every couple of meetings.

William - Quarterly reports would be great.

Rich - I think that's part of their duty.

Dusty - If we request they attend our meeting, I feel like they need to do their due diligence and provide that information, I just don't know how that would get done.

Cindy - Planning, Zoning, Park Board, TIFF/TEDD/ Council meetings, closed meetings (all at night). That's one of the reasons why we moved the Council meeting to 6 since they're here all day. I don't have a good answer right now unless you want to do it quarterly and see how that goes.

Craig - Maybe we stagger them?
