During public comment we ask that all participants respect the right of others to make their comment uninterrupted. The council's goal is to receive as much comment as time reasonably allows. All public comment should be directed to the chair (Mayor or designee). Comment made to the audience or individual council members may be ruled out of order. Public comment must remain on topic, and free from abusive language or unsupported allegations.

During any council meeting you have two opportunities to comment:

- 1. During the public comment period near the beginning of a meeting.
- 2. Before any decision-making vote of the council on an agenda item.

Comment made outside of these times may not be allowed.

Citizens wishing to speak during any public comment period should come forward to the podium and state their name and address for the record. Comment may be time limited, as determined by the chair, to allow as many people as possible to comment. Comment prior to a decision-making vote must remain on the motion before the council.

#### Mayor / Council Members:

Based on the recent situation, I would recommend an independent investigation regarding the allegations of improper expenditures for attorney fees. I have spoken with the Mayor, council member Devlin, and Robert Underwood. At this point, it would not be prudent for my office to conduct this investigation nor would it be accepted by the public (in my opinion). Regardless, this determination is up to you.

At this time, I have spoken with a few prospective investigators: Jill Gerdrum, Jordan Crosby, and Isaac Canter. Jill is unable to provide assistance based on her recent representation of the Town. Therefore, if you choose to move forward, Jordan and Isaac have availability.

Jordan is out of Great Falls and is concerned that the necessary travel for interviews may significantly increase her legal bill. Her rate is \$215/hour.

Isaac is based out of Missoula. He will not be available until June 28. His rate is \$200/hour and he estimates that this investigation would cost somewhere between \$3,000 and \$6,000. He will forward an engagement letter for you to consider at your next council meeting.

If you decide to have an independent investigation, I would advise that council direct this investigation and sign the engagement letter.

I understand that the next council meeting will be held on June 28. Please let me know how you decide to proceed.

Finally, I understand that Mr. Vick and Mr. Shourd have resigned. If there is anyone else that needs this information, please forward.
