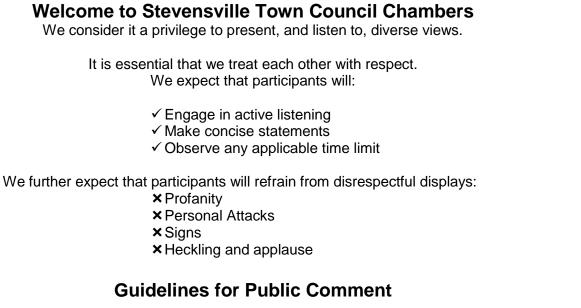

Comment made outside of these times may not be allowed.

Citizens wishing to speak during any public comment period should come forward to the podium and state their name and address for the record. Comment may be time limited, as determined by the chair, to allow as many people as possible to comment. Comment prior to a decision-making vote must remain on the motion before the council.

Will Rowe: it is the Museum of Mountain Flying hanger that is currently up their and they have decided to sell the hanger and they have a buyer. The buyer reached out to me, and the bank needs to see a signed lease before he can get the money, this one was in front of the board.

Councilmember Barker: I will make a motion to approve the Stevensville Airport Land Lease Transfer and Hanger Transfer for Block 2 Lot 10.

Councilmember Brown: 2nd

Mayor Michalson: motion and a 2nd.

Councilmember Brown: Will please check into the fees on that lease. They were receiving a discount.

Will Rowe: they were receiving a discount. It was a "dark smoke-filled room handshake" between them and the previous airport manager that should not have happened. They were a little upset but that is what it is, you pay to play. This is a new lease, not a transfer. The number of years start over.

f. Discussion/Decision: Approval of Matthew Wilkinson as the new Public Works Assistant

Mayor Michalson: introduced new business item f. Approval of Matthew Wilkinson as the new Public Works Assistant. Matthew works at the local hardware store and his dad works for public works. Gina and I and Stephen interviewed him, and we think that he would be a good fit for the town of Stevensville. I would like to point out that it is an \$18.00 hour starting out and after he gets is CDL he will get his \$1.00 hour raise.

Councilmember Barker: make a motion to approve Matthew Wilkinson as the new Public Works Assistant.

Councilmember Smith: 2nd.

Mayor Michalson: motion and a 2nd. Discussion

Councilmember Brown: did you say that his dad also works for the town? Do we have a nepotism problem here?

Mayor Michalson: that did come up in the interview. He did not feel that there were going to be any issues.

Councilmember Barker: it has gone through HR and Gina knows everything.

Gina Crowe: yes.

Stephen Lassiter: he would not be working directly for Jeff.

Mayor Michalson: any other comments from the council? Public comments? Jenelle take the vote.

Councilmember Barker: aye.

g. Discussion/Decision: Approve Contract/Offer Between the Town of Stevensville and Parks Supervisor/Public Works Assistant Position

Mayor Michalson: introduce new business item g. Approve Contract/Offer Between the Town of Stevensville and Parks Supervisor/Public Works Assistant Position. This was on my desk on the first day that I started. This was not brought in front of the council. No employee can hold two job titles. If you were to accept that you would have to rework that also. Received an email from our town attorney, Greg Overstreet, and he said that we were to not approve this there could be a liability issue. Not knowing what that liability issue would be I went looking into our personnel manual and under page 4 section 3 authority for personal action. (Mayor Michalson read from the personnel policy page 4 section 3.) this job was recreated and did not come before the council and the town has the right to create this position and you also have the right to take away this position. You have the right to abolish a job or reduce force so I do not understand what the real liability would be and also the \$4.50 was not in the budget, but Mayor Gibson will probably get up and talk about this, Park Supervisor was in the budget and so was Cody's job. When Steve Kruse resigned and Mr. Lassiter took his position, I think what they did we will combined these two positions and pay Mr. Anderson more to do this and he would be covering both of these jobs.

Councilmember Barker: make a motion to approve the contract /Offer Between the Town of Stevensville and Parks Supervisor/Public Works Assistant Position.

Councilmember Smith: 2nd.

Mayor Michalson: motion and a 2nd. Discussion from the council.

Councilmember Barker: we approved the budget we approved our wages and to give somebody a \$4.50 per hour raise I feel is very wrong. We are fighting to keep our police officer let alone giving the other town employees something else. I do not feel that it was right not being brought to the council. It was drawn up as a contract and as you said contracts have to be brought in front of the council and it was not until tonight a lot of failure on both parts.

Councilmember Smith: I would like to know as the parks supervisor who would he be supervising.

Mayor Michalson: off the top of my head I could say, please go ahead.

Stephen Lassiter: seasonal workers, lifeguards at the pool. I hear what you are saying on the money part. It was not a contract it was an offer letter and we all got one. When I took Kruse's and Cody took mine, we each took that for less money. So, the money, even though it was not the same people, we took the jobs for less. So, we are saving the town a little bit. Regardless of how he got here or done properly. I ask that you realize that Cody is a valued employee. He is an asset to this town, and I do not think that he should bare any burden for what happened that he did not have any control over and think about that when you take your vote.

Councilmember Barker: I appreciate your input on it we are not giving anyone else an opportunity to fill that parks position by combining it. I understand that you say we are saving money but to give someone else an opportunity to get that position.

Stephen Lassiter: it was advertised in house.

Mayor Michalson: yes, it was advertised in house.

Stephen Lassiter: I will say he has really stepped up since he has had this. He has become more of a leader. Taking time, training others on what he does. I have seen a change in him, and he has really stepped up.

Councilmember Barker: I think that it has caused a lot of contention when we are trying to keep our police officers and then someone comes in and says I just got a \$4.50 raise. It make is tough

Stephen Lassiter: I know, this \$4.50 raise, yes, he is making more money, but he is making a salary for that position. It is not that he is doing the same thing. I disagree with the term raise.

Councilmember Barker: does he have certification that he is going to have to obtain.

Stephen Lassiter: yes, pool operator as well as he is still working on his wastewater. He has a lot of studying to do, he is taking it seriously.

Councilmember Smith: with the certifications and all like the other gentleman that we hired, are their raises like the CDL.

Stephen Lassiter: he has his CDL already.

Councilmember Smith: are there other certificates that have a raise with it.

Stephen Lassiter: I will have to look at his offer letter there maybe after he gets his wastewater. There should be.

Mayor Michalson: if you were to approve this you would have to come back unless you have a new job title, he cannot have two job titles and one employee cannot hold that.

Councilmember Brown: if it gets approved can we go back and recreate the job description. I would like to see it done and I am sure there is grey area here and how each individual reads it. The personnel policy and other parts of the town and the state, but I felt that we should have created the job first and then offered and made a decision. if we can go backwards and recreate it.

Mayor Michalson: I believe as the council you can go back and start over with a new job title, description and wage.

Councilmember Brown: I guess another thing to look at do we have to do a budget amendment to do this.

Gina Crowe: I can get that for you. I think we really need to think about what we are doing and make sure that we are good stewards of the town money.

PUBLIC COMMENT

Steve Gibson: 1517 Creekside Drive. I do not see this as a contract. We draw up an offer letter for every employee. You get benefits, it is a town employee. If this was a contract, there would not be any benefits. It was opened in house, and anyone could have applied. Getting a raise, it was a compensation. The job description went to Mr. Lassiter, and this saved the town money. to do what he did when he was Parks Supervisor. To make the job description be what they really do. When he was Parks Supervisor, he did a lot of these things that were not in the job description, they were not spelled out. Anyone could have applied for this job, and it was not different from when Mr. Kruse left, we posted in-house. Steve Lassiter and Cody applied for that, and Steve Lassiter got it. We went over this last year with Mr. Overstreet about does this need to go to the council, he reviewed it and said that it did not have to come forward. If the town attorney would have said that this was a problem I would have stopped. Personally, when I was mayor, I listened to the licensed legal advice of the town attorney. A lot of people have opinions about statues, this is illegal, or this is illegal, I rely on the town attorney. In regards to salaries being approved, yes, they are all in the budget. The employees that we hired, public works, chief of police, parks supervisor were in the budget and all of them have been hired at less then the previous salary. He did get more money, got more responsibilities. In his offer letter, Councilmember Brown you asked that question, water and wastewater certification certain amount of time. We did consult with the attorney and there were some questions about does this have to go to the council, and it did not. If you wish in the future and want to approve every position that is up to you, I personally do not feel that there was anything done wrong. Out of all of these combinations the job that was approved tonight is making less than what Cody was making. Same thing, as I have always said is I did what was best for Stevensville not just a hand full of people. As in the personnel policy, I think that it is a good job to have your employees apply for a job in-house. And yes, it was a promotion, it was not a separate raise, yes, he got more money. with that I can take questions and if not, that is fine. This contract is confusing to me, it goes in the personnel file. If it was a contract there would be other language, no different.

Mayor Michalson: you are stating that the parks supervisor position before was not a department head?

Steve Gibson: I am saying that it is not a department head, he works for him. Bobby was a department head and we changed all of that, he is not a department head, Mr. Overstreet and I changed all of that.

Mayor Michalson: and you still do not think according the MCA salaries, (quoted this code).

Steve Gibson: the salaries were already in the budget; we did not know that Mr. Kruse was leaving.

Mayor Michalson: you said that you discussed this in August and the offer is signed November 27th. You said that you discussed this in August.

Steve Gibson: Steve Kruse left November 17th. The budget was passed before that. We talked to the attorney about this, and the salaries went down. Went down \$4.00. Chief of police makes less then Mac Sosa did.

Councilmember Smith: Did you say regarding liability, that you had an email from the attorney?

Mayor Michalson: yes.

Councilmember Smith: because it is a contract it is a liability?

Mayor Michalson. Yes, the attorney said that it was a contract in the email. And that there was a chance for liability. Identifying risk was his job.

Greg Overstreet: I am unable to describe what my legal advice was in a public setting. You guys can talk about but so that everybody knows I cannot, so I am being silent.

Mayor Michalson: any other comments from the council? Publ; ic.

Councilmember Brown: I could use a little bit more information on this item.

Mayor Michalson: do you want to table this item?

Councilmember Barker: I would like to withdraw my motion for the approval of the contract/offer between the town of Stevensville and the parks supervisor/ public works position.

Councilmember Brown: 2nd.

Mayor Michalson: motion and a 2nd to withdraw your motion. Jenelle, would you take the vote.

Councilmember Barker: aye.

Councilmember Brown: aye.

Councilmember Smith: aye.

Mayor Michalson: motion passes 3-0

Councilmember Barker: I would like to table this contract/offer between the town of Stevensville and the parks supervisor/ public works position. Until we get more information can we have this ready by the next council meeting?

Mayor Michalson: you are going to have to reword and change the title.

Councilmember Brown: I think that we have to nail down the job description so that it is not confusing to public works. Maybe at the next council meeting we can get the job diction for this. Opinion from MMIA on this, it this is a job offer or a contract

Councilmember Barker: I think that we need more definition of what we have here, we have rules that we have to follow, and I think that it needs to be done properly.

Mayor Michalson: motion and a 2nd.

Councilmember Smith: what is the motion?

Jenelle Berthoud: motion is to table.

Mayor Michalson: motion to table, bring it back, have it cleared through MMIA, reviewed by Greg our town attorney and make sure that we have the money for that.

Councilmember Brown: and move our agenda items around to do this before because this would be unfinished business. I would like to clean this up a bit. Or whatever the council decides.

Mayor Michalson: any public comment on tabling this?

PUBLIC COMMENT

Steve Gibson: I am going to say one more thing, this is not a contract per say it is the same thing that you do for every position.

Mayor Michalson: I will say in my eight years of local government I have not seen a contract or offer made up this way come forth.

Steve Gibson: I did not put any words in there that said contract.

Mayor Michalson: I am not saying you did I have never seen in my eight years it done this was where there was an offer made to an employee that was never brought to the council. Any more comments from the public or council.

Councilmember Barker: aye.

Councilmember Brown: aye.

Councilmember Smith: aye.

Mayor Michalson: motion passes 3-0.

h. Discussion/Decision: Schedule a C.O.W. Meeting Date and Time to Review Job Descriptions

Mayor Michalson: introduced new business item h. Schedule a C.O.W. Meeting Date and Time to Review Job Descriptions. At my first staff meeting I asked the employees to review and make changes, my example that I bring up every time is Jenelle has been doing fingerprinting forever and it is a good revenue for the town, and she was doing that when she was a police clerk and carried that over to the clerk now, if she wants to add that to her job description then she needs to do that. If public works would like to add or take away, most of these job descriptions have not been updated since 2018.

Councilmember Barker: make a motion to schedule a C.O.W. meeting date and time review for job descriptions.

Councilmember Smith: 2nd.

Mayor Michalson: motion and a 2nd.

(Council discussion took place on availability for each other's schedules.)

Councilmember Barker: how much time to do you need for a notice?

Jenelle Berthoud: 72 hours is fine.

Mayor Michalson: we have not done one for a long time, it may take more than one meeting.

(Council discussion took place on availability for each other's schedules.)

Jenelle Berthoud: no airport meeting, or board meetings. are you thinking of proposing something in the late afternoon?

Councilmember Barker: 18th at 3:00 pm?

Jenelle Berthoud: January 18, 3:00 pm COW meeting.

Councilmember Barker: make a motion to schedule a COW meeting on January 18th at 3:00 pm to review job descriptions. And that would include some of the departments.

Mayor Michalson: do we have any comments from the public on this?

Chief Motley: it makes it hard to attend at that time.

Mayor Michalson: the public does not usually weigh in it is between the council and the staff; they can come and attend they really don't discuss.

Vicky Motley: if he has to take time off of work, he looses salary. I am just saying.

And that is big as we all know. Trevor was up there the other day taking her place and they like him. They are bringing Mac's expertise into the community. Gina and I and Stephen had a meeting with HDR to discuss the break down of the Mission Street water main project. We tabled that and sent it back to have it rebid because the bids need to be opened in front of the council. We had a meeting with Eli, and we will put it out for rebids, and it will only by Mission Street. Will advertise on the 22nd and then they are due on February 22 and then opened at that meeting. Send it out to HDR to review and bring it back to the March meeting and then Jenelle had a good idea that we should have a special meeting to award so that we can get this project going. My old council seat still has not been filled, it is kind of sad, it is open until the 16th. Do I have a motion to adjourn?

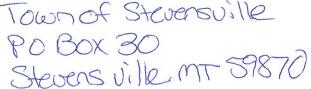

WHEREAS, the Town Council of the Town of Stevensville is desirous of recognizing the impacts that the Town of Stevensville may encounter due to the average global temperature increasing and rising sea levels; and

WHEREAS, the primary duties of the board are to first create a climate plan for the town; and

WHEREAS, the secondary goal is to address economic development and growth policy, and to ensure that the economic and development growth policy are flexible for a growth rate that could increase; and

WHEREAS, the tertiary goal is to research grants that are designed to help municipalities reduce the amount of energy used, provide improvements to existing infrastructure, climate education for the public, as well as grants that can be used to help with economic development (pertaining to climate change).; and
