B. Review Park Plan

Thunstrom reviewed the Park Plan that was adopted in 2022. She stated that Council is planning to put money in the Park Fund for 2024. She encouraged the Commission members to use this as their guide when setting goals and strategies. We have had discussions on Community Park, Ice Rinks and what the community is looking for in the future. They have shown interest in a splash pad.

Zutz asked what the purpose of the Parks Commission just to clarify to everyone why we are here. Thunstrom stated that we have this plan and we need to move it forward and we need community input and to help guide Council on where to spend the money that is set aside for parks.

The City has land that was purchased and has been set aside for future park use. A park is not necessarily playground equipment. It can mean a dog park or walking paths, etc.

Tom Koep spoke on Smith Lake Park. He stated that it is a 10 acre parcel that hasn't really had anything done with it. The residents have mowed a walking trail and there is a 1.2 mile loop.

C. Pictures of Commission Members added to the website. The group discussed having their pictures added to the website and agreed that it is something that they would like to see done.

7. DISCUSSION/MEMBER REPORTS

Chairwoman Anderson asked that the group do an introduction on the group being that they do not know each other that well. Each person present went through and gave an overview on how long they have lived/worked in the city.

Zutz asked about the funds and what that dollar amount is. Thunstrom stated that she will know that number on December 4th. The City Council will set the budget for 2024 at that meeting.

Anderson asked about Community Education programs using the parks and ways that we can cooperate in programming with different organizations. Thunstrom stated that we can certainly plan for that and work with these groups but we also need to be mindful that we do not have a full time recreation department or director.

Zutz asked about a Community Center and what that looks like in the new City Hall Fire Station as heard talks of that. Thunstrom stated that there we designs that were put into place to have a 3,000 SF bump out added to the building that included walking track, climbing walls, etc. but to add that on was an additional million dollars and wasn't feasible financially for the tax levy. So, we took the second floor of the new building and created an unfinished space that in the future could be used for community space. The survey that

was done this summer at a community event showed that the community would really like a community center.
