OVERVIEW:

Cities with a General Election must canvass the local race results. Per MN State Statute 204C.33 the County canvassing board shall meet at the county auditor's office between the 3rd and 10th day after the State General Election. The County will provide the results by the end of day on November 14th. At that time the City can canvass the local race results. In regards to the write-ins, per City Charter;

Section 5.01 Subd. 2 A write-in candidate who wants their write-in votes to be counted in the general election must file a written request with the city clerk no later than seven (7) days before the general election. All write-in votes for candidates who have not filed a written request to have these votes counted shall be treated collectively as votes for a single nonqualified candidate referenced as "other".
