- ♦ <u>Chris and Ron Murphy</u>. Thanked the Council for denying their Street Vacation request. They honor and understand their decision. They learned a lot about City government during the process. They are happy to be citizens of St. Helens.
 - Council appreciated them coming and their patience.
- Eric Zahl. He used his time to show a video explaining the damage that will occur to Liberty Hill Knife River proceeds with mining. That video can be viewed here: https://www.youtube.com/watch?v=U775JE2NiE8. After reviewing the video, Eric expressed his opposition to the Knife River mining permit on Liberty Hill. The County's comment period ends January 30 and they're concerned this is being rushed through. It potentially could increase the water problems on Pittsburg Road. He will personally be impacted as an adjacent property owner. They can move north and not affect the surrounding land as much. There are many people opposed.
- ♦ <u>Brady Preheim</u>. He emphasized the need to preserve Liberty Hill. It's a unique piece of property. He suggested a force annexation if they can do that.

♦ <u>Pamela Scoonover</u>. She expressed her concerns about Liberty Hill. Walking through there, she has seen the beautiful camas flowers. They are fortunate to have that there. The people living at the retirement facility will not be able to handle the blasting noise. She hopes the Council can find a way to prohibit mining in this location and move it north.
