BACKGROUND: The attached resolution authorizes city staff to apply for the Transportation Economic Development (TED) Program for the purpose of financial assistance for the turning lanes connected to the 12th Avenue South Highway Expansion project.

RESOLUTION NO. 09.25.11

RESOLUTION AUTHORIZING THE SUBMITTAL OF THE DEPARTMENT OF TRANSPORTATION TRANSPORTATION ECONOMIC DEVELOPMENT (TED) PROGRAM APPLICATION

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES,

MINNESOTA, that the City of St. James act as the legal sponsor for the 12th Avenue South Highway District Expansion project and requests funding from the Transportation Economic Development (TED) Program of the Minnesota Department of Transportation.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that the City of St. James has the legal authority to apply for financial assistance, and the institutional, managerial, and financial capability to ensure matching funds and adequate construction of the proposed project.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that the City of St. James has not violated any Federal, State or local laws pertaining to fraud, bribery, graft, kickbacks, collusion, conflict of interest or other unlawful or corrupt practice.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that upon approval of its application by the state, City of St. James, may enter into an agreement with the State of Minnesota for the above-referenced project(s), and that it will comply with all applicable laws and regulations as stated in all contract agreements.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that the City of St. James, has committed \$5,048,450 towards the local match requirement.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that the City of St. James confirms if the project cost increases above the amount listed in the Application, City of St. James will provide or secure all additional funds necessary to complete the project.

City of St. James certifies that it will comply with all applicable laws, regulations, and rules of the Application.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that the sources and uses, private investors, equity, and other financing commitment represented in the attached document are accurate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES, MINNESOTA, that Economic Development Director and City

Manager or their successors in office, are hereby authorized to execute such agreements, and amendments thereto, as are necessary to implement the project(s) on behalf of the applicant.
