The bicycle pedestrian trail plan has been adopted. City Engineer Hari Karikaran stated the recommendation is divided into three categories; sidewalks, bicycle & trail master plan and spot projects. The adopted plan is hundreds of pages and is located on the city's website under Major Plans. The City Engineer gave an additional review of the plan we well as a review of the map, showing the trail.
