There was discussion on the development of a food truck roster for event organizers. The committee will aim to generate revenue and economic impact from events. There was also discussion on challenges faced with past outdoor events due to weather conditions.

The Screen on the Green event is coming and expected to attract a large crowd. It was stated marketing strategies, including billboards and geo-fencing, are essential for effective event promotion and increasing participation.

The Commission's shift to the Stonecrest Development Authority allows for greater financial autonomy, enabling more innovative revenue-generating opportunities. Past experiences with weather-related challenges highlight the need for contingency planning in event management to ensure community participation.
