Engineering

Street Resurfacing

City Engineer Hari Karikaran shared a presentation, reviewing the annual budget, contract, and expenditures for street resurfacing, each year, from 2019 to 2025.

Councilmember Grimes followed up on District 5 and some of the surface areas she asked about previously. Salem Road was mentioned, as DeKalb incurred some water damage a while ago and the road has been bumpy since. Mr. Hari Karikaran responded to a question and stated that he helps with the decision of work orders but 50% are decided by consultants that are hired for that purpose. He also advised that single roads would be completed after they finish the sub sections.

Street Reflector Follow Up – Tabled to next meeting scheduled to take place in July.

Motion – made by Councilmember Terry Fye to table the Street Reflector item until next meeting, scheduled for the month of July. Second by Councilmember Tammy Grimes. **Motion passed unanimously.**

 Statewide Projects Update - Mr. Hari Karikaran showed a 'State Projects' chart and explained that not much has changed since the last meeting. He will research the projects and have more information at the next meeting.

Mr. Karikaran added that the Fairington Road project is being handled by DeKalb County. Once the contract is approved and signed, it will be posted for bidding.

Parks and Recreation

Fairington Park Lockdown Update
