**LOCATION:** 4183 Windermere Drive

**PETITIONER'S REQUEST:** The applicant is seeking a Special Administrative Permit (SAP) to operate as a Type 1 Home Occupation for an administrative office for a trucking service business.

The applicant, Mr. Cedric Claritt, was present at the public hearing. He stated that this location will be used as an administrative office only for his trucking business. He will not use this location to park trucks or any other vehicles. He also states that there will be no customer contact occurrences at this location.
