This will bring the total number of members to six, with Mayor Cobble as number seven. Mayor Cobble will recommend a replacement for Elijah and asked if the members had any recommendations.

Motion did not pass. Joyce Walker was disconnected and there were not enough members present to vote. This item will be postponed to the next meeting.

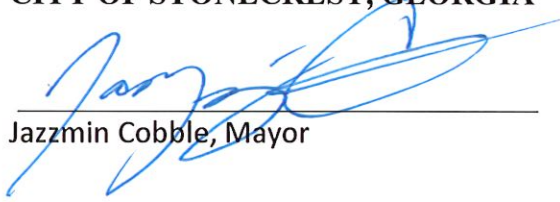

The meeting was adjourned at 8:35p.m.

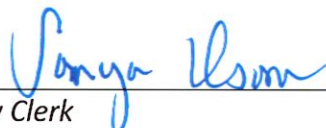
