c. Review and approve Business Incentive Application

Committee reviews the business incentive application and discusses the criteria for evaluating applications, including the economic impact analysis and the proposed timeline for the project.

d. Review and approve draft MOU

Committee also reviews the draft MOU, which outlines the terms for the Development Authority to use the funds in the city-owned bank account labeled for the Development Authority. The MOU includes a promise to pay back the loan and the unapproved transfer once the Development Authority starts making money.

Committee discusses the financial challenges of the past Development Authority and the need to open up a proper bank account with their own EIN so that they can be prepared to start doing business.

Committee decides to send the draft MOU to the city for approval and to ask the Economic Development Department to fund the Development Authority with some seed money each year.

e. Discuss DCA Annual Authority Registration and Financing Report & EIN

Committee also discusses the need for a separate email for the Development Authority to communicate about applications and business, and the importance of keeping conversations about specific projects in executive session to protect sensitive information.
