b. FY25 Capital Improvement priorities from Council

Mayor Pro Tem Turner mentioned this item was talked about in the council retreat and some points of clarity were needed.

Mayor Cobble gave an overview of stated Capital Improvement priorities, mentioning park acquisitions, and including Salem Park, Farrington, Southeast, and Browns Mill and Everett Parks. Projects will need to be organized as to order and which year. There was additional discussion on capital costs and operating costs, as well as a list of categories. The City Engineer will share a list of sidewalks that are high priority, in addition to utilizing the bicycle plan and transportation plan to pull projects, as well as streets for additional lighting.

There were questions asked in regard to prioritizing paving. Engineer Karikaran gave an update on the progress of the contractors. There was a request to later get the percentage of streets and miles that have been paved as well as a list of streets that have been paved.

c. Resurfacing roads abandoned by contractors without bonding

This item is being presented due to contractors moving on without putting a second layer of paving in a subdivision. There is no bonding in place, which should have been in place before Stonecrest. The City Engineer has been working on this matter and stated there is an expired bond.

d. SPLOST projects beyond transportation

This item was discussed during agenda item b.


