Section 3.04. City manager:

The following was proposed: Interference is to bypass the city manager, and we reference section 2.12 for oversight. Judicial independence is important. No further changes suggested to 3.04 as it relates to oversight in light of 3.03.

City Council interference with administration.

In regard to Section 3.03 (5) it is proposed to add the phrase "must notify within 24 hours of telling of complaints" at the end of the sentence.

Section 3.03 (9), it is proposed to include the following after oversight function: "Including but not limited to once the city council has passed...".
