**III. AGENDA ITEMS**

**a. Decision – State of Emergency Declaration Extension – *Winston Denmark***

Attorney Winston Denmark provided an overview. Due to the increase in positive Omicron and Delta variant cases, it was proposed that the City extend its State of Emergency to June 2022. This extension can be shortened or extended if Council should find cause to do either. Councilmember Jazzmin Cobble and Mayor Pro Tem George Turner both agreed that June is too far out. Councilmembers Tammy Grimes and Tara Graves both agreed that June is best, as the variant is effecting everyone.

**Motion -** Made by Councilmember Jazzmin Cobble to approve the ordinance extending the State of Emergency. Seconded by Councilmember Rob Turner.

**Motion passed unanimously.**

**b. Appointments – For Urban Redevelopment Agency – *Mayor Pro Tem George Turner***

Mayor Pro Tem George Turner provided an overview. The appointments up for voting expired on December 31, 2021. In the Mayor's absence, the Mayor Pro Tem can make a recommendation for the URA chair. Mayor Pro Tem George Turner recommends Councilmember Jazzmin Cobble as the URA chair. This will be confirmed at the next URA meeting.

**Motion 1-** Made by Councilmember Jazzmin Cobble for Councilmember Jazzmin Cobble to succeed herself in Post 3. Seconded by Councilmember Rob Turner.

**Motion passed unanimously.**

**Motion 2-** Made by Councilmember Rob Turner for Mayor Pro Tem George Turner to succeed himself in Post 4. Seconded by Councilmember Jazzmin Cobble.

**Motion passed unanimously.**

**Motion 3-** Made by Councilmember Jazzmin Cobble to appoint Councilmember Tara Graves to Post 1. Seconded by Councilmember Rob Turner.

**Motion passed unanimously.**

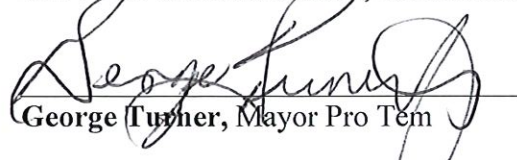

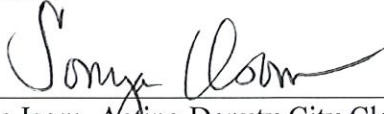
