## **STAFF REPORT**



**SUBJECT:** The Stable Development Agreement / TxDOT LOSA

**MEETING:** Special City Council Meeting - 17 May 2022

#### **RECOMMENDATION:**

Staff recommends approval of the proposed resolution for a TxDOT Local On-System Agreement (LOSA).

#### **BACKGROUND:**

The Stable Development provides for commercial business growth and the extension of Wolfe Nursery Drive south of Washington Street which requires traffic signal and pavement layout modifications to the intersection. Because the modifications will take place within the TxDOT right-of-way, the state must grant authorization for the developer to perform the work.

The TxDOT LOSA form is a streamlined version of the Advance Funding Agreement, which was used recently for projects such as the traffic signal improvements at Saint Felix and Christy Plaza. TxDOT does not partner with private developers and the LOSA is the mechanism available for TxDOT to provide support and authorize the work for the project.

At the May 3, 2022 regular City Council Meeting, council authorized staff to execute the TxDOT LOSA once the agreement forms are received and the final version is approved by the city attorney.

This memorandum provides council with the opportunity to approve the TxDOT-required resolution for the LOSA. The necessary resolution language, required for TxDOT to approve the LOSA, was received from TxDOT on Friday, May 13<sup>th</sup>.

#### **FISCAL IMPACT SUMMARY:**

The LOSA provides formal state acknowledgement and permission to perform the work and places the financial liability with the city for the modifications to be installed in accordance with TxDOT requirements and specifications.

The construction costs for the improvements are identified as \$359,500. The direct and indirect state costs for the LOSA are identified as \$18,246 and \$17,148 respectively, totaling \$35,394. TxDOT has absorbed and waived all state fees and there are no state costs to the developer or the City of Stephenville for the LOSA.

While the LOSA places financial liability on the city for the intersection improvements, the Developer Agreement with The Stable, LLC that was approved at the May 13, 2022 council meeting, provides assurance to the city that the developer will "assume all the financial liability to construct the on-site necessary improvements..."

#### **RESOLUTION NO. 2022-R-XX**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF STEPHENVILLE, TEXAS, SUPPORTING A LOCAL ON-SYSTEM IMPROVEMENT PROJECT AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE INSTALLATION OF TWO NEW TRAFFIC SIGNAL MAST ARMS AND ASSOCIATED FOUNDATIONS LOCATED AT US 67 AND WOLFE NURSERY ROAD

WHEREAS the City Council of the City of Stephenville ("City") wishes to enter into an Local On-Site System Improvement Project Agreement with the Texas Department of Transportation ("TxDOT") for the construction of active signal devices located at the intersection of US 67 and Wolfe Nursery Road in Stephenville, Texas.

#### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STEPHENVILLE, TEXAS:

#### SECTION 1.

That the City Council of the City of Stephenville authorizes a Local On-System Improvement Project Agreement with TxDOT for the installation of two new traffic signal mast arms and associated foundations to be installed at the intersection of US 67 and Wolfe Nursery Road for a total estimated cost of \$394,894.00 with the City's estimated share of the costs to be \$359,500.00, to be funded through a developer agreement between the City and The Stable Development, LLC. The City acknowledges that it is responsible for any project cost overruns.

#### SECTION 2.

That the mutual covenants and agreements between the City and TxDOT are detailed in a Local On-System Improvement Project Agreement for the project identified as CSJ # 02-2LOSA001.

#### SECTION 3.

The City Council authorizes the mayor or mayor pro tem of the City of Stephenville to execute all documents necessary to complete this transaction.

#### SECTION 4.

That it is hereby officially found and determined that the meeting at which this resolution is passed is open to the public and that public notice of the time, place, and purpose of said meeting was given as required by law.






