#### **STAFF REPORT**



**SUBJECT:** Discussion of the City Planner Position

**DEPARTMENT:** Development Services **STAFF CONTACT:** Steve Killen, Director

#### **BACKGROUND:**

During the 2020-21 budget process, City Council funded a City Planner position effective October 1, 2020. Recruiting efforts were initiated and funding was subsequently authorized to secure third party recruitment services. The labor market proved challenging and recruitment efforts provided very few candidates. The position was filled in December, 2021; however, the incumbent resigned in March, 2022.

The explosive interest by developers to do business in the City of Stephenville has placed time sensitive demands on many departments, including Development Services. Most projects require immediate and ongoing attention until completion. Although a City Planner position is of utmost importance in regards to the long-term development of our city, current workloads have made the need for administrative assistance the immediate priority. Staff is requesting consideration of redirecting recruitment efforts for the City Planner.

Options to consider include, but, are not limited to:

- 1. Continue recruitment efforts for the City Planner position as originally intended.
- 2. Reclassify the position with less restrictive, minimum qualifications.

Staff respectfully recommends Option 2.

**SUBJECT:** Fire Department Reorganization

**DEPARTMENT:** Fire Department

#### **RECOMMENDATION:**

Consider a reorganization of the fire department executive and command staff.

#### **BACKGROUND:**

Currently the department operates with an assistant chief (vacant), fire marshal, and a training captain.

This proposal would allow a consistent focused management of department operations. Maintaining regulated training, equipment testing, and policy updating, inspection and compliance demands full time attention in many areas. I recommend the assistant chief position, fire marshal, and training captain be reclassified as division chiefs. The three divisions would have focused duties while allowing some crossover for consistent management. The three divisions would be Administration, Operations, and Prevention. These positions would report directly to the fire chief

Two battalion chiefs manage the current structure of the three operational shifts. The third battalion chief is a vacant position, previously held by the former assistant chief. I recommend the elimination of the battalion chief positions through attrition. This would cause the shift management to move to the current captains and overseen by the newly created operations division.

At the time the battalion chiefs are eliminated through attrition, I recommend the backfill of firefighters.

#### **FISCAL IMPACT SUMMARY:**

With the elimination of high-ranking positions, this reorganization will result in a salary savings.

#### **ALTERNATIVES**

Continue with existing structure of assistant chief/battalion chief.

**SUBJECT:** Axon Enterprises Contract re-write for Body Worn Cameras, Fleet Cameras, Interview Room

Cameras and Evidence.com Subscriptions

**DEPARTMENT:** Police

#### **RECOMMENDATION:**

Approve the contract rewrite with Axon for camera services and storage.

#### **BACKGROUND:**

Since 2013 the Police department has used body cameras provided by Axon Enterprises (formerly known as Taser International). In May of 2020 we entered into a five-year contract with Taser to provide both body-worn cameras (bwc) and vehicle mounted cameras. Both the body-camera and fleet systems use evidence.com to manage and store the videos, perform video redaction and digital evidence management and sharing. The original contract provided a set amount of storage (9 TB), user accounts (12 pro, 30 basic) and enough body cameras for all patrol officers and animal services officers (26). In 2021 we entered into a contract with Axon to provide Interview room cameras that also use the evidence.com system for storage. All three of these systems integrate together using evidence.com for complete video evidence management but are on separate contracts.

In the last two years we have begun to greatly exceed the amount of storage used (currently 19 TB) as well as having insufficient number of user licenses to evidence.com for all employees who need access. We have also added one additional fleet camera to the system. Axon has offered to re-write the contract to provide unlimited storage for video, body worn and interview room camera systems, refresh all current body worn cameras and docks with brand new equipment, increase the number of body worn cameras and docks to include all sworn and field personal (46) and provide additional licenses for evidence.com users. (14 pro, 34 basic.) They will also install new fleet cameras in FY 23 at no charge when the new model comes out. The new contract will continue to provide complete warranty and maintenance for all hardware as well as refresh hardware at the 2.5 and 5 year marks.

The contract re-write will also place all three current contracts into a single contract all on the same upgrade and refresh cycles with a single yearly payment. This will simply contract administration and reduce administrative costs associated with approving and paying each contract each year.

#### **FISCAL IMPACT SUMMARY:**

No impact to the FY 21/22 budget as the Year 1 costs for all contracts in the amount of \$58,755.45 is already budgeted. For years 2 to 5 the yearly cost will increase to \$76,258.58.

- Continue with current contracts, pay additional storage costs
- Create separate contract for additional equipment/storage

**SUBJECT:** 377 Elevated Storage Tank Rehabilitation Project **MEETING:** Public Works Committee Meeting – 21 JUN 2022

**DEPARTMENT:** Public Works **STAFF CONTACT:** Nick Williams

#### **RECOMMENDATION:**

Staff recommends entering into a professional services agreement with Provenance Engineering for the budgeted design of the 377 Elevated Storage Tank Rehabilitation Project.

#### **BACKGROUND:**

In May of 2021, a thorough examination was performed of the interior, exterior, and foundation of the 750,000 Gallon 377 Elevated Storage Tank (EST), originally built in 1985, located at 536 County Road 386. Based upon the inspection report findings, rehabilitation of the tank was recommended, and a design cost was approved in the FY21-22 budget.

#### **PROPOSAL:**

A professional services proposal has been received from Provenance Engineering to provide plans, detailed technical specifications, and competent on-site field representation/inspection services for the tank rehabilitation project. The proposal provides a 10-month term to provide the design, bid, and construction phase services.

HOT Inspection Services, Inc., is proposed as a sub-consultant to perform the on-site construction oversight services including welding, blasting, and coating application inspections. Also included with the work is a one-year warranty inspection by the coatings inspector as recommended by the American Water Works Association.

HOT Inspection Services, Inc. performed the inspections for the Garfield Elevated Tower Rehabilitation Project in 2013, the Garfield Ground Storage Tank Rehabilitation Project in 2018, and the 377 Ground Storage Tank Rehabilitation Project in 2020 with success. Additionally, the firm has performed inspections for water tank construction and rehabilitation projects across Texas for over twenty-five years and reference recommendations from reputable engineering firms endorse HOT as an efficient and reliable sub-consultant.

#### **FISCAL IMPACT SUMMARY:**

The full agreement provides for the preparation of construction drawings, detailed specifications, notice, pre-bid and bidding assistance, contractor recommendation, and on-site field representation/inspection services for \$98,400.

The basic services for design and management total \$25,000. The bid phase and construction services total \$73,400.

The approved FY21-22 budget allocated \$25,000 for the project design. Staff requests approval of the total \$98,400 contract amount in order to prevent escalation of the design and inspection costs.

Once the design is completed, the bid and construction phase services would only commence with written authorization from the city and only if funds are allocated in the FY22-23 budget.

#### **ALTERNATIVES:**

The following alternatives are provided for consideration:

- 1. Delay the design portion of the tank rehabilitation project.
- 2. Recommend a different firm or firms.

#### **ADVANTAGES:**

Approval of the agreement remains within the approved project budget. The agreement provides for the on-site services under a single contract. Successive phases are only permitted with written approval.

#### **DISADVANTAGES:**

There are no known disadvantages to proceeding as described above.

## AGREEMENT BETWEEN OWNER AND ENGINEER FOR PROFESSIONAL SERVICES CITY OF STEPHENVILLE, TEXAS 377 ELEVATED STORAGE TANK REHABILITATION

Item 4.

THIS IS AN AGREEMENT effective as of June 7, 2022 ("Effective Date") between City of Stephenville ("Owner") and Provenance Engineering, LLC. ("Engineer").

Owner's Project, of which Engineer's services under this Agreement are a part, is generally identified as follows: 377 Elevated Storage Tank Rehabilitation ("Project").

Engineer's services under this Agreement are generally identified as follows: Design, Bid and Construction Phase Services for the 377 elevated storage tank rehabilitation ("Services").

Owner and Engineer further agree as follows:

#### 1.01 Basic Agreement and Period of Service

- A. Engineer shall provide or furnish the Services set forth in this Agreement. If authorized by Owner, or if required because of changes in the Project, Engineer shall furnish services in addition to those set forth above ("Additional Services").
- B. Engineer shall complete its Services within the following specific time period: 10 months presuming there are no delays between each task.
- C. If, through no fault of Engineer, such periods of time or dates are changed, or the orderly and continuous progress of Engineer's Services is impaired, or Engineer's Services are delayed or suspended, then the time for completion of Engineer's Services, and the rates and amounts of Engineer's compensation, shall be adjusted equitably.

#### 2.01 Payment Procedures

- A. *Invoices*: Engineer shall prepare invoices in accordance with its standard invoicing practices and submit the invoices to Owner on a monthly basis. Invoices are due and payable within 30 days of receipt. If Owner fails to make any payment due Engineer for Services, Additional Services, and expenses within 30 days after receipt of Engineer's invoice, then (1) the amounts due Engineer will be increased at the rate of 1.0% per month (or the maximum rate of interest permitted by law, if less) from said thirtieth day, and (2) in addition, Engineer may, after giving seven days written notice to Owner, suspend Services under this Agreement until Engineer has been paid in full all amounts due for Services, Additional Services, expenses, and other related charges. Owner waives any and all claims against Engineer for any such suspension.
- B. Payment: As compensation for Engineer providing or furnishing Services and Additional Services, Owner shall pay Engineer as set forth in Paragraphs 2.01, 2.02 (Services), and 2.03 (Additional Services). If Owner disputes an invoice, either as to amount or entitlement, then Owner shall promptly advise Engineer in writing of the specific basis for doing so, may withhold only that portion so disputed, and agrees to pay the undisputed portion.

#### 2.02 Basis of Payment—Lump Sum

A. Owner shall pay Engineer for Services as follows:

- 1. A Lump Sum amount of \$98,400.00 unless prior OWNER approval in writing. Additional Services may be performed only with prior OWNER approval in writing.
  - a. Payments to be made by Owner based on work progression.
- 2. In addition to the Lump Sum amount, reimbursement for the following expenses: NONE
- B. The portion of the compensation amount billed monthly for Engineer's Services will be based upon Engineer's estimate of the percentage of the total Services actually completed during the billing period.

#### 3.01 Termination

- A. The obligation to continue performance under this Agreement may be terminated:
  - 1. For cause,
    - a. By either party upon 30 days written notice in the event of substantial failure by the other party to perform in accordance with the Agreement's terms through no fault of the terminating party. Failure to pay Engineer for its services is a substantial failure to perform and a basis for termination.
    - b. By Engineer:
      - 1) upon seven days written notice if Owner demands that Engineer furnish or perform services contrary to Engineer's responsibilities as a licensed professional; or
      - 2) upon seven days written notice if the Engineer's Services are delayed for more than 90 days for reasons beyond Engineer's control, or as the result of the presence at the Site of undisclosed Constituents of Concern, as set forth in Paragraph 5.01.I. The Owner anticipates lead-based paint may be present and therefore shall not be consider a Constituent of Concern.
    - c. Engineer shall have no liability to Owner on account of a termination for cause by Engineer.
    - d. Notwithstanding the foregoing, this Agreement will not terminate as a result of a substantial failure under Paragraph 3.01.A.1.a if the party receiving such notice begins, within seven days of receipt of such notice, to correct its substantial failure to perform and proceeds diligently to cure such failure within no more than 30 days of receipt of notice; provided, however, that if and to the extent such substantial failure cannot be reasonably cured within such 30 day period, and if such party has diligently attempted to cure the same and thereafter continues diligently to cure the same, then the cure period provided for herein shall extend up to, but in no case more than, 60 days after the date of receipt of the notice.
  - 2. For convenience, by Owner effective upon Engineer's receipt of written notice from Owner.
- B. In the event of any termination under Paragraph 3.01, Engineer will be entitled to invoice Owner and to receive full payment for all Services and Additional Services performed or furnished in accordance with this Agreement, plus reimbursement of expenses incurred through the effective







date of termination in connection with providing the Services and Additional Services, and Engineer's consultants' charges, if any.

#### 4.01 Successors, Assigns, and Beneficiaries

- A. Owner and Engineer are hereby bound and the successors, executors, administrators, and legal representatives of Owner and Engineer (and to the extent permitted by Paragraph 4.01.B the assigns of Owner and Engineer) are hereby bound to the other party to this Agreement and to the successors, executors, administrators, and legal representatives (and said assigns) of such other party, in respect of all covenants, agreements, and obligations of this Agreement.
- B. Neither Owner nor Engineer may assign, sublet, or transfer any rights under or interest (including, but without limitation, money that is due or may become due) in this Agreement without the written consent of the other party, except to the extent that any assignment, subletting, or transfer is mandated by law. Unless specifically stated to the contrary in any written consent to an assignment, no assignment will release or discharge the assignor from any duty or responsibility under this Agreement.
- C. Unless expressly provided otherwise, nothing in this Agreement shall be construed to create, impose, or give rise to any duty owed by Owner or Engineer to any Constructor, other third-party individual or entity, or to any surety for or employee of any of them. All duties and responsibilities undertaken pursuant to this Agreement will be for the sole and exclusive benefit of Owner and Engineer and not for the benefit of any other party.

#### 5.01 General Considerations

- A. The standard of care for all professional engineering and related services performed or furnished by Engineer under this Agreement will be the care and skill ordinarily used by members of the subject profession practicing under similar circumstances at the same time and in the same locality. Engineer makes no warranties, express or implied, under this Agreement or otherwise, in connection with any services performed or furnished by Engineer. Subject to the foregoing standard of care, Engineer and its consultants may use or rely upon design elements and information ordinarily or customarily furnished by others, including, but not limited to, specialty contractors, manufacturers, suppliers, and the publishers of technical standards.
- B. Engineer shall not at any time supervise, direct, control, or have authority over any Constructor's work, nor shall Engineer have authority over or be responsible for the means, methods, techniques, sequences, or procedures of construction selected or used by any Constructor, or the safety precautions and programs incident thereto, for security or safety at the Project site, nor for any failure of a Constructor to comply with laws and regulations applicable to such Constructor's furnishing and performing of its work. Engineer shall not be responsible for the acts or omissions of any Constructor.
- C. Engineer neither guarantees the performance of any Constructor nor assumes responsibility for any Constructor's failure to furnish and perform its work.
- D. Engineer's opinions (if any) of probable construction cost are to be made on the basis of Engineer's experience, qualifications, and general familiarity with the construction industry. However, because Engineer has no control over the cost of labor, materials, equipment, or services furnished by others, or over contractors' methods of determining prices, or over







competitive bidding or market conditions, Engineer cannot and does not guarantee that proposals, bids, or actual construction cost will not vary from opinions of probable construction cost prepared by Engineer. If Owner requires greater assurance as to probable construction cost, then Owner agrees to obtain an independent cost estimate.

- E. Engineer shall not be responsible for any decision made regarding the construction contract requirements, or any application, interpretation, clarification, or modification of the construction contract documents other than those made by Engineer or its consultants.
- F. All documents prepared or furnished by Engineer are instruments of service, and Engineer retains an ownership and property interest (including the copyright and the right of reuse) in such documents, whether or not the Project is completed. Owner shall have a limited license to use the documents on the Project, extensions of the Project, and for related uses of the Owner, subject to receipt by Engineer of full payment due and owing for all Services and Additional Services relating to preparation of the documents and subject to the following limitations:
  - Owner acknowledges that such documents are not intended or represented to be suitable
    for use on the Project unless completed by Engineer, or for use or reuse by Owner or others
    on extensions of the Project, on any other project, or for any other use or purpose, without
    written verification or adaptation by Engineer;
  - 2. any such use or reuse, or any modification of the documents, without written verification, completion, or adaptation by Engineer, as appropriate for the specific purpose intended, will be at Owner's sole risk and without liability or legal exposure to Engineer or to its officers, directors, members, partners, agents, employees, and consultants;
  - 3. Owner shall indemnify and hold harmless Engineer and its officers, directors, members, partners, agents, employees, and consultants from all claims, damages, losses, and expenses, including attorneys' fees, arising out of or resulting from any use, reuse, or modification of the documents without written verification, completion, or adaptation by Engineer; and
  - 4. such limited license to Owner shall not create any rights in third parties.
- G. Owner and Engineer may transmit, and shall accept, Project-related correspondence, documents, text, data, drawings, information, and graphics, in electronic media or digital format, either directly, or through access to a secure Project website, in accordance with a mutually agreeable protocol.
- H. To the fullest extent permitted by law, Owner and Engineer (1) waive against each other, and the other's employees, officers, directors, members, agents, insurers, partners, and consultants, any and all claims for or entitlement to special, incidental, indirect, or consequential damages arising out of, resulting from, or in any way related to this Agreement or the Project, and (2) agree that Engineer's total liability to Owner under this Agreement shall be limited to \$40,000 or the total amount of compensation received by Engineer, whichever is greater.
- I. The parties acknowledge that Engineer's Services do not include any services related to unknown or undisclosed Constituents of Concern. If Engineer or any other party encounters, uncovers, or reveals an unknown or undisclosed Constituent of Concern, then Engineer may, at its option and without liability for consequential or any other damages, suspend performance of

Services on the portion of the Project affected thereby until such portion of the Project is no longer affected, or terminate this Agreement for cause if it is not practical to continue providing Services.

- J. Owner and Engineer agree to negotiate each dispute between them in good faith during the 30 days after notice of dispute. If negotiations are unsuccessful in resolving the dispute, then the dispute shall be mediated. If mediation is unsuccessful, then the parties may exercise their rights at law.
- K. This Agreement is to be governed by the law of the state in which the Project is located.
- L. Engineer's Services and Additional Services do not include: (1) serving as a "municipal advisor" for purposes of the registration requirements of Section 975 of the Dodd-Frank Wall Street Reform and Consumer Protection Act (2010) or the municipal advisor registration rules issued by the Securities and Exchange Commission; (2) advising Owner, or any municipal entity or other person or entity, regarding municipal financial products or the issuance of municipal securities, including advice with respect to the structure, timing, terms, or other similar matters concerning such products or issuances; (3) providing surety bonding or insurance-related advice, recommendations, counseling, or research, or enforcement of construction insurance or surety bonding requirements; or (4) providing legal advice or representation.
- M. Liquidated Damages Failure to meet the time lines for completion of work identified in (the project schedule or other appropriate language) will result in liquidated damages of \$50.00 per consecutive calendar day until the work identified in "Exhibit A" Scope of Services is submitted. Liquidated damages are only applicable to items under the control of ENGINEER and will not be enforced due to circumstances out of the control of ENGINEER.

#### 6.01 Total Agreement

A. This Agreement (including any expressly incorporated attachments), constitutes the entire agreement between Owner and Engineer and supersedes all prior written or oral understandings. This Agreement may only be amended, supplemented, modified, or canceled by a duly executed written instrument.

#### **Definitions**

- B. Constructor—Any person or entity (not including the Engineer, its employees, agents, representatives, and consultants), performing or supporting construction activities relating to the Project, including but not limited to contractors, subcontractors, suppliers, Owner's work forces, utility companies, construction managers, testing firms, shippers, and truckers, and the employees, agents, and representatives of any or all of them.
- C. Constituent of Concern—Asbestos, petroleum, radioactive material, polychlorinated biphenyls (PCBs), hazardous waste, and any substance, product, waste, or other material of any nature whatsoever that is or becomes listed, regulated, or addressed pursuant to (a) the Comprehensive Environmental Response, Compensation and Liability Act, 42 U.S.C. §§9601 et seq. ("CERCLA"); (b) the Hazardous Materials Transportation Act, 49 U.S.C. §§5101 et seq.; (c) the Resource Conservation and Recovery Act, 42 U.S.C. §§6901 et seq. ("RCRA"); (d) the Toxic Substances Control Act, 15 U.S.C. §§2601 et seq.; (e) the Clean Water Act, 33 U.S.C. §§1251 et seq.; (f) the Clean Air Act, 42 U.S.C. §§7401 et seq.; or (g) any other federal, State, or local statute, law, rule,

**4.1 Construction Meetings** – Construction Kick-off Meeting – Conduct a construction kick-off meeting with the Contractor and OWNER to review the key construction processes outlined in Contract Documents, establish lines of communication and protocols, identify critical path of schedule, provide four (4) Conform to Bid Documents to Contractor, and issuing Notice to Proceed with executed Contracts to Contractor.

Additional Services can be performed as requested in writing by the OWNER. A detailed scope, schedule and fee will be created upon request by the OWNER as these services are NOT included in the Scope of Work, Schedule, or Fee of this contract.

#### Services Not Included

Any other services, including but not limited to the following, are not included in this Scope of SERVICES:

#### Information Needed from the OWNER

OWNER shall provide at a minimum to ENGINEER, the following items/information/assistance:

- **1.** Furnish any existing data, reports, addresses, maps, plans, or construction drawings, etc. that may pertain to the project as requested.
- 2. Provide access to the tank sites by issuing keys, combinations and approval to enter facilities on as needed basis while under contract to inspect the facility.



#### **Time Period for Performance**

Time periods for performance of the SERVICES are as follows:

10 months - TASK 1.0 2 months - TASK 2.0 2 months - TASK 3.0 6 months - TASK 4.0 TOTAL 10 months

#### **Method of Payment**
