Motion No. 4 – Second Park Entry Sign

A motion was made to authorize expenditures of up to \$18,000 for the purchase of a second entry sign to be installed at one of the City of Sweeny parks. Notes: EDC will purchase the first entry sign, and the second sign will be purchased by Sweeny Parks and Recreation (up to \$18,000) and Sweeny Chambers of Commerce (\$3000).

Motion No. 5 – Additional Playground Equipment

A motion was made to purchase additional playground equipment for EXA Mae Keller Park, including a small bulldozer play feature and an outdoor tic-tac-toe activity panel.
