- a) CHANCE - Report by James Page

James Page, CADC-II with CHANCE presented a power point titled “Evidence Based Strategies to Eliminate Stigma”, on opioid abuse and addiction, treatment and recovery, as well as general information on what CHANCE does. Other discussion included setting measurable goals, starting with small steps, and other measures to help get people the solution to their addiction. The increase in addiction due to isolation during COVID has been evident.
