## Reports of Committees:

Chairperson Gourley recognized a new committee Homelessness Action Committee and asked Dr. Horton to give a report. Brock Beyers, Family Assistance Resource Group, facilitated the group and brought a group together who met for four days. Discussion and input included efforts at the Nazarene Church where 17 tents house 23 individuals until March 31st. The subcommittee is seeking alternative sites for the group come April 1st. The Family Assistance Resource Group has offered to help manage the site as well as provide resources. The group identified a tag line: Helping People Help Themselves; a vision: Improving the Livability in our Community Through Hope and Wholeness; and mission statement: To Provide a Safe, Clean, Diverse Environment Where People Experience Unstable Living Conditions, Can Receive Services, Improving Lives with Dignity and Respect.
