Reports of Committees:

Community Health Fair Committee

Bob Dalton reported on the Health Fair and stated he is already getting inquiries. The committee is looking to support Mental Health issues among students, especially ones without a permanent address.

Chair Gourley added to her observations regarding mental health and suggested a led discussion thru a parent cafe. Current parent classes and support groups were discussed.

Western University

Dr. Larry Horton reported on focus group progress. Data is currently being compiled and a report on findings may be out in a month. Zoom meetings and in person mentoring is occurring.

Homeless Action Committee

There are 23 clients currently at the FAC site. Manna is serving meals 3 days a week and FAC is serving 2 meals a day for 7 days a week. Permanent housing has been found for 4 clients. Clients are keeping the area clean by picking up trash and cleaning restrooms.

Chief Ogden stated that calls are low compared to calls at the old City Hall. Fire Chief Tyler reported that calls from the Sweet Home Fire and Ambulance district were lower as well.

It was reported that many of the clients now have managed plans. Statics were reported by the clients as to the number of veterans, addicts, OHP, Social Security benefits, Social Security with disabilities, an other information such as mental disabilities and past trauma. It was reported that most of the clients have ties to Sweet Home and very few of the clients come from outside the community.

The City Manager reported on March 1st the City Council declared a State of Emergency prompting Linn County to partner with us by requesting the Governor add us to their State of Emergency which will help us with funding. The City is hoping for aide for a Family Shelter.

Old Business:

Chair Gourley stated the committee needs to set new goals and decide what the community needs that the committee could work on. Parent Cafes were discussed.
