## Approval of Minutes

Mayor Coleman moved to approve the minutes of the November 21, 2023 Ad Hoc Committee on Arts & Culture meeting. Committee Member Horton seconded the motion. The motion carried unanimously by those present.

## Old Business

### Mural RFP Update

Director Pretty stated that the selection jury had met and selected two artists with contract negotiations pending. She added that additional artists may be selected in future phases and as additional funding became available.

### Bronze Statues

Committee Member Peda stated that a community group was interested in providing funding for a memorial statue of Alice Grovum, a celebrated volunteer with the Sweet Home Beautification Committee. She asked the the committee assist in developing a cost estimate.

### New Business

#### Grants Update

Committee Member Peda stated that a grant application was submitted to the Sweet Home Community Foundation and an award of \$5,000 was granted to support the mural effort.

#### Salmon Cutouts

Mayor Coleman stated that any additions to the medians would need to be small in size to comply with Oregon Department of Transportation regulations.

Discussion ensued regarding enlisting high school students to create the salmon cutouts. No action was required for this item.

Mayor Coleman suggested modifying the meeting schedule to quarterly. There was consensus for same.

Discussion ensued regarding collaboration with the Park & Tree Committee to bring arts programming to city parks.
