Dick Knowles commended Sean Morgan for the data. Tomorrow is the Linn County Heart memorial for those who have passed away while living on the streets. Dick Knowles reported on the number of the community who were affected by the closure of Bi-Mart pharmacy,

Bob Dalton stated the City has made phenomenal progress in the past year with the homelessness issue. Fundraising goals have almost been met for the new Samaritan Facility.

Dr. Horton also reported on the progress over the past year and acknowledge the work Sean Morgan has been doing.
