City Council Work Session - Charter Amendments

a) Proposed Charter Amendment

City Manager Pro Tem Pretty stated that there were currently three efforts underway proposing to modify the Charter regarding the election of the Mayor: a citizen-led petition, a direct referral to the ballot by City Council, and a Charter Review Committee. She reviewed the duties of the Mayor under the current City Charter and Council Rules. She explained the processes for a direct referral, citizen-led petition, and Charter Review Committee. She noted that a prospective petition was filed on February 4, 2025 but due to statutory timelines, it would not be possible for the initiative to appear on the May 2025 ballot. She reviewed the items the Mayor had charged the Charter Review Committee to review and noted that this process would potentially allow for greater public input. She added that the City Council would ultimately be responsible for deciding on direct referrals to the ballot of any Committee recommendations. She stated that elections outside of May or November of even years would incur costs to the City. She reviewed the cost methodology for elections and noted that it was not possible to estimate costs due to the variability of the number of initiatives and jurisdictions appearing on the ballot. She stated that the last election that incurred costs to the City of Sweet Home occurred in 2015 and cost over \$10,000.

City Manager Pro Tem Pretty stated candidates would not be able to run for Councilor and Mayor simultaneously under State law. She noted that Councilors in the middle of serving their terms would not be required to vacate their seats if they chose to run for Mayor. She stated that the language as presented would eliminate any two-year terms for Councilors and all would serve four-year terms. She reviewed recent history of previous Charter review processes. She noted that the ability to vote was governed by State law and that one's primary residence determined where they were eligible to vote, not their status of property ownership.

Councilor Sanchez asked of the Mayor's ability to allocate Commercial Exterior Improvement Program (CEIP) funds if they exceeded a certain amount. City Manager Pro Tem Pretty stated that the Mayor was typically not involved in allocating CEIP funds but she would review the program terms to confirm. Councilor Sanchez asked of the cost to place two levies on the May 2025 ballot as planned. City Manager Pro Tem Pretty stated that it was not possible to estimate the costs due to Linn County's cost methodology but noted that it was unlikely that placing the charter amendment on the ballot would lead to savings. Councilor Sanchez expressed support for City Council referring the amendment to the ballot regardless of cost.

Mayor Coleman asked how the required number of petition signatures was determined. City Manager Pro Tem Pretty replied that it would be 15% of the registered voters at the time the petition is filed. Mayor Coleman asked how the signatures would be verified. City Manager Pro Tem Pretty stated that they would be verified by Linn County. Mayor Coleman asked of the eligibility to sign the petition. City Manager Pro Tem stated that only those registered to vote within City limits would have valid signatures. Mayor coleman asked of the time investment from staff to manage the petition and prospective referral. City Manager Pro Tem Pretty replied that the petition required the highest time investment due to research, establishing timelines, and preparing legal notices. Mayor Coleman asked if anyone had the ability to file a petition. City Manager Pro Tem Pretty replied that anyone could.

Councilor Bronson stated that the current Mayor could not be replaced until her current term expired in 2027 and expressed support for delaying the charter amendment to a later election to allow for additional conversation and engagement.

Councilor Richards expressed support for referring the amendment to the May 2025 ballot.

Councilor Sanchez stated that 11 out of 13 cities in Linn County directly elect their Mayor.

Councilor Augsburger expressed support for referring the amendment to the May 2025 ballot based on community input she received.

Mayor Coleman asked how a community could remove an elected Mayor. City Attorney Larsen replied that it would follow the same recall process as any elected Councilor. Mayor Coleman noted that a direct referral to the May 2025 ballot would limit public comment opportunity compared to a referral to the Charter Review Committee. She asked of the process to challenge the direct referral. City Attorney Larsen stated that voters could challenge the ballot title during the standard challenge period or vote the initiative down in the election. Mayor Coleman noted that the Charter Review Committee would allow for consideration of multiple issues including direct election of the Mayor. She expressed support for delaying the vote to allow for more public comment opportunities.

Councilor Augsburger stated that placing the referral resolution on the next City Council agenda would allow for public comment opportunity.

Councilor Sanchez noted that the amendment would preserve the current weak Mayor system.

Councilor Hegge stated that he had received community input in opposition to a direct election of the Mayor and expressed support for a more thorough public input process. He asked if the language presented to City Council during the Work Session is what would appear on the ballot. City Attorney Larsen stated that City Council had the option to modify the language prior to referral to the ballot.

Councilor Augsburger reiterated that a public vote would allow the public to voice their opinion.

There was consensus to place a direct referral of the amendment on the next City Council agenda.

Work Session - Boards, Committees & Commissions Review

City Manager Pro Tem Pretty provided an overview of the general function of boards, committees, and commissions in the City. She noted that they provided residents and appointees the opportunity to influence policy direction for the City of Sweet Home. She added that City Council had the ability to refer questions and topics to relevant advisory bodies for review and recommendations. She reviewed the governance, composition, meeting schedule, and responsibilities of the following: Planning Commission, Park & Tree Committee, Library Board, Public & Traffic Safety Committee, Community Health Committee, Budget Committee, and the Board of Appeals. She reviewed current vacancies on Planning Commission and the Budget Committee. She requested City Council feedback regarding the existing committees and their charges, the roles of Council liaison assigned to advisory bodies, and any other changes they wished to see.

Mayor Coleman asked of actions City Council may take related to parks and trees that do not go through the Park & Tree Committee. Staff noted the importance of the assigned Council liaison to communicate with City Council to reduce potential conflicts between Council action and previous plans approved by the Committee.

Discussion ensued regarding Planning Commission and whether City Councilors have the ability to attend or interact with the Commission. City Councilors were advised that they may attend but should not attempt to sway any decisions of the Planning Commission, particularly if they have personal bias. City Attorney Larsen stated that Councilors who review Planning Commission materials and meetings in advance of a City Council vote should ensure they declare ex parte information as a result of their attendance or review, and to recuse themselves if they have any personal bias.

Mayor Coleman invited Councilors to recommend ideas for committees to review and to encourage community member participation.

Councilor Augsburger asked of the best way to refer ideas to the committees. City Manager Pro Tem Pretty recommended suggesting items during Council Business for the Good of the Order and requesting a referral to the appropriate committee.

Discussion ensued regarding potential changes to committees regarding residency requirements. No recommendations from City Council were made.

President Pro Tem Thorstad asked of the Administration, Finance, and Property Committee. City Manager Pro Tem Pretty stated that she had not included it in the presentation as it was not a citizen-led committee, but noted that it primarily served as a way to interview committee applicants and make recommendations for appointment to the full City Council for consideration. Mayor Coleman stated that the Charter Review Committee could examine that process and make recommendations for changes.

Purpose of this RCA:

The purpose of this RCA is to present a potential Charter Amendment Referral that, if passed by the voters of the City of Sweet Home, would change the office of Mayor to one that is directly elected by the voters, rather than elected by the City Council from among the membership of the Council.

Background/Context:

At a City Council work session held on February 11, 2025, the City Council, by consensus, directed staff to draft the necessary documents for a ballot measure that would amend the City Charter so that the position of Mayor is elected by voters, rather than by the City Council from among the membership of the Council.

The text of the amendment presented at that work session is as follows, with deleted text in strikethrough, and added text in **bold**:

Section 3 Council And Mayor

Except as otherwise provided in this charter, all powers of the city shall be vested in a council of seven members nominated and elected from the city at large.

At each biennial general election, four three councilors and a mayor shall be elected. The three receiving the highest number of votes councilors shall each hold office for four years, and the one receiving the number of votes next to the three highest mayor shall hold office for two years. Tie votes shall be determined by lot.

At its first meeting of the new term after each biennial general election, the council shall elect from its membership a chairperson who shall be mayor for a term of two years.

The mayor and councilors in office at the time of adoption of this charter shall continue in office until the expiration of their respective terms, with powers and duties as provided in this charter.

In order to meet the deadlines imposed by the applicable State statutes, a resolution referring a matter to the voters at the May 20, 2025, election must by passed by the City Council no later than February 28, 2025.

The attached resolution and attachments include all the documents that must be approved by the Council in order to refer this Charter amendment to the voters at the May 20, 2025 election.

If approved by voters, the first election that would be impacted by this amendment is in November 2026, and any Councilor wishing to run for mayor at that election would have to declare his or her candidacy for mayor, and would not be able to seek a City Council seat. If a Councilor was elected Mayor, and that Councilor's current term would not end at the end of 2026, then upon his or her swearing in, there would immediately be a vacant seat on the Council which would need to be filled by the Council.

The Challenge/Problem:

Should the City Council refer a charter amendment to the voters of the City of Sweet Home on May 20, 2025?

Stakeholders:

- <u>Sweet Home City Council</u> The City Council has the authority to refer measures to eligible voters within the City of Sweet Home.
- <u>Sweet Home Citizens</u> Citizens must approve any amendment to the City of Sweet Home Charter.

Issues and Financial Impacts:

The financial impacts of this matter are limited to staff time, required publications, and election-related fees, which are unknown at this time. As noted at the February 11, 2025 City Council Work Session, any City measures in odd-numbered years will impose a cost on the City, while City measures in even-numbered years can be placed on the ballot at no cost to the City.

Elements of a Stable Solution:

A stable solution is one that complies with State law and implements the will of the Council and Sweet Home Citizens.

Options:

- 1. Do nothing No measure would be referred to voters on May 20, 2025.
- 2. Adopt Resolution No. 6 for 2025, A Resolution of the Sweet Home City Council to Refer Amendment of City Charter Chapter II, Section 3 Council and Mayor, to the Electors of the City and Adopting a Ballot Title and Explanatory Statement as presented.
- 3. Adopt Resolution No. 6 for 2025, A Resolution of the Sweet Home City Council to Refer Amendment of City Charter Chapter II, Section 3 Council and Mayor, to the Electors of the City and Adopting a Ballot Title and Explanatory Statement with changes.

RESOLUTION NO. 6 FOR 2025

A RESOLUTION OF THE SWEET HOME CITY COUNCIL TO REFER AMENDMENT OF CITY CHARTER CHAPTER II, SECTION 3 COUNCIL AND MAYOR, TO THE ELECTORS OF THE CITY AND ADOPTING A BALLOT TITLE AND EXPLANATORY STATEMENT

WHEREAS, only the voters of the City of Sweet Home can approve amendments to the Charter of the City of Sweet Home; and

WHEREAS, members of the community have shown interest in amending the Charter such that the position of Mayor is directly elected by the Electors of the City of Sweet Home; and

WHEREAS, the Sweet Home City Council has discussed and heard from citizens about the benefits and detriments of both the current method of selecting the Mayor and other methods;

NOW, THEREFORE, the City Council resolves as follows:

Section 1. Proposed Charter Amendment. If a majority of eligible voters vote "yes" on the following measure, Chapter II, Form of Government, Section 3 of the Charter of the City of Sweet Home will be amended as follows, with strikethrough text deleted, and **bold** text added:

Section 3 Council And Mayor

Except as otherwise provided in this charter, all powers of the city shall be vested in a council of seven members nominated and elected from the city at large.

At each biennial general election, four three councilors and a mayor shall be elected. The three receiving the highest number of votes councilors shall each hold office for four years, and the one receiving the number of votes next to the three highest mayor shall hold office for two years. Tie votes shall be determined by lot.

At its first meeting of the new term after each biennial general election, the council shall elect from its membership a chairperson who shall be mayor for a term of two years.

The mayor and councilors in office at the time of adoption of this charter shall continue in office until the expiration of their respective terms, with powers and duties as provided in this charter.

Section 2. Referral. The ballot title attached as Attachment A and the above text shall be filed with the City Elections Officer and referred to the legal voters of the City of Sweet Home, Linn County, Oregon at an election on May 20, 2025.

Section 3.	Election. May 20, 2025 is designated as the date for holding the election for the purpose of voting on this measure. The precinct for the election shall be all of the territory within the corporate limits of the City of Sweet Home, and the election shall be conducted by the Linn County Clerk's Office by mail.
Section 4.	Publication. The City Elections Officer is directed to publish notice of receipt of the ballot title under standard procedures and in compliance with ORS 250.275(5).
Section 5.	Filing with County. The City Elections Officer shall file the ballot title with the Linn County Clerk as required by ORS 254.095 and include the proposed measure in the statement of city measures to be voted on.
Section 6.	Explanatory Statement. The Explanatory Statement for the measure on Attachment B shall be submitted for inclusion in the voters' pamphlet as provided in ORS 251.345.
Section 7.	No Position. The City Council takes no position in favor of, nor opposing this proposed measure.

Should the Sweet Home Charter be changed so that the Mayor is elected by voters, rather than the City Council?

C. Summary (175 words allowed, 175 total)

The Sweet Home Charter is the constitution of the City of Sweet Home. Under the Charter, the role of Mayor is limited to acting as chairperson of the city council, presiding over council meetings, appointing committees, and signing ordinances and other documents authorized by the city council. Last amended in 2014, the Charter currently states that the city council "shall select from its membership a chairperson who shall be mayor for a term of two years."

A "YES" vote changes the Charter to allow for direct election of the Mayor by the voters of the City of Sweet Home instead of the current process of the mayor being selected by the city council. The Mayor and councilors currently in office would continue to serve in their offices for the remainder of their terms, three councilors and the Mayor until January 2027, and the other three councilors until January 2029.

This amendment does not change any of the powers or duties of the Mayor.

The first election affected by this measure would be in November 2026.

Attachment B to Resolution No. 6 for 2025

Measure No. 25-_____ Explanatory Statement (500 words allowed, 427 words total)

The Oregon Constitution gives city voters the right to adopt, amend, and revise the City Charter.

Sweet Home voters last amended the City Charter in 2014.

The City Charter is the constitution of the City if Sweet Home, and dictates, among other things, the powers of the City, the powers and duties of city officers, and how city officers are selected.

Under the current charter, the office of Mayor is the chairperson of the council and presides over council meetings. The charter gives the Mayor the power to call special meetings, appoint members of committees, determine the order of business, and sign all ordinances and other writings authorized by the council. The Mayor is a member of the city council and may vote as a city councilor.

Regarding the election of councilors, the current charter states that at each biennial election (November of even numbered years), four councilors shall be elected: the three with the highest number of votes serve four-year terms, and the one with the least number of votes serves a two-year term.

Regarding the election of the Mayor, the charter states that at the first meeting of the new term after each biennial election, the Mayor is elected from the membership of the city council for a term of two years.

This proposed measure would amend the current City Charter Chapter II FORM OF GOVERNMENT, Section 3 Council And Mayor to read as follows:

Section 3 Council And Mayor

Except as otherwise provided in this charter, all powers of the city shall be vested in a council of seven members nominated and elected from the city at large.

At each biennial general election, three councilors and a mayor shall be elected. The councilors shall each hold office for four years, and the mayor shall hold office for two years. Tie votes shall be determined by lot.

The mayor and councilors in office at the time of adoption of this charter shall continue in office until the expiration of their respective terms, with powers and duties as provided in this charter.

This measure would change the election process for city councilors and the mayor by eliminating one city council position and changing the position of mayor to an office that is elected to a two-year term by registered voters within the boundaries of the City of Sweet Home. Remaining city councilors would all have four-year terms, and three of them would be elected at each biennial election.

The City Council adopted this Explanatory Statement but has taken no position favoring nor opposing this proposed measure.

Purpose of this RCA:

The purpose of this RCA is to present for City Council consideration an Ordinance that amends Ordinance Nos. 427 (pertaining to certain street names), 825 (pertaining to certain subdivision street names), 975 (pertaining to Wild, Exotic, or Dangerous Animals), 1224 (pertaining to Animals and Birds), and 1322 (the Alyrica Franchise Agreement).

Background/Context:

The previous City Attorney, Robert Snyder, discovered last year that several City Ordinances did not have the clause "the City of Sweet Home does ordain as follows" that is required by the Sweet Home Charter for enacting ordinances. Consequently, he drafted the proposed ordinance to correct this problem. The current City Attorney has reviewed his findings, and the Ordinance he drafted, and agrees that this correction should be made.

These ordinances are not being changed in content by the proposed ordinance except that each will now include the charter clause. Ordinance 427 was used to name some streets; Ordinance 825 was used to name a few subdivision streets; Ordinance 975 dealing with Wild, Exotic or Dangerous Animals (wolf, poisonous reptile, alligator, etc.) and Ordinance 1224 dealing with Animals and Birds (amount and area for certain animals). Ordinance 1322 is the Franchise Agreement with Alyrica Networks. The remaining text in these ordinances is to remain as passed. Ordinance 975 is found at SHMC 6.12 and Ordinance 1224 is found at SHMC 6.04. The other ordinances are contained in the Sweet Home Municipal Code.

The proposed ordinance will amend said Ordinances, which were previously passed by the City Council, with the enacting clause required by the City Charter.

A first and second reading of the Ordinance were conducted during the City Council meeting on February 11, 2025.

The Challenge/Problem:

Should the City of Sweet Home pass the proposed Ordinance to have said Ordinances include the enacting clause as set forth in the City Charter?

Stakeholders:

- <u>City of Sweet Home Staff</u>: The Ordinance provides a consistent approach to Ordinances.
- <u>Sweet Home City Council</u>: The Council is responsible for passing Ordinances that conform to the requirements of the City Charter.

Issues and Financial Impacts:

This Ordinance has no financial impact.

Elements of a Stable Solution:

The amendment of all non-conforming ordinances with the Enacting Clause required by the Sweet Home City Charter.

Options:

- 1. <u>Do nothing</u>: Keep the current Ordinances as passed. This leaves some Ordinances out of compliance with the City Charter
- 2. <u>Motion to approve the Ordinance as proposed</u>: City Council may approve the Ordinance without changes.
- 3. <u>Motion to approve proposed ordinance with changes</u>: The Council may make changes to the proposed ordinance.
- 4. <u>Direct Staff to draft other or different provisions and terms for the ordinance.</u>

Recommendation:

Staff recommends option 2: Move to approve the Ordinance as proposed.

Section 1. The clause, "The City of Sweet Home does ordain as follows:", is hereby inserted in its own paragraph directly after the title in Ordinance No. 427, Ordinance No. 825, Ordinance No. 975, and Ordinance No. 1224 and directly after the "Ordinance No. 1322" in Ordinance No. 1322 of the City of Sweet Home Ordinances and the said five Ordinances are incorporated herein and made a part hereof as if fully set forth herein with any Ordinance amendments thereto passed by the Sweet Home City Council prior hereto.

Section 2. <u>EXPEDIENCY CLAUSE</u>. It is hereby adjudged and declared by the Sweet Home City Council that existing conditions are such that this Ordinance is needed to be in effect at the time and date of its passage by the City Council and approval by the Mayor and it is hereby declaring an emergency to promote the public safety and welfare.

First Avenue Truck Signage

City Manager Pro Tem Pretty stated that the size and quantity of signage on First Avenue to indicate through-trucks were not allowed. Chair Gallagher stated that he had observed a reduction in trucks on First Avenue since the installation of the new signage.

No action was required for this item.

First Avenue Traffic Control Update

City Manager Pro Tem Pretty stated that an engineering firm had been selected to perform an analysis and make recommendations regarding temporary traffic controls on First Avenue and work was anticipated to begin soon. She noted that the Committee had recommended speed humps on First Avenue to City Council in 2015 for a cost of \$10,800 but City Council voted against approval of the new traffic control.

Vice Chair Graybill expressed interest in observational data regarding any preferred detours once traffic controls were installed.

Committee Member Adams expressed support for both permanent and temporary speed humps based on his observations in other cities.

No action was required for this item.

First Avenue Crosswalks

Chair Gallagher expressed support for additional or improved crosswalks on First Avenue, such as at Nandina Street.

Vice Chair Graybill noted the lack of a crosswalk at First and Main Street and recommended its addition. Committee Member Adams expressed agreement with both recommendations.

No action was required for this item.

Transportation System Plan

City Manager Pro Tem Pretty reminded the Committee that the Transportation System Plan (TSP) was approaching its final draft and stated that the first reading of the Ordinance to adopt the TSP was tentatively scheduled for City Council on April 22, 2025. She noted that Committee Members could submit comments to staff for final incorporation. Planning and Building Manager Clegg added that it would come before the Planning Commission before City Council for an additional public comment opportunity.

Vice Chair Graybill asked if the final draft was available for public review yet. City Manager Pro Tem Pretty replied that it was not but it would be distributed once available.

No action was required for this item.

New Business

Engine Brake Usage

Chair Gallagher stated that he had received community feedback regarding the use of engine brakes (or "jake brakes") despite a prohibition in City limits. Discussion ensued regarding enhanced signage reminding drivers of the prohibition. City Manager Pro Tem Pretty stated that existing signage was likely under the jurisdiction of the Oregon Department of Transportation (ODOT) but staff would investigate options.

Chief Ogden stated that engine braking was prohibited on all highways in Oregon.

No action was required for this item.

Good of the Order

Vice Chair Graybill asked of a prior request for stop signs at 12th Avenue and Tamarack. Chief Ogden stated that he reviewed the location and it was not an appropriate location for additional signage.

Committee Member Adams expressed concern regarding parking commercial vehicles on residential streets, particularly with those parked facing the wrong direction.

City Manager Pro Tem Pretty reminded the Committee that public safety and crime-related items are under the purview of the Committee if there were items they wished to discuss. She stated that the Police Department levy would be on the May ballot and that it funded the entirety of the department.

Committee Member Adams asked of issues related to bicycle safety in Sweet Home. City Manager Pro Tem Pretty stated that a section of the TSP addressed needs to enhance bicycle safety and facilities.

President Pro Tem Thorstad requested that the monthly data published in City Council agendas regarding
Police Department statistics be included in future Committee packets.
