The Council also agreed by Consensus to include site improvements for a shared driveway which would include a gravel road base, and water and sewer infrastructure (using 50K of Marijuana Tax Funds only). The Council agreed to also allow an easement for FAC and Linn County.

The purpose of this Request for Council Action is to update the Council on actions regarding the proposed agreement with Family Assistance and Resource Center Group (FAC), and the development of a facility for the unsheltered in Sweet Home.

Background/Context:

At the February 8, 2022 meeting, the City Council voted to request that Linn County donate property directly to FAC, and that City Staff continue to work with FAC on an agreement for services. Since that time, Staff have been working with Linn County to work out details for the donation of the property. Staff have also been working with FAC to update the previous agreement to fit the current situation.

The Challenge/Problem:

How does the City address the impacts of homelessness in a way that meets the needs of the housed, unhoused, and business community, while still following case law and State statutes?

Stakeholders:

- <u>Sweet Home Residents</u> Residents deserve a neat, clean, and orderly city. Unsheltered residents need a place to sleep and keep warm.
- <u>Sweet Home Businesses</u> Local businesses deserve a city in which they can operate their businesses and serve customers in the community without the negative impacts that typically accompany homelessness.
- <u>Sweet Home City Council</u> Council members are the voice of the citizens they serve and represent and are responsible for determining the uses and services offered on City property.

- <u>City of Sweet Home Staff</u> City Staff need to be able to enforce Sweet Home ordinances but are prevented from doing so by court decisions and State law.
- <u>Family Assistance and Resource Center Group</u> FAC desires to serve the unsheltered and others in the community, but needs a site from which to do so, and would like to cooperate with the City to do this.

Issues and Financial Impacts:

FAC has obtained grant funding of over \$400,000 to create and operate the proposed facility. This funding will cover all development costs except for Public Works Staff time, the value of which is expected to amount to \$15,000. The City budgeted \$50,000 in the current fiscal year to address homelessness, of which \$42,700 remains. This funding would be tapped to pay for Public Works Staff time. In addition, the City would commit to providing nighttime security at the site, which is expected to cost approximately \$88,000 annually.

Elements of a Stable Solution:

An ideal outcome would be to partner with a non-profit organization for the creation and operation of a facility that provides services for the unsheltered, which would allow the City to follow court decisions and State statutes, but still enforce ordinances that promote a safe, clean, and orderly community.

Options:

City Staff are not currently seeking any Council action, however, as always, the Council is welcome to provide any additional direction it so chooses.

Recommendation:

None at this time.

Respected Commissioners,

The purpose of this memo is to update you on the City's actions regarding our cooperation with Family Assistance and Resource Center Group (FAC) to address homelessness in Sweet Home, and to request that the County donate land for this purpose to FAC.

Background

For several months, City Councilors and Staff have discussed various options with Linn County Commissioners and Staff regarding the so-called 'knife-shaped' property. There seems to be general agreement that a facility for the unsheltered could be located on the eastern third of the property, and a County-owned RV dump station may be developed on the western two-thirds. A partition of the property and accompanying easement through the neighboring City property has been approved by the City of Sweet Home, and a final plat is being prepared for recording. While the City has declined to accept the property from Linn County, FAC has indicated its desire to own the property and develop its facility there.

The City has also been working toward developing a rail crossing in order to extend 24th Avenue to the north—an effort for which Linn County and Albany & Eastern Railroad have indicated support. Currently, the 'handle' of the 'knife-shaped' property extends eastward to that street, and the whole property is accessed at that point. Unfortunately, this access is not compatible with a rail crossing—a driveway or street would need to be at least 100 feet south of the proposed rail crossing. Consequently, the City is seeking to change access to the property to make way for the rail crossing and is willing to provide an easement through the City's Public Works facility to facilitate the rail crossing.

Proposed Development

The City, FAC, and Linn County Parks Department have collaborated on a site plan for the property, which can be seen on the enclosed map. As you can see, an easement through the City's property is proposed to provide access to both portions of the 'knife-shaped' property, as well as an easement through the eastern portion of the property that would benefit the western portion. These easements will include street lighting and water, power, and telecommunications lines to serve both properties. Wastewater connections will be made along the south side of the property to a City wastewater main line.

In order to accommodate pedestrians and large recreational vehicles, the driveway to the two properties will need to include paved vehicle lanes and a sidewalk or multi-use path along the southern edge, separated by a three-foot-wide strip (often called a 'beauty strip'). While a 'beauty strip makes the site more attractive, its main purpose is safety—greater distance between moving vehicles and pedestrians decreases accident rates.

The FAC facility will include exterior parking, an office building, and a fenced compound containing site lighting, security cameras, portable restrooms, a mobile shower unit, and 'Conestoga huts'— small, insulated, mobile structures that provide basic shelter. The fencing will be constructed with privacy slats, providing a visual barrier around the site. The proposed County RV dump site will consist of service islands where RVs can dump their waste, a bulk water filling station, a turnaround loop, and a small pet recreation area.

City Council Actions

The City Council has been working toward an agreement with FAC and the creation of a facility for the unsheltered for over a year. At its January 25, 2022 meeting, the City Council approved an agreement for services with FAC. This agreement was based on the idea that FAC would be leasing property from the City, and therefore has not been signed and needs to be updated. Later, at its February 8, 2022 meeting, the City Council voted 5-1 in favor of entering into an agreement with FAC to operate a facility for the unsheltered and request that Linn County donate property to FAC for this purpose. At the same meeting, the Council voted 7-0 to authorize an easement through the City's Public Works Yard to the 'knife-shaped' property.

Since that meeting, City Staff have been working to move this project forward. FAC is currently revising the agreement for services, after which the City will make revisions. City Staff have also met with Linn County Parks Director Brian Carrol to iron out the details of this venture.

Request


The City of Sweet Home requests the Linn County donate the eastern third of the 'knife-shaped' property to FAC. While there are still many items to be worked out regarding this project, the City and FAC are well on our way to working them out. There are additional items to be worked out with Linn County, of course, but they are not negatively affected by the proposed donation of the property. There are still agreements needed regarding the allocation of development costs, but those agreements are necessary for the development of the RV dump station, not the facility for the unsheltered.

We are trying to work as fast as possible on this proposal. FAC has been approved for grants to fund their operations, but these funds are contingent upon owning or leasing a property on which a facility can be built. The transfer of the property to FAC will allow FAC to obtain these funds.

I appreciate your kind attention to this matter, as well as your willingness to collaborate with the City.

Purpose of this RCA:

To remove barriers to access of library materials for all Sweet Home Library cardholders we are asking the City Council to permanently eliminate fines on library materials, as approved by the Library Advisory Board.

Background/Context:

The threat of accumulating fines for late library materials can keep low-income families away from libraries or from checking out materials to take home. These fines can negatively affect the borrowing habits of members of the community that need the library the most. Removing barriers or perceived barriers to access of library materials can increase visits to the library and the circulation of materials. Many libraries have noted a dramatic increase in the number of items returned to the library after fines were eliminated. Libraries can also generate positive publicity and increased usage from all city residents by going fine free.

During our 3-month trial period, staff saw a 79% decrease in long overdue items year over year. This saves staff a few hours every week of calling patrons. Staff are spending 3-4 hours per month less on accounting duties. Staff savings alone far exceed the \$60 average fines were bringing in each month.

Charges for lost materials will still occur if an item is not brought back to the library within 30 days of being due.

The Challenge/Problem:

How does the City eliminate barriers to the access of library materials in the library and in the home?

Stakeholders:

- <u>City of Sweet Home Library Residents</u> Residents pay property taxes for the library through a levy. The library works with the money they invest to operate the public library.
- <u>Sweet Home City Council Members</u> Council members are the voice of the citizens they serve and represent.
- <u>Library Advisory Board</u>– Appointed members of the community whose role is to make recommendations to the City Council about rules and policies for the efficient and effective operation of the library.
- <u>Sweet Home Public Library card holders</u>- Members of the community that use and wish to continue to use the library collections at the library and in their homes.
- <u>Sweet Home Public Library staff</u>- Library staff interact with library users daily and provide excellent customer service.

Issues and Financial Impacts:

The library believes the financial impact will be minimal to the library's budget, but the impact on the community and those that can least afford to pay the fines will be large. September-October the average per month for fines paid was \$60.

Elements of a Stable Solution:

The ideal outcome will be to work towards addressing economic disparities in the community when it comes to access to library materials and to remove barriers to access of information, as well as direct limited staff time to other projects and duties.

Options:

- 1. <u>Do Nothing</u> Return to placing fines on all library materials and library staff again collect fines.
- <u>Motion to adopt Resolution No. 6 for 2022 as presented, which eliminates library fines</u> <u>permanently</u> – The computer system will automatically no longer charge fines on library materials, with no intervention from library staff.
- <u>Motion to adopt Resolution No. 6 for 2022, amended to eliminate library fines only for an</u> <u>additional three months</u> – Fines will continue to be waived for materials for another three-month trial period.

Recommendation:

The Library Advisory Board recommends option 2, *Motion to adopt Resolution No. 6 for 2022* as presented, which eliminates library fines permanently.

WHEREAS, the Sweet Home Public Library receives far less than 1% of funding from the payment of library fines;

WHEREAS, the Library Board desires to eliminate overdue fines for library materials going forward;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SWEET HOME RESOLVES AS FOLLOWS:

The Sweet Home Public Library will eliminate overdue fines for library materials.

Purpose of this RCA:

The purpose of this RCA is to approve and sign the Conditional Use application CU22-04. Per SHMC 17.24.030(H) a Public Utility Facility is allowed via a Conditional Use. A new Conditional Use application shall be processed if a proposed change results in a change to lot or parcel boundaries and if there is an increase in the amount of operational activity (SHMC 17.80.060(A)(3) and (5). The City of Sweet Home Wastewater Treatment Plant (WWTP) is an existing facility serving all residents and businesses in the City of Sweet Home. The applicant (the City of Sweet Home) is proposing major modifications required by Oregon Department of Environmental Quality.

Background/Context:

Under SHMC 17.24.030(H) a Public Utility Facility is allowed via a Conditional Use in the Residential Low Density (R-1) zone. On November 17, 2020, land use applications PLA20-07, PLA20-08, PLA20-09 and PLA20-10 were approved administratively. The property line adjustments were completed to allow for the improvements and expansion of the existing WWTP. SHMC 17.80.060(A)(3) and (5) states that a new Conditional Use application shall be processed if a proposed change results in a change to lot or parcel boundaries and if there is an increase in the amount of operational activity. The WWTP project includes both an increase in operational activity, and a change to lot boundaries, and will, therefore, require a Conditional Use Permit.

The Challenge/Problem:

How does the City proceed with the WWTP project and comply with City Code?

Stakeholders:

• <u>City of Sweet Home Residents</u> – The expansion of the WWTP will result in better and more reliable wastewater service, as well as increased capacity.

- <u>Downstream Residents</u> Residents downstream of the WWTP will enjoy improved water quality.
- <u>Oregon Department of Environmental Quality</u> DEQ regulates wastewater services and oversees water quality in the South Santiam River. Improvements will comply with Administrative Order from DEQ to expand the plant.

Issues and Financial Impacts:

While the overall project includes many financial impacts, this particular application involves only staff time and public notice requirements.

Elements of a Stable Solution:

A stable solution is one in which a decision on the application is made and signed.

Options:

- 1. <u>Deny Application CU22-04</u> staff would withdraw the application.
- <u>Approve Application CU22-04 as presented and authorize the City Manager or Designee</u> <u>to sign the application</u> – Approving Conditional Use application CU22-04 will allow staff and consultants to move forward with the WWTP expansion.

Purpose of this RCA:

To review vacant positions and authorize the City Manager Pro Tem to appoint employees to fill the vacancies.

Background/Context:

Currently there are five positions vacant across the City. These positions include four (4) Police Officers and one (1) Collections Crew Leader. The vacancies are due to the resignations of Police Officers to pursue other opportunities (in many cases outside law enforcement) and the Collections Crew Leader accepted a development opportunity with another municipality. Existing searches are ongoing to fill these vacancies but staff and the City Attorney have concluded that there is no authority to hire these replacements under the rules of the Sweet Home City Charter.

The charter states that "the council shall appoint a manager pro tem who shall possess the powers and discharge the duties of the manager during such absence or disability only; provided, however that a manager pro tem shall have no authority to appoint or remove any city officer or employee except with the approval of five members of the council." While the City Manager is out, the City Council has appointed Blair Larsen, Community & Economic Development Director to serve as City Manager Pro Tem. As Pro Tem, Mr. Larsen has the authority of the City Manager but is unable to hire or fire based on the language above.

Staff is seeking authorization for the Manager Pro Tem to fill these positions based on recommendations from the appropriate Department Heads (Chief of Police and Public Works Director).

The Challenge/Problem:

During the interim period, how does the City replace departed employees to ensure continuity of operations?

Stakeholders:

- <u>City of Sweet Home citizens</u> The citizens and businesses in Sweet Home rely on these positions to access vital services. A fully staffed police department ensures a continued focus on public safety within Sweet Home and an employee in the Collections division of Public Works aids in the continued transport of waste from various homes and businesses.
- <u>City of Sweet Home staff</u> Maintaining adequate staffing levels ensures that essential functions can continue without interruption and limits burnout of existing employees who are facing mandatory overtime and limited capacity to complete projects, investigations, etc.
- <u>City of Sweet Home City Council</u> The City Council reviews and adopts the annual budget which outlines what full staffing is for the organization. Additionally, the Council has placed a specific emphasis on investing in staff stability and improving community safety and police services.

Issues and Financial Impacts:

Each of these positions is budgeted for the 2022 fiscal year due to end on June 30, 2022. The vacancies create salary savings of approximately \$510,000 annually. These savings do not consider any necessary overtime costs incurred by existing employees to fill the gaps. Too much overtime can lead to burnout in employees potentially reducing retentions and ensuring the cycle of vacancies continues over time (more than "standard" turnover).

Elements of a Stable Solution:

The City needs to complete the existing searches and fill these five positions as candidates are identified. This requires an authorization to fill these positions from five (5) or more City Councilors.

Options:

- 1. <u>Do Nothing</u> Council could choose not to authorize the City Manager Pro Tem to appoint candidates to budgeted vacancies.
- Move to authorize the City Manager Pro Tem to appoint up to four Police Officers and one Collections Crew Leader as recommended by respective hiring managers – This option allows the City Manager Pro Tem to appoint new employees as identified through employment searches and selections.
- <u>Authorize the City Manager Pro Tem to hire only specific budgeted positions</u> The City Council could limit the Pro Tem to hiring only specific positions until such time that additional positions are authorized by the City Council or the request is no longer necessary.
- 4. <u>Authorize the City Manager Pro Tem to appoint any and all employees necessary</u> The City Council could chose to allow the Pro Tem to appoint employees as needed determined by the Pro Tem and respective Department Heads. This authority would expire with the expiration of the appointment of the exisiting Manager Pro Tem and would need a new authorization in future Pro Tem situations.

Recommendation:

Staff recommends option 2, <u>move to authorize the City Manager Pro Tem to appoint up to four</u> <u>Police Officers and one Collections Crew Leader as recommended by respective hiring</u> <u>managers</u>. These positions are budgeted positions and will aid in meeting Council goals and ensuring our staffing keeps up with operational needs.

ORDINANCE NO. 2 FOR 2022 ORDINANCE NO.

AN ORDINANCE GRANTING A FRANCHISE BY THE CITY OF SWEET HOME TO CENTURYTEL OF OREGON, dba CENTURYLINK, ITS SUCCESSORS AND ASSIGNS, THE RIGHT TO FURNISH, SELL AND DISTRIBUTE TELECOMMUNICATIONS SERVICES TO THE CITY AND TO ALL PERSONS, BUSINESSES AND INDUSTRIES WITHIN THE CITY AND THE RIGHT TO ACQUIRE, CONSTRUCT, INSTALL, LOCATE, MAINTAIN, OPERATE AND EXTEND INTO, WITHIN AND THROUGH SAID CITY ALL FACILITIES REASONABLY NECESSARY TO FURNISH, SELL AND DISTRIBUTE A TELEPHONE PLANT, TRANSMISSION LINE OR LINES AND TO TRANSMIT COMMUNICATIONS IN AND TO THE CITY OF SWEET HOME TO ALL PERSONS, BUSINESSES AND INDUSTRIES WITHIN THE CITY AND THE RIGHT TO MAKE REASONABLE USE OF ALL STREETS AND OTHER PUBLIC PLACES AS MAY BE NECESSARY, AND FIXING THE TERMS AND CONDITIONS THEREOF.

THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:

ARTICLE I - Definitions

For the purpose of this franchise, the following words and phrases shall have the meaning given in this Article. When not inconsistent with the context, words used in the present tense include the future tense, words in the plural number include the singular number, and words in the singular number include the plural number. The word "shall" is mandatory and "may" is permissive. Words not defined in this Article shall be given their common and ordinary meaning.

1.1 "City" refers to and is the City of Sweet Home, Linn County, Oregon, and includes the territory as currently is or may in the future be included within the corporate boundaries of the City of Sweet Home.

1.2 "City Council" refers to and is the legislative body of the City of Sweet Home.

1.3 "Company" refers to and is CenturyTel of Oregon, Inc. dba CenturyLink and its successors and assigns.

1.4 "Communications Facilities" refer to and are only those facilities reasonably necessary to provide telecommunications services within the City.

1.5 "Facilities" refer to and are all facilities reasonably necessary to provide telecommunications services into, within and through the City and include plants, works, systems, lines, equipment, underground links, switches, wires and radio links.

1.6 "Public Utility Commission" refers to and is the Public Utility Commission of the State of Oregon or other authority succeeding to the regulatory powers of the Public Utility Commission of the State of Oregon.

1.7 "Revenues" refer to and are those amounts of money which the Company receives from its customers within the City for the sale of exchange access services, as authorized by ORS 221.515 and 403.105, from the Company under rates, temporary or permanent, authorized by the Public Utility Commission, adjusted for refunds, the net write-off of uncollectible accounts, corrections or other regulatory adjustments.

1.8 "Streets and Other Public Places" refer to and are streets, alleys, viaducts, bridges, roads, lanes, easements, public ways and other public places in said City.

ARTICLE II - Grant of Franchise

Section 1. <u>Grant of Franchise</u>. The City hereby grants to the Company, for the period specified and subject to the conditions, terms and provisions contained in this Ordinance, the right to furnish, sell and distribute any telecommunications or telecommunications-related services to the City and to all persons, businesses and industries within the City; a non-exclusive right to acquire, construct, install, locate, maintain, operate and extend into, within and through the City all facilities reasonably necessary to provide communication facilities to the City and to all persons, businesses and industries within the City; and a non-exclusive right to make reasonable use of all streets and other public places as may be necessary to carry out the terms of this Ordinance.

Section 2. <u>Term of Franchise</u>. The term of this franchise shall be for ten (10) years, beginning March 8, 2022 and expiring March 8, 2032.

ARTICLE III - Franchise Fee

Section 1. <u>Franchise Fee</u>. In consideration for the grant of this franchise, the Company shall collect and remit to the City a sum equal to seven percent (7%) of the Revenues.

Section 2. <u>Payment Schedule</u>. For the franchise fee owed on revenue received after the effective date of this Ordinance, payment shall be made in quarterly installments due on or before the last day of the month following the end of each calendar year quarter. Payments at the beginning and end of the term of this Ordinance shall be prorated. All payments shall be made to the City Manager. The City Council, or any committee appointed by the City Council, shall have access to the books of the Company for the purpose of auditing or checking to ensure that the franchise fee has been correctly computed and paid.

Section 3. <u>Franchise Fee Payment in Lieu of Other Fees</u>. Payment of the franchise fee by the Company is accepted by the City in lieu of any occupancy tax, license tax, permit charge, inspection fee or similar tax, assessment or excise upon the privilege of doing business or in connection with the physical operation thereof, but does not exempt the Company from any lawful taxation upon its real property, sales and use taxes or any other tax not related to the franchise or

the physical operation thereof, or assessment of fees for building permits or land use permits for structures and construction projects located outside of streets and rights of way.

ARTICLE IV - Conduct of Business

Section 1. <u>Conduct of Business</u>. The Company may establish, from time to time, such rules, regulations, terms and conditions governing the conduct of its business as shall be reasonably necessary to enable the Company to exercise its rights and perform its obligations under this franchise; provided, however, that such rules, regulations, terms and conditions shall not be in conflict with the laws of the State of Oregon or the City of Sweet Home.

Section 2. <u>Tariffs Available Online</u>. The Company shall make available online copies of all its tariffs currently in effect and on file with the Public Utility Commission. Said tariffs shall be available for inspection by the public.

Section 3. <u>Compliance with PUC Regulations</u>. The Company shall comply with all rules and regulations adopted by the Public Utility Commission.

Section 4. <u>Compliance with Company Tariffs</u>. The Company shall furnish communication facilities within the City to the City and to all persons, businesses and industries within the City at the rates and under the terms and conditions set forth in its tariffs on file with the Public Utility Commission.

Section 5. <u>Applicability of Company Tariffs</u>. The City and Company recognize that the lawful provisions of the Company's tariffs on file and in effect with the Public Utility Commission are controlling over any inconsistent provision in this franchise dealing with the same subject matter.

ARTICLE V - Construction, Installation & Operation of Company Facilities

Section 1. <u>Location of Facilities</u>. Company facilities shall not interfere with the City's water mains, sewer mains, gas mains or other municipal use of streets and other public places. Company facilities shall be located so as to cause minimum interference with public use of streets and other public places and shall be maintained in good repair and condition.

Section 2. <u>Excavation and Construction</u>. All construction, excavation, maintenance and repair work done by the Company shall be done in a timely and expeditious manner, which minimizes the inconvenience to the public and individuals. All such construction, excavation, maintenance and repair work done by the Company shall comply with all applicable codes of the City of Sweet Home, the State of Oregon and the United States of America. All public property whose use conforms to restrictions in easements disturbed by Company construction or excavation activities shall be restored as soon as practicable by the Company at its expense to as good as or better than its former condition. The Company shall comply with the City's requests for reasonable and prompt action to remedy all damage to streets or dedicated easements and City utilities contained therein where the Company is performing construction, excavation, maintenance or repair work. The City reserves the right to restore property and remedy damages caused by

Company activities at the expense of Company in the event the Company fails to perform such work within a reasonable time after Notice from the City.

Section 3. <u>Relocation of Company Facilities</u>. If at any time the City requests the Company to relocate any distribution line service connection, or other facility installed or maintained in streets or other public places in order to permit the City to change street grades, pavements, sewers, water mains or other City works, such relocation shall be made by the Company at its expense. The Company is not obligated hereunder to relocate any facilities at its expense, which were installed in private easements obtained by the Company, the underlying fee of which was, at some point subsequent to installation, transferred to the City. Following relocation, all property shall be restored to as good as or better than its former condition by the Company at its expense. The City will reasonably exhaust alternatives not requiring relocation in all cases.

Section 4. <u>Service to New Areas</u>. If during the term of this franchise the boundaries of the City are extended, the Company shall extend service to areas not served by any other telephone company in accordance with the Company's tariffs and applicable laws.

Section 5. <u>Restoration of Service</u>. In the event the Company's communications system, or any part thereof, is partially or wholly destroyed or incapacitated, the Company shall use due diligence to restore its system to satisfactory service within the shortest practicable time.

Section 6. <u>Rules and Regulations</u>. All lines and equipment constructed under this grant shall be constructed in accordance with established practices as prescribed by applicable REA specifications and drawings and the rules and regulations of the Public Utility Commission of the State of Oregon, and its duly or legally constituted successors in authority; and the rights and privileges herein granted in said streets, alleys and public highways shall be subject at all times to such ordinances and reasonable regulations as are now or shall hereafter be ordained or passed by said City concerning similar uses and excavations in the care of streets, alleys and public highways.

Section 7. <u>Safety Regulations by the City</u>. The City reserves the right to adopt, from time to time, reasonable regulations in the exercise of its police power which are necessary to ensure the health, safety and welfare of the public, provided that such regulations are not destructive of the rights granted herein and not in violation of any state or federal laws. The Company agrees to comply with all such regulations, now existing or duly adopted, in the construction, maintenance and operation of its facilities and in the provision of telecommunications services within the City.

Section 8. <u>Inspection, Audit and Quality Control</u>. The City shall have the right to inspect, at all reasonable times, any portion of the Company's system used to serve the City and its residents. The City also shall have the right to inspect and conduct an audit of Company records relevant to compliance with any terms of this Ordinance at all reasonable times, but no more than once per year. The Company agrees to cooperate with the City in conducting the inspection and/or audit and to correct any discrepancies affecting the City's interest in a prompt and efficient manner. Each party shall pay its own expenses in connection with any such audit, unless a material irregularity is found during such audit, in which case the Company shall pay the reasonable cost of such audit.

Section 9. <u>Maps</u>. The Company shall prepare and submit to the City a map showing the location of its distribution system within the City, showing location of all appurtenances incident

to the distribution system, insofar as such facilities can reasonably be determined. The map shall be revised no more frequently than annually by the addition of the information hereby required as the system is extended or revised. The City agrees that any such maps shall not be used by it or disseminated to the public for use in locating underground facilities.

Section 10. <u>Tree Trimming</u>. Subject to the provisions of this ordinance, the Company may prune trees, when necessary in public right of way, for the operation of the utility lines, wires or other appurtenances, provided such pruning shall be performed by or supervised by a certified arborist, and it shall be done without cost or expense to the City.

The Company shall provide a written notice to the City Public Works Department and property owner and resident at least ten (10) business days prior to any pruning to be done on the property. The City recognizes that a ten (10) day notice may not be possible in emergency situations; however, the City does encourage the Company to provide as much advance notice to property owners and residents as is reasonably possible under such emergency circumstances.

ARTICLE VI - Indemnification of the City

Section 1. <u>City Held Harmless/Insurance</u>. The Company shall maintain its structure, apparatus and other equipment as to afford all reasonable protection against injury or damage to persons or property therefrom, and the Company shall save the City harmless from all liability or damage and all reasonable expenses necessarily accruing against the City arising out of the exercise by the Company of the rights and privileges hereby granted, provided such liability or damage was not caused by the City.

Section 2. <u>Notice to Company</u>. The City will provide prompt notice to the Company of any claim or action against the City arising out of the exercise by the Company of its franchise rights.

Section 3. <u>Payment of Expenses</u>. The Company shall pay for all expenses relating to the publication of notice and ordinances arising out of the process for obtaining this franchise.

ARTICLE VII - Assignment; Saving Clause; Amendment

Section 1. <u>Assignment</u>. The Company shall not transfer or assign any rights under this franchise to a third party, excepting only corporate reorganizations of the Company not including a third party, unless the City shall approve such transfer or assignment in writing. Approval of the transfer or assignment shall not be unreasonably withheld.

Section 2. <u>Saving Clause</u>. If any portion of this franchise Ordinance is declared illegal or void by a court of competent jurisdiction, the remainder of the Ordinance shall survive and not be affected thereby. In such case, the parties shall proceed with due diligence to attempt to draft provisions that will achieve the original intent.

Section 3. <u>Amendment</u>. This franchise agreement may be amended by written amendment, signed by both parties.

Section 4. Replacement. Upon the effective date of this ordinance it shall replace and supersede Ordinance No 2 for 2010, Ordinance No 1216, which was the prior franchise agreement between the parties.

Trends:

Our department continues to work on traffic concerns throughout town. Below is a breakdown of the efforts, resources, and data that we have worked on and acquired.

Main Street Radar Signs

- We currently have three functional radar signs on Highway 20. The two downtown were struck and damaged by RVs. They recently have been replaced. A third sign has been malfunctioning, and we have not been able to repair it. We will need to discuss it with the vendor.
- What we've discovered: Data appear to show that these signs (westbound City Hall and eastbound Subway) have little impact on highway speeds long term 85th percentile and median speeds fluctuate around the same numbers regardless of whether they display the speeds or are in stealth mode.
- We've left the displays on since early data collection to provide awareness to drivers. We have heard, anecdotally, and seen on 12th Avenue that signs do cause drivers to slow down once they see their speed displayed.
- Downtown: While traffic moves quickly past Subway, with 85th percentile speeds around 30. Based on
 placement of the radar trailer, eastbound traffic appears to slow down starting around 10th Avenue. Based
 on direct observation, higher speeds at the Subway sign occur regardless of whether Highway 228 or
 Highway 20 traffic is stopped at the red light or able to move through on green.

Portable Radar Signs

- We have two portable signs functional now. They malfunctioned and were offline for a while. Public Works has gotten both of them working now, and one is out on 12th Avenue. Installing them can be difficult and finding a suitable pole for placement is required before they can go out at a particular location.
- During volunteer data collection sessions, we have found evidence corroborating reports of higher speeds on 12th Avenue south of Kalmia Street as well as Clark Mill Road north of Highway 20. Public Works was able to install one on 12th but unable to locate a suitable pole on Clark Mill.
- Based on volunteer data collection on Monday, we believe that this sign is impacting driving behavior. The total number of observed speeders has declined from 83 percent in October and 79 percent in November to 63 percent this week. Nearly everyone speeding Monday reduced speed to about 25 mph after triggering the sign.

Radar Trailer

- The radar trailer has stopped charging well enough to last a week, and it is now in the shop at Public Works for assessment and repair. Generally speaking, last year, the radar trailer moved around weekly to areas where we have received complaints.
- Residents report that when it is in their area, it slows traffic down.

Volunteer Data Collection

- Leo Singler, a volunteer, and CSO Morgan regularly monitor various locations. Other volunteers also have participated. They collect the data with a handheld radar unit in an unmarked vehicle. They normally collect samples during the 4 p.m. hour based on reports that speeding is most common between 4 p.m. and 6 p.m. Typically, they have found most locations have 85th percentile speeds at 6 mph or less above the posted speed and median speeds around the speed limit.
- They have located two places where 85th percentile speeds, median speeds and the total number of speeders are much higher, Clark Mill Road (35.5 mph 85th percentile, 31 mph median and 94 percent of drivers were speeding) and 12th Avenue south of Kalmia (34 mph 85th percentile, 30 mph median speed and 83 percent speeding).
- More typically, they find the 85th percentile around 30 and the median speed around 25 mph in 25-mph zones. On Nandina Street, the 95th percentile was 27 mph. The median speed was 23 mph, and 25 percent of drivers were speeding. This is among the lowest results they have seen. East Long, in the 4000 block and 4500 block had similar results. First Avenue has shown 85th percentile speeds at 30 mph and 31 mph, median speeds of 25 and 26 mph and total number of speeders at the 50 percent mark.
- All locations have a small number of outliers that we believe are the focuses of complaints. They exist
 across the city. Just Monday, they recorded 43 mph on 1st Avenue and 42 mph on 12th Avenue. They've
 seen a maximum of 41 mph on Clark Mill and 44 mph on 10th Avenue south of Elm.
- Based on the data collected so far, Public Works installed a radar sign on 12th Avenue but was unable to locate a suitable pole on Clark Mill. Most of the significant speeding was southbound, up the hill, so the sign faces southbound traffic. Two weeks after the installation on 12th (Monday), they collected data on 12th, showing a decline in total speeders and in 85th percentile and median speeds, 30 mph 85th percentile and 27 mph median. Nearly every southbound speeder cut speed once the sign started flashing. Rather than slowing down, one driver accelerated to 38 mph.

Speed and design

- It is our belief that street design is a major component of speed. In places where the road appears wide and comfortable, speeds seem to be higher. Substantial research indicates this to be the case. Heavy traffic enforcement can impact this until heavy enforcement ends. Otherwise, drivers tend to drive at the "design speed" of a road. The standard for setting speed limits is based on the 85th percentile 85 percent of drivers travel at this speed or less for this reason.
- Research suggests that design changes are required to lower driving speeds. This was the concept behind parking lanes and proposed chicanes on First Avenue in the past.
- In our experience, this seems borne out by the data. For example, Nandina appears narrow, with homes closer to the street and significant parking on one side of the street, while 12th Avenue has a more open feel and less on-street parking. Clark Mill feels like a wide, open county road with a natural speed limit of perhaps 35 mph, like the east end of Long Street, which does have a 35-mph limit.
