Reports of Committees:

Community Health Fair Committee

Bob Dalton provided an update on the event. He estimated that the attended numbers would not be as high as past years. He also reported that LOVE Inc. was on site providing clothing to those in need. The backpack program provided over 200 backpacks to students. Mr. Dalton indicated that overall there was good feedback from the vendors who felt the turnout was good and enjoyed the outdoor venue. A discussion ensued regarding the amount of Narcan that had been given out along with a number of sharps containers. This led to talk regarding the need for additional disposal sites for needles.

Jim Gourley estimated there were 400 in attendance.

Western University

Dr. Larry Horton provided an update on the progress. Dr. Horton explained that the community health focus groups which consist of between 35 - 40 individuals are ready to go, they are now just waiting on Western University. He felt there should be a lot of movement next month.

Homeless Action Committee

Brock Byers provided an update on the site. They continue to focus on street outreach, housing, and services. Mr. Byers also explained that FAC is also focusing on Harm Reduction in Linn County and they are the recipients of all the Linn County Harm Reduction supplies.

Mr. Byers also praised the Public Works Department for the work that they have put into the site. He reported that the High School students have been doing an amazing job building the micro shelters.

Mr. Byers stated they have been having supply issues, but they hope to be open in October.
