2024-04-16 Ad Hoc Committee on Arts & Culture Meeting Minutes

Councilor Gourley moved to approve the minutes of the April 16, 2024 Ad Hoc Committee on Arts & Culture. Committee Member Gerson seconded the motion. The motion carried unanimously by those present.

Old Business

Murals Update

Assistant City Manager Pro Tem Pretty provided an update on grants received to support mural painting, potential selected locations, and the current status of selected mural artists.

Gourley asked of the eligibility of Commercial Exterior Improvement Program (CEIP) grants for murals. Assistant City Manager Pro Tem Pretty stated that there were limited funds available and structural improvements would likely be prioritized over artistic grants.

Committee Member Mull entered at this time.

Committee Member Gerson asked of the installation of a mural that had not been reviewed by the committee and if there was a process to have them approved. Assistant City Manager Pro Tem Pretty replied that the City of Sweet Home did not have exterior design standards that prohibited business from installing murals of their choice.

Discussion was held regarding gathering volunteers to provide maintenance for existing murals.

No action was required for this item.

Bronze Statues

Chair Peda stated that the Community Foundation may be interested in assisting with a bronze statue later in the fiscal year. Discussion ensued regarding incorporation of a water feature.

High School Metal Artwork

Chair Peda asked if there were still plans to ask the high school to do metal salmon cutouts for the medians on Main Street. Special Projects Manager Leisinger stated that the School District was supposed to contact him once the school year began.

Historic Buildings

Discussion was held regarding what the committee considered historic. There was consensus to focus on buildings of 75 years and older.

Discussion was held regarding the installation of maps marking historic places in Sweet Home.

New Business

Crosswalks

Discussion was held on the potential installation of artistic crosswalks. Staff will follow up with cost and feasibility info.

East Linn Museum

Mayor Coleman stated that the East Linn Museum was in need of additional volunteers to maintain operations. She asked the committee to reach out to the community to solicit volunteers.
