### **Community Health Fair Committee**

Bob Dalton reported the Health Fair Application has been revised.

Western University

a) Western University Student Presentation

Students Paulie, Jordan, Mira, and Michelle presented the Committee with a report on data from their research study. The 2017 study showed unmet health needs which resulted in the MIKE program. It also identified the need for an urgent care and promotion of healthy resources that are available.

The current study showed the same results and similar needs. Next steps and action items include an Education Forum, Advertise Resources, Volunteer, continue Project Mike, Health and Fitness Clubs and Team Sports.

Di Lacy, Western University Director of Student Services, reported the MIKE program for Sweet Home received national recognition with a 2022 Public Health Service Award. Di Lacy stated Sweet Home is more engaged and welcoming than other communities and she applauded our efforts.
