Recognition of Visitors and Hearing of Petitions:

Lori Martin, 37675 Sunset Lane, Brownsville, spoke regarding the upcoming State Mask Mandate stating the community is opposed to the mandate and asked what Sweet Home can do. The Mayor replied the Council is working on a Resolution regarding their position on the mandate. Mayor Mahler clarified the City Council has no authority over the School District. The Mayor stated that anyone is available to come and address the Council. City Manager Towry stated that the mandates are legal and lawful, however the City does not enforce any mask mandate. Ms. Martin asked for a public meeting or town hall to share ideas. Councilor Trask reported Representative Jamie Cate and Senator Girod have said the Governor has the right to mandate masks at schools. They wrote a letter to Governor Brown asking that masks in schools be optional. Mayor Mahler stated behind the scenes actions are happening and emotions cannot dictate our decisions. City Manager Towry added the Wastewater Treatment Plant upgrade is the bigger picture. Councilor Sanchez encouraged the community to put pressure where it is needed at the state level.

Nancy White, 911 6th Avenue, was concerned about a code enforcement issue regarding a neighbor who has open storage of trash, disabled vehicles, and a large dumpster full or garbage. CEDD Larsen stated it is certainly an issue and the property owner is a repeat offender who gains compliance after notification, but then falls into relapse. Staff must follow process and order to avoid dismissal. He added Code Enforcement work is not quick.

Vince Adams, 809 Mountain View Road, agreed with a town meeting regarding any mask mandate. He was opposed to any homeless camp in Sweet Home. Mahler Mahler stated the Council and staff are trying to address the homelessness problem.

Raquel Buyers, Corvallis, asked what is happening regarding the mask mandate. Mayor Mahler explained the previous discussion regarding a town hall meeting and resolution that will explain the Council's stance. He stated it will be a public meeting and everyone will be welcome to come. He encouraged community voices be heard at the State Capitol.

Old Business:

a) Police Department Traffic Data Review

Chief Lynn presented a Traffic Data Report with findings regarding traffic concerns in the downtown area. Chief Lynn reported that speed and volume of traffic will not be fixed with only enforcement. Chief Lynn presented the data collected in June from the radar signs that showed a high volume of traffic and a high percentage of traffic going at least 5 miles over the posted limit. The data also showed there was a significant decrease in speeding traffic where the road narrows. Staff has engaged with ODOT to find more ways of "traffic calming" efforts. The Police Department will use targeted education to gain more compliance, focusing on the downtown area first, then work further east. Chief Lynn will continue tracking and presenting data and keechanging.

b) Request for Council Action - Premium Pay for Employees Working During COVID-19

City Manager Towry introduced the request to consider premium pay for staff who worked during COVID as a part of the American Rescue Plan Act relief funds.

Finance Director Neish presented the total cost from ARPA funds noting six employees do not qualify for ARPA, if Council wanted to include those six employees, those funds would come from appropriate funds.

Councilor Gourley stated City staff has gone above and beyond thru COVID and recent fire season. Motion to approve premium pay for all employees. Motion made by Councilor Gourley, Seconded by President Pro Tem Gerson.

Engineer Technician Rice introduced the request for approval of contract to Knife River for the 2021 Overlay Project. The bid process was outlined and all bid totals presented to Council.

Councilor Sanchez declared a potential Conflict of Interest and abstained from voting.

Community and Economic Development Director Blair Larsen introduced the 24th Avenue Land Exchange Agreement explaining the need for improved access off 24th to accommodate development of the Quarry property for events like the Oregon Jamboree. To better develop 24th Avenue, the City has proposed a land exchange for property along 24th owned by Reliable Welding for City owned property along their the north property line. The exchange has met all requirements of Oregon law and processes.

Motion to Approve and Authorize the City Manager to Sign the Agreements and Subsequent Planning Applications. Motion made by Councilor Trask, Seconded by Councilor Richards. c) Request for Council Action - Water Meter Modernization Authorization

Finance Director Neish presented the requests to upgrade water meters. He explained the benefits of the smart meters including a customer service benefit as the smart meters will help determine and alert staff of potential leaks early. The average lifespan of the smart meters are double the current meters. Finance Director Neish explained the cost of the change over that would include the meters and software. Funding options were discussed. Council asked how rates would be affected.

Motion made by President Pro Tem Gerson, Seconded by Councilor Gourley to approve staff purchase new meters to complete the change-out project and bring an interfund loan forth at the next meeting – The City could complete this project internally, using funds provided from either the General Fund, Wastewater fund or other funding source to be repaid at the beginning of the 2023 fiscal year (July 2022). Any additional costs for interest would be determined by the Council in the interfund loan resolution to be presented during the August 24<u>th</u> City Council meeting.

City staff met with Senator Merkley's staff, DEQ, Business Oregon, and USDA, to discuss barriers that rural cities navigate to access federal funds. City staff learned there are a few other programs we may be able to access.

A seven member group made of staff, committee and community members are traveling to Walla Walla, WA to study homeless solutions. They hope to learn key points to bring back and implement to comply with Federal and State mandates.

Senator Girod and Representative Cate held a special meeting with the district Fire Chiefs, and City Managers. They plan on continuing to meet on a quarterly basis.

Saturday Senator Girod and Representative Cate held a town hall at Sankey Park. There was good conversation between them and community members.

City Manager Towry reported Governor Brown announced she will be implementing COVID precautions, including wearing masks indoors in public spaces. Staff will set a town hall meeting as requested to discuss what the City can and cannot do. City Manager Towry stated it is important to remember Sweet Home first. Sweet Home has a history of stepping up

helping during tough times. City Manager Towry asked that we remember we may not like what's going on, but we need to put Sweet Home first.

Purpose of this RCA:

For Council consideration, a resolution and accompanying proclamation of a state of emergency concerning the effects of the COVID-19 Emergency Response

Background/Context:

At the August 10, 2021, City Council meeting, Mayor Mahler requested a Resolution be brought before the City Council regarding the effects of COVID-19 precautions enacted by Governor Kate Brown. Attached is a draft of a document for your consideration.

On March 8, 2020, Governor Kate Brown enacted Executive Order 20-03 declaring a state of emergency throughout Oregon due to the COVID-19 virus and pending pandemic. In that time, and under the authority of ORS 401.165 to 401.670, ORS 433.443, and ORS 431A.015, Governor Brown declared a public health emergency under ORS 653.616.

Since that time additional Executive Orders have been enacted for the purpose of protecting and mitigating the spread of COVID-19.

Some of the mandates have been sweeping in nature including the closing of schools, businesses, and churches.

There have been unintended consequences of these measures encompassing increases in certain crimes and mental health issues including depression. It is commonly discussed that children may be suffering the most from the Executive Orders implemented to combat the spread of COVID-19.

The City of Sweet Home has seen an increase in mental health calls of 131% between 2019 to 2021. They currently are on track for an increase of 288% in 2021 over pre-pandemic numbers. Likewise, Sweet Home Police have recorded a 24% increase in domestic violence calls in 2020.

The Challenge/Problem:

Should the City of Sweet Home declare a state of emergency concerning effects of the COVID-19 emergency response?

Stakeholders:

- <u>Businesses of Sweet Home</u> Businesses have been hard hit by the Executive Orders; some have closed for extended periods of time. Additional relief would be appreciated. Some businesses were hit harder than others and mandated to be closed longer than others. While many received financial aid, for some it was not enough to replace their lost revenue or requires interest be paid.
- <u>Adults of Sweet Home</u> Many have been laid off, resulting in record unemployment numbers because of the business closures. Adults have experienced a rise in mental health issues and domestic violence in our community amongst other challenges related to homeschooling as a result of school closures.
- <u>Children of Sweet Home</u> The closure of schools has impacted their education and their mental well-being. Children have been unable to socialize at school or during school sponsored events. Likewise, other activities such as club sports and scout programs were cancelled limiting their social growth opportunities.

Issues and Financial Impacts:

\$7,000,000.00 is in the current state budget as a General Fund expense earmarked for our Wastewater Treatment Plant upgrade project. While the budget is set and the opportunity for a line-item veto has passed, under the current state of emergency the Governor has unregulated authority. We have reached out to get a definitive answer as to if the Governor could instruct staff not to distribute the funds to us – essentially implement a selective spending freeze. Further, Article X-A of the Oregon Constitution allows her to utilize all General Fund allocations for a public health emergency. Loss of those funds would result in each water account holder (some have multiple accounts, i.e., a constituent may have both a residential and business account) would be responsible for +/-\$2500 plus interest to cover the gap.

Elements of a Stable Solution:

A decision regarding a state of emergency concerning effects of the COVID-19 emergency response.

Options:

- 1. <u>Do nothing</u> Council could choose to do nothing.
- <u>Adopt Resolution No. 22 for 2021, A resolution proclaiming a "state of emergency"</u> <u>concerning effects of the COVID-19 emergency response as presented</u>. – Staff would then fulfill the requirements as indicated in statute.
- 3. <u>Suggest edits to the draft resolution</u>. Council could discuss edits in the open session.
- 4. Remand the document to the Admin, Finance and Property Committee.

Recommendation:

Staff has no recommendation, but respectfully reminds City Council that they are elected to make decisions that do the most good, for the most people, for the longest of period of time.

RESOLUTION NO. 22 FOR 2021

A RESOLUTION PROCLAIMING A "STATE OF EMERGENCY" CONCERNING EFFECTS OF THE COVID-19 EMERGENCY RESPONSE.

WHEREAS, the City of Sweet Home has the authority granted under ORS Chapter 401 and the Sweet Home Municipal Code Chapter 2.52.030, that provides direction to the City, its officials, and others in the event of an emergency that exists within the City; and,

WHEREAS, the City Manager, acting as the Emergency Program Manager, under Sweet Home Municipal Code Chapter 2.52 hereby requests the Sweet Home City Council to proclaim the existence of a "state of emergency" for the City of Sweet Home concerning COVID-19 mandates; and,

WHEREAS, a Proclamation declaring a "state of emergency" for the City of Sweet Home has been prepared and attached hereto;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SWEET HOME:

That the City Council hereby declares and proclaims that the City of Sweet Home is in a "state of emergency" and directs the Mayor of Sweet Home to execute said Proclamation.

That the Proclamation attached hereto is incorporated herein and made a part of this resolution.

IT IS FURTHER DECLARED, that emergency procurement of goods and services are authorized pursuant to ORS 279B.080, and all other applicable laws and rules.

This resolution shall become effective immediately upon passage by the City Council and signature of the Mayor.

PASSED by the Council and approved by the Mayor this 25th day of August 2021.

PROCLAMATION Declaring a State of Emergency for the City of Sweet Home

WHEREAS, the Constitution of the United States and the Oregon State Constitution are the cornerstones of governance for the freedom and rights of our citizens and the grounds for legislative actions; and,

WHEREAS, the City of Sweet Home has the authority granted under ORS Chapter 401 and the Sweet Home Municipal Code Chapter 2.52.030, that provides direction to the City, its officials, and others in the event of an emergency that exists within the City; and

WHEREAS, the Sweet Home Municipal Code Chapter 2.52 designates the City Manager as the City of Sweet Home Emergency Program Manager; and

WHEREAS, Sweet Home Municipal Code Section 2.52.040 (A) empowers the Emergency Program Manager to request the Sweet Home City Council to proclaim the existence of a "state of emergency" for the City of Sweet Home; and

WHEREAS, existing conditions related to the COVID-19 Emergency Orders warrant the proclamation of emergency, as defined by Sweet Home Municipal Code Section 2.52.020; and

WHEREAS, the novel coronavirus (COVID-19) is a respiratory disease that may result in serious illness or death and is easily transmissible from person to person; and

WHEREAS, on March 8, 2020, Governor Kate Brown declared a state of emergency exists in all counties in the State of Oregon due to the number of confirmed cases of COVID-19 in the State and implemented Emergency Orders in response to combat the pandemic; and

WHEREAS, we as a municipality have no legal ability to summarily defy the Governor's Emergency Executive Orders, mandates, guidelines and enforcement by State agencies, and therefore cannot protect any local business from State-directed targeting, repercussions and penalties if such local business personally chooses to; and,

WHEREAS, social distancing and prolonged isolation are proven to create a number of mental health issues such as anxiety and depression, sometimes pushing individuals toward suicide; and,

WHEREAS, social distancing and prolonged isolation, combined with unemployment and other stressors, increased cases of domestic abuse calls to the Sweet Home Police Department by 24% in 2020; and,

WHEREAS, the Sweet Home Police Department recorded a 131% increase in mental health calls in 2020 over 2019, is on track to record a 288% increase in 2021 over 2019; and,

WHEREAS, the City requires additional assistance, and a formal declaration of emergency allows additional resources to flow to the City in a timely fashion; and,

WHEREAS, we believe in the kindness, compassion, and common sense of our citizens and

businesses to help protect the most fragile and susceptible in our community; and,

WHEREAS, the State of Oregon owes a duty to its constituents to address the mental health crisis caused by the COVID-19 pandemic mandates with increased funding and resources for mental health care throughout the state of Oregon, especially for rural Oregonians; and,

WHEREAS, the State of Oregon owes a duty to its constituents to address the rise in criminal activity correlating with the COVID-19 pandemic mandates through increased funding and resources directly to local jurisdictions to help recruit, hire, and train a more qualified police force, especially for rural Oregon communities; and,

WHEREAS, the State of Oregon should look to the future and fully fund an initiative for DPSST to train our future police officers to better equip them to deal with mental health issues.

WHEREAS, fear is a tool of untruth, manipulation, and control; and,

WHEREAS, the City Council request the emergency Executive Orders implemented by the Governor lasting more than thirty (30) days require the approval of the Oregon House and Senate before implementation; and finally,

WHEREAS, Sweet Home City Council met and passed by resolution this Proclamation declaring a "state of emergency" for the City of Sweet Home.

NOW, THEREFORE, I, Greg Mahler, Mayor of the City of Sweet Home, do hereby proclaim with City Council authorization, a "state of emergency" in the City of Sweet Home; and that during the existence of said emergency, the powers, functions, and duties of the Sweet Home Emergency Program Manager and the emergency organization of this city shall be those prescribed by state law and by ordinances and resolutions of this City. Said "state of emergency" shall exist for a period of time during which conditions resulting from the COVID-19 Executive Orders exist which have given rise to the Proclamation. The local emergency shall continue until terminated by the Mayor of the City of Sweet Home, State of Oregon.

Purpose of this RCA:

The Sweet Home Planning Commission held a public hearing on July 15, 2021. At the hearing the Planning Commission reviewed application ZMA21-02 where they received testimony and recommended that the application move on to the City Council for approval.

On July 27, 2021 the City Council held a Public Hearing and completed the 1st Reading of Zone Map Amendment Application ZMA21-02. On August 10, 2021 the City Council completed the 2nd reading of Zone Map Amendment Application ZMA21-02. On August 24, 2021 the City Council will complete the 3rd and final reading of Zone Map Amendment Application ZMA21-02.

Background/Context:

The applicant is proposing to change the Zoning Map in an area consisting of approximately 29,335 square feet (.67 acres) located 1411 18th Avenue and 1355 19th Avenue, Sweet Home, OR 97386 (13S01E32DB Tax Lots 3701, 400 and 1100). The Sweet Home Zoning Map is proposed to change from the Commercial Highway (C-2) and Industrial (M) Zones to Light Industrial Zone. The proposed zone change would bring the zoning designation into conformity with the property's existing Comprehensive Plan Map designation. The Planning Commission will hold a public hearing and make a recommendation to the City Council. The City Council will hold a public hearing and decide on this application.

The Sweet Home Planning Commission held a public hearing on July 27, 2021. At the hearing the Planning Commission reviewed application ZMA21-02. The Planning Commission received testimony and deliberated on this matter at their July 27, 2021 meeting and passed a motion to recommend approval of the application to City Council. That motion of approval specified a 12-

day appeal period from the date the decision motion is mailed. No specific conditions of approval were required.

Application ZMA21-02 is being filed simultaneously with Applications PLA21-13, PLA21-14, and PLA21-15. Applications PLA21-13, PLA21-14 and PLA21-15 were approved with conditions by the Community and Economic Development Director on July 6, 2021.

The Challenge/Problem:

Should the zoning map be changed to allow industrial activity on the property in question, rather than the current Commercial Highway (C-2) and Industrial (M) designation?

Should the Comprehensive Plan designations be followed if the proposed amendment is consistent with the goals and policies of the comprehensive plan? The Comprehensive Plan States that the Planning Commission will recommend, and the City Council shall determine the location of boundaries by examining the goals and policies contained within the Plan. [Chapter 2, Page 12 of the Comprehensive Plan].

Stakeholders:

- <u>The Owner/Developer</u> would be able to develop the property as they have proposed.
- <u>The residents and businesses in the surrounding area would benefit from the future site</u> improvement of the property.
- <u>The City of Sweet Home</u> would benefit from the future site improvement of the property that could come from the changed zoning

Issues and Financial Impacts:

There are no issues or financial impacts currently identified.

Elements of a Stable Solution:

A stable solution is one in which a decision on the application is made that conforms with City Code and State Law.

The Sweet Home Comprehensive Plan guides official policy decisions about development within the area. The Plan aims to organize and coordinate complex interrelationships between people, land, resources, and facilities to meet the future needs of the citizens and to protect the livability of the community. The Plan also reflects the public's goals and aspirations for Sweet Home about the best way to handle development and conservation in the City. The officially acknowledged Comprehensive Plan gives policy direction for land use decisions and coordinates private and public development. [Chapter 1, Page 1 of the Comprehensive Plan].

Comprehensive Plan Map Policy 1: The Comprehensive Plan Map graphically portrays Sweet Home's land use pattern as recommended by Comprehensive Plan policy. Each designation has a different symbol or color. The land use map portrays the long-range vision of land use patterns in Sweet Home. [Chapter 2, Page 12 of the Comprehensive Plan].

SHMC 17.12.025 Review Criteria for Map Amendments. An amendment to the official zoning or comprehensive plan map may be authorized provided that the proposal satisfied all relevant requirements of this title and also provided that the applicant demonstrates the following:

- A. The proposed amendment is consistent with the goals and policies of the comprehensive plan;
- B. The proposed amendment is orderly and timely, considering the pattern of development in the area, surrounding land uses, and any changes which may have occurred in the neighborhood or community to warrant the proposed amendment;
- C. Utilities and services can be efficiently provided to serve the proposed uses or other potential uses in the proposed zoning district; and

D. The proposed amendment to the comprehensive plan map is consistent with Oregon's statewide planning goals

Options:

- 1. <u>Deny Application Staff</u> would prepare an Order of Denial for Application ZMA21-02.
- 2. <u>Approve Application ZMA21-02</u> and Ordinance Bill No. 6 for 2021, Ordinance No. 1298 as presented.
- 3. <u>Recommend different zone amendment</u>. Council could review these proposed changes and recommend different zone amendments. Staff would take these recommendations and revise the proposed application for review at a future Planning Commission and Council meeting.

Recommendation: Staff Recommends Option 2: <u>Approve Application</u> ZMA21-02_and Ordinance Bill No. 6 for 2021, Ordinance No. 1298 as presented.

ORDINANCE BILL NO. 6 FOR 2021

ORDINANCE NO. 1298

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP

WHEREAS, the applicant, Sweet Home Sanitation Service, Inc., submitted Zone Change Application ZMA21-02 and requested a zone map change for an area consisting of approximately 29,335 square feet (.67 acres) located 1411 18th Avenue and 1355 19th Avenue, Sweet Home, OR 97386 (13S01E32DB Tax Lots 3701, 400 and 1100). The Sweet Home Zoning Map is proposed to change from the Commercial Highway (C-2) and Industrial (M) Zones to Light Industrial Zone. The proposed zone change would bring the zoning designation into conformity with the property's existing Comprehensive Plan Map designation. The subject property is identified on the Linn County Assessor's Map as 13S01E32DB Tax Lots 3701, 400, 1100; and

WHEREAS, the Planning Commission of the City of Sweet Home held a public hearing on July 15, 2021 with due notice of such public hearing having been given and provided an opportunity for public comments and testimony. The Planning Commission deliberated at their July 15, 2021 meeting, and recommended that the City Council approve this application: and

WHEREAS, the City Council held a public hearing on this matter on July 27, 2021, with due notice of such public hearing, to provide opportunity for public comment and testimony. The City Council approved this application by motion at their July 27, 2021 meeting; and

WHEREAS, the proposed Light Industrial zoning is needed to facilitate development of the subject property;

Now, Therefore,

THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:

Section 1: The City of Sweet Home adopts the findings of fact in support of zone change application ZMA21-02 included as Exhibit A.

Section 2: The City of Sweet Home amends the Official Zoning Map, identified in SHMC 17.20.020 as the City Zoning Map including all subsequent amendments, for the an area consisting of approximately .67 acres located at 1411 18th Avenue and 1355 19th Avenue, Sweet Home, OR 97386.; and identified on the Linn County Assessor's Map as 13S01E28DC Tax Lots 3701, 400, and 1100. The Official Zoning Map shall be amended from the Commercial Highway (C-2) and Industrial (M) Zones to the Light Industrial Zone for the subject property as shown on Exhibit B.

Findings of Fact in Support of Zone Change Application ZMA21-02

Exhibit A to Order of Approval for ZMA21-02

The review and decision criteria for a zone change are listed below in bold. Staff findings and analysis are provided under each review and decision criterion.

- A. An amendment to the official zoning or comprehensive plan map may be authorized provided that the proposal satisfied all relevant requirements of this title and also provided that the applicant demonstrates the following: [SHMC 17.12.010]
- 1. The proposed amendment is consistent with the goals and policies of the comprehensive plan; [SHMC 17.12.025(A)]
 - a. The Zoning Code implements the Comprehensive Plan by providing specific development guidelines for each Land Use Designation. The general nature of each Comprehensive Plan Land Use Designation will guide the uses and standards for the corresponding zone in the Zoning Code. [Sweet Home Comprehensive Plan, Chapter 2 Text]
 - b. The Comprehensive Plan Map graphically portrays Sweet Home's land use pattern as recommended by Comprehensive Plan policy. Each designation has a different symbol or color. The land use map portrays the long-range vision of land use patterns in Sweet Home. [Sweet Home Comprehensive Plan, Chapter 2, Comprehensive Plan Map Policies, Policy 1]
 - c. Zoning Codes. The Zoning Codes regulate the use of land on a comprehensive basis. More specifically, the Zoning Codes divide the community into residential, commercial, industrial, and other use zones based on the Comprehensive Plan. Each zone has standards and regulations that determine the allowed uses on that land and the standards to which structures must conform, such as building height, yard setbacks, and lot size. The Codes consists of text, found in Title 17 of the Sweet Home Municipal Codes, and an official Zoning Map.

The Zoning Codes fulfill two major roles. First, zoning promotes the public health, safety, and welfare of Sweet Home. Secondly, the Zoning Codes implement the Comprehensive Plan. Oregon Revised Statute 197.175 states that cities will:

- Prepare, adopt, amend, and revise comprehensive plans in compliance with Statewide Planning Goals; and
- Enact land use regulations to implement their comprehensive plan.

In a broad sense, zoning encourages the orderly development of the community and implements the Comprehensive Plan. Zoning can only partially relate to the long-term aspects of the plan because as a regulatory tool, it must relate to the current conditions within the City of Sweet Home.

The Comprehensive Plan provides a general and long-range policy for the City while the Zoning Codes serve as a legal ordinance with binding provisions on

land development. The various zones have specific boundaries and when drafting the Zoning Ordinance, the City considers how each land parcel will be affected.

Zoning Code provisions and the Zoning Map can be amended. Amendments shall be consistent with the Comprehensive Plan. If proposed amendments to the Zoning Codes do not comply with the Comprehensive Plan, the Comprehensive Plan must also be amended so that the two documents correspond. [Sweet Home Comprehensive Plan, Chapter 2, Comprehensive Plan Map Policies, Chapter 8: Plan Management]

- d. Updating the plan: Making the Comprehensive Plan a basic part of the community's planning process an ongoing active function of City government will keep the Plan as a viable and useable policy document. The Comprehensive Plan needs to be updated occasionally for the following reasons: [Sweet Home Comprehensive Plan, Chapter 8: Plan Management]
 - i. To accurately reflect changes in the community.
 - ii. To ensure integration with other policies, Zoning Codes, and Subdivision Codes.
- e. Changes to the Plan Shall be made by ordinance after public hearings. [Sweet Home Comprehensive Plan, Chapter 2, Plan Amendment Policies, Policy 2]
- f. Changes in the Plan shall be incorporated directly into the document at the appropriate place. A list of all amendments with date of passage should be a part of the document. [Sweet Home Comprehensive Plan, Chapter 2, Plan Amendment Policies, Policy 3]
- g. Property Owners, their authorized agents, or the City Council may initiate a Comprehensive Plan amendment. In order to obtain a Comprehensive Plan amendment, the applicants have the burden of proof that all of the following conditions exist. [Sweet Home Comprehensive Plan, Chapter 2, Plan Amendment Policies, Policy 5]
 - i. There is a need for the proposed change;
 - ii. The identified need can best be served by granting the change requested;
- iii. The proposed change complies with the Statewide Planning Goals; and,
- iv. The proposed change complies with all other elements of the City's Comprehensive Plan.
- h. Highway Commercial: To provide suitable and desirable commercial areas along the highway intended to meet the business needs of the community. [Sweet Home Comprehensive Plan Land Designations for Economic Development, Table 11]
- i. High Density Residential: To provide areas suitable and desirable for higher density residential development, and particularly for apartments, manufactured home parks, other residential uses, and appropriate community facilities. [Sweet Home Comprehensive Plan Map Residential Land Designations, Table 7]

<u>Staff Findings:</u> The applicant is proposing to change the Zoning Map of an approximately 29,335 square feet (.67 acres) located 1411 18th Avenue and 1355 19th Avenue, Sweet Home, OR 97386 (13S01E32DB Tax Lots 3701, 400 and 1100). The Sweet Home Zoning Map is proposed to change from the Commercial Highway (C-2) Zone and Industrial (M) Zone to Light Industrial Zone.

Based on the Linn County 2018 aerial photograph, the area is surrounded by Highway Commercial and Industrial lots. There is no development planned with the Zone Map Amendment application.

Based on the findings above the proposed zoning plan designation would be consistent with the Sweet Home Comprehensive Plan.

The application complies with this criterion.

2. The proposed amendment is orderly and timely, considering the pattern of development in the area, surrounding land uses, and any changes which may have occurred in the neighborhood or community to warrant the proposed amendment; [SHMC 17.12.025(B)]

<u>Staff Findings</u>: Staff finds that the proposed zoning map amendment would be orderly and timely, be consistent with the pattern of development in the area, and based on the 2018 Linn County aerial photograph, staff finds that the subject property is surrounded by Highway Commercial and Industrial lots.

The application complies with this criterion.

3. Utilities and services can be efficiently provided to serve the proposed uses or other potential uses in the proposed zoning district; and [SHMC 17.12.025(C)]

<u>Staff Findings:</u> Water and sanitary sewer services are available in 18th Avenue and 19th Avenue. The subject property has frontage along 18th Avenue and 19th Avenue. The applicant has not proposed development with this Zone Map Amendment application

The application complies with this criterion.

4. The proposed amendment to the comprehensive plan map is consistent with Oregon's statewide planning goals. [SHMC 17.12.025(D)]

Staff Findings: The applicant is not proposing an amendment to the comprehensive plan map.

- 5. OAR 660-012-0060(1). If an amendment to a functional plan, an acknowledged comprehensive plan, or a land use regulation (including a zoning map) would significantly affect an existing or planned transportation facility, then the local government must put in place measures as provided in section (2) of this rule, unless the amendment is allowed under section (3), (9) or (10) of this rule. A plan or land use regulation amendment significantly affects a transportation facility if it would:
 - a. Change the functional classification of an existing or planned transportation facility (exclusive of correction of map errors in an adopted plan);
 - b. Change standards implementing a functional classification system; or
 - c. Result in any of the effects listed in paragraphs (a) through (c) of this subsection based on projected conditions measured at the end of the planning period identified in the adopted TSP. As part of evaluating projected conditions, the amount of traffic projected to be generated within the area of the amendment

may be reduced if the amendment includes an enforceable, ongoing requirement that would demonstrably limit traffic generation, including, but not limited to, transportation demand management. This reduction may diminish or completely eliminate the significant effect of the amendment.


- i. Types or levels of travel or access that are inconsistent with the functional classification of an existing or planned transportation facility;
- ii. Degrade the performance of an existing or planned transportation facility such that it would not meet the performance standards identified in the TSP or comprehensive plan; or
- iii. Degrade the performance of an existing or planned transportation facility that is otherwise projected to not meet the performance standards identified in the TSP or comprehensive plan. [OAR 660-012-0060(1)]

<u>Staff Findings:</u> The subject property has existing frontage along Highway 20. The applicant has proposed a change in zoning from the Commercial Highway (C-2) Zone and Industrial (M) Zone to Light Industrial Zone. The proposed use would be consistent with the Comprehensive Plan Map designation. Based on these findings, staff concludes that the proposed zone change would not significantly affect the existing transportation infrastructure in the neighborhood and is consistent with the Sweet Home Transportation System Plan.

The application complies with this criterion.

Our department continues its recruiting efforts to fill the open police officer vacancies. We currently have four open positions. We have held several testing sessions for applicants and have several background packets out to individuals. Recruiting for law enforcement positions is becoming more difficult, not just for Sweet Home, but for the entire profession nationwide. We are in the process of refining our recruitment process in the hopes of attracting a variety of qualified applicants.

We continue to monitor trends in several types of calls for service to determine what effects the ongoing COVID-19 pandemic situation has on them. The calls that we are monitoring include thefts, domestic violence calls, child abuse calls (physical and sexual), suicide calls, mental health calls and burglaries. Below is a comparison of those types of calls between July of 2021 and July of 2020.

As mentioned over previous reports, the calls associated with mental health continue to be a focus. Through the CSO's efforts, the cooperation that we have with Linn County Mental Health has been excellent. They have been highly responsive when we have called. With that said, they do continue to have limited resources and have seldom been able to respond to an individual in crisis. But they have been doing work on the backend of person who has experienced a mental health crisis through their outreach. The CSO and I do meet with Linn County Mental Health on a monthly basis to review specific cases and to keep the lines of communication and cooperation open.
