DEPARTMENTAL UPDATES

David Casian, Building Inspector addressed the council informing them of the new inititive to remove abandoned vehicles from the city. In conjunction with TPD, they will begin placing notices on vehicles, notifying the owners that the vehicle is in danger of being towed at their expense. The building inspector will mark vehicles on private property and TPD will identify vehicles on public property. He also addressed the issue of business owners not properly Skirting. Skirting requires them to properly conceal non-used vehicles on private property.

Todd McGill of TED addressed the council with updates for the department. They've been assisting PW with cutting trees and maintaining power poles.

Scott Evans of P & R informed the council of the upcoming events at the center and that the approved basketball goals where installed at Brummitt Heights earlier today. Also that he and Deputy Mayor Lisa Baker met with the Lakeshore Foundation on a plan to offer virtual fitness classes to the elderly and anyone with mobility issues. More information to come on this program.

Chief Major informed the council that the vehicles purchased as a result of the Special Meeting on October 22, 2021 are now in the possession of TPD and that there was a 5th vehicle procured. He thanked the council for hearing and approving the acquisition on short notice.

Lisa Baker, Deputy Mayor addressed the council informing and instructing them on completing the required survey for the League of Municipalities Economic Development Academy.

Charlie Williams of PW then addressed the council providing updates on his department. He asked William Dumas of 2095 Eastlake Blvd and Rev. and Mrs. Matthews to inform the council of the flooding issues on their properties as a result of issues stemming from city property. They are seeking remedies and repairs to be made by the city. Charlie also informed the council that PW is planning to place No Parking signs on both sides of Eastlake Blvd, near City Hall and replacing signs on the 1400 block of Thomason Ave.

CITY COUNCIL OF THE CITY OF TARRANT, ALABAMA ORDINANCE NO. 1140

AN ORDINANCE OF THE CITY OF TARRANT, ALABAMA, AMENDING CHAPTER 4, ARTICLE I, SECTION 4-4 OF THE CITY CODE, ADOPTING CODES SETFORTH BY THE INTERNATIONAL CODE COUNCIL RELATING TO INSPECTION ACTIVITES AND ENFORCEMENT OF BUILDING PROVISIONS FOR THE CITY OF TARRANT.

Whereas, it is the desire of the City Council of the City of Tarrant to adopt, in all respects, the various International Code Council (ICC) codes relating to building, residential, electrical, gas, mechanical, and plumbing; and

Whereas, the adoption of these Codes is done to facilitate proper inspections activities by the City of Tarrant relating to construction of buildings within the corporate limits of said city and relating to public safety, health and general welfare;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Tarrant on November 15, 2021, at 7 p.m.:

<u>Section 1.</u> Section 4-4 of the City Code is hereby amended to read as follows:

Sec. 4-4. Technical codes – Adopted by reference.

Codes are for the 2021 Edition:

- (1) 2021 ICC International Building Code (IBC)
- (2) 2021 ICC International Residential Code (IRC)
- (3) 2021 ICC International Mechanical Code (IMC)
- (4) 2021 ICC International Plumbing Code (IPC)
- (5) 2021 ICC International Fuel Gas Code (IFGG)
- (6) 2021 ICC International Energy Conservation Code (IECC)
- (7) 2021 ICC International Existing Building Code (IEBC)
- (8) 2021 ICC International Wildland Urban Interface Code (IWUIC)
- (9) 2021 ICC International Performance Code for Buildings and Facilities (ICCPC)
- (10) 2021 ICC International Property Maintenance Code (IPMC)
- (11) 2021 ICC International Zoning Code (IZC)
- Section 2. This Ordinance shall take effect upon its adoption, as otherwise provided by law.

Section 3. If any provision of this Ordinance or the application thereof to any person, thing, or circumstances, is held invalid by a court of competent jurisdiction, such invalidity shall not affect the provisions or application, and to this end, the provisions of this code and such amendment and statutes are declared to be severable.

Section 4. The provisions of this Ordinance shall be included and incorporated in the Code of Ordinance of the City of Tarrant as an addition or amendment thereto, and shall be appropriately renumbered as necessary to conform to the uniform numbering system of the code.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TARRANT AS FOLLOWS:
