PUBLIC HEARING- OPEN SPACE GRANT APPLICATION- ACQUISITION OF WALZ PROPERTY

A Public Hearing was conducted on September 4, 2018 for the Borough's 2018 Municipal Open Space Grant Program through Monmouth County. The hearing was conducted as part of the regularly scheduled Borough Council meeting at 7:30pm. The Public Hearing was advertised in the Asbury Park Press on August 23, 2018.

The Borough Engineer, Thomas Neff, explained that the Borough is eligible to apply for a Monmouth County Municipal Open Space Grant. The goal of the program is to acquire lands for open space preservation and to improve land for parks and recreation purposes. The applications are due on September 20, 2018. The maximum grant award is \$250,000. A 50% funding match is required from the Borough.

Mr. Neff indicated that the Borough has the options of submitting a grant to renovate an existing park, build a new playground or other park/recreation facility, or to utilize grant funds to acquire a new open space parcel. Acquisition projects are typically favored over renovating existing facilities.

Mr. Neff recommended that, based on discussions with various Borough officials, the Borough submit a grant application for the acquisition of what is known at the Walz Property, which is an old farm consisting of approximately 59.8 acres and is known as Block 145, Lot 28.01. The site is located north of Shark River Road between Shafto Road and Wardell Road. It provides a buffer between the Mazza Recycling Center and the residential houses on Hart Terrace, Thresher Court, and Almar Road.

Mr. Neff states that at this time, the Borough has no intentions to develop the site into specific sports fields or playgrounds. The Borough would prefer to keep it as open space and only create walking trails throughout the fields and woods. The Borough may also create a dock or platform for fishing at the pond. There are also existing historic buildings that could be used for occasional tours.

The Borough Council and Administration expressed their support for this application and indicated that sufficient funds are in place for the 50% match requirement.

The topic was then opened to the public in attendance at the meeting to solicit their input for this project or any other projects or ideas. Mr. Gerald Turning spoke about the proposed Walz Property acquisition. Mr. Turning questioned if this property would end up on the ROSI list. He is not in favor of the necessary requirements and restrictions for Green Acres properties. Mr. Neff stated that this grant program has similarities to NJDEP Green Acres, but not all of the same exact requirements. Mr. Turning questioned if there are any environmental concerns that would prohibit the Borough from taking this property. Mr. Neff stated that any environmental areas of concern would be addressed prior to the Borough accepting any potential grant funds. Mr. Turning stated he has been out to the property, and expressed that it is beautiful, and he recommends the Borough apply for the grant and pursue purchasing the land. No other members of the public spoke about the grant opportunity.

At 7:47 PM Mr. Neff closed the public session.

Mr. Fallon briefly discussed Ordinance 2018-1436 for introduction on tonight's agenda. He explained that it is an Ordinance that would approve an amendment to the financial agreement with Commvault. He wants to clarify that it is not changing any of the financial terms of the agreement however they are amending it to add an additional parcel of land that was purchased by Commvault. They will not be extending the terms of the agreement and the annual service charge percentage will stay the same. Mr. Fallon discussed the 2017 Tax Reform and Job Act passed by the Federal Government and explained how it changed the State and local tax deduction. He stated that the Borough will continue to monitor any changes in legislation.

Borough Administrator- Michael Skudera

Mr. Skudera announced that the date for the 2018 Tinton Falls Day has changed to Saturday, October 6, 2018 with a rain date of October 7, 2018. WHEREAS, on May 22, 2018, CommVault acquired an additional 4.0 acre parcel adjacent to the Property, commonly known as the Charles Wood Fire Station parcel (the "Fire Station Parcel"), from the Fort Monmouth Economic Revitalization Authority; and

WHEREAS, CommVault intends to incorporate the Fire Station Parcel as part of the CommVault corporate campus on the Property and develop it as part of the underlying redevelopment project; and

WHEREAS, CommVault has petitioned the Township to include the Fire Station Parcel as part of the Property for purposes of the Financial Agreement, to which the Borough hereby agrees; and

WHEREAS, consistent with the LTTEL, Section 16.6 of the Financial Agreement permits amendments to the same upon duly adopted ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Tinton Falls, in the County of Monmouth, State of New Jersey, as follows:

- 1. The application of CommVault Tinton Falls Urban Renewal LLC, an urban renewal entity, requesting the amendment of the Financial Agreement to include the Fire Station Parcel as part of the Property, as defined in the same, is hereby accepted and approved.

WHEREAS, CommVault has petitioned the Township to include the Fire Station Parcel as part of the Property, as defined in the Financial Agreement, to which the Borough hereby agrees; and

WHEREAS, on DATE, the Borough adopted Ordinance 2018-1426, approving the application of CommVault to include the Fire Station Parcel as part of the Property as defined under the Financial Agreement.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

- 1. The Financial Agreement is hereby amended to add the Fire Station Parcel to the definition of "Property" contained therein.
- 2. The Fire Station Parcel is hereby subject to any and all terms of the Financial Agreement, including but not limited to the inclusion of all gross revenues derived by CommVault from the same in the calculation of gross revenue subject to the annual service charge under the Financial Agreement.
- 3. CommVault hereby agrees to be bound by the terms and conditions and perform any and all obligations contained in the Financial Agreement with respect to the Fire Station Parcel.
- 4. This Amendment may be executed in any number of counterparts, each of which when executed and delivered shall be an original, but all such counterparts shall constitute one and the same instrument.
- 5. In all other respects, except as herein specifically amended, the Financial Agreement continues in full force and effect as originally executed.
- 6. This Amendment shall be effective as of the date hereof.
