Mayor's Report - Vito Perillo

Mayor Perillo read a letter from Senator Chris Smith which states that Tinton Falls has been recognized as a Tree City USA for the year 2018 by the Arbor Day Foundation. Mayor Perillo presented the letter to Mrs. Carney, Chair of the Shade Tree Commission. Council President Baldwin thanked Mrs. Carney for her many years of dedication to the Borough.

Engineer's Report- Thomas Neff

Mr. Neff discussed Resolution R-19-125 authorizing execution of a TWA for MCRC upgrades and gave a brief overview of the expansion of sewer services. He briefly discussed Resolution R-19-145 which is an MOU for sewer service agreement with Eatontown for Suneagles Golf Club. He explained that the developer, Martelli, is in the process of redeveloping this property with new townhouses as well as renovating the club house and the tavern. He discussed the current sewer connection for this property and explained that this agreement will allow the Borough to collect sewer connection fees from the new development and clubhouse. He stated that this will be a significant financial gain for the Borough and discussed the breakdown of the connection fees.

Council's Report

Councilwoman Fama discussed the Library's latest Save our Library event that was held at the Sycamore Fields and thanked all who attended to show their support for the library. She also thanked Administration and DPW for their time and effort in supporting this community event. She announced that the next library event will be a food tasting on October 14, 2019 at Gibbs Hall, for more information visit www.tintonfallslibrary.com. Ms. Fama inquired about the new structure in Code Enforcement and again requested an update in writing from Administration so that we can actually know in real quantitative way if the new structure is working or something that is not benefiting our town.

Councilman Siebert announced that he recently attended the Jr. Police Academy graduation and stated that it was a great event. He thanked the Police Department for putting together an excellent 3-week program for the young adults of Tinton Falls. Mr. Siebert explained that there will be a Monmouth County Eco Tour on Saturday morning with 3 stops in Tinton Falls.

Councilman Manginelli stated that he also attended the Police Cadet Graduation and commended the Police Department on a wonderful program.

Council President Baldwin stated that he has been attending this graduation ceremony for the past ten years and thanked former Police Chief Mr. Gerald Turning for putting this program together in 2001. He discussed the upcoming Planning Board Meeting on August 14, 2019 in which there are two applicants on the agenda.

PUBLIC DISCUSSION OPEN

Ron Wollner, 8 Green Meadow Drive- Mr. Wollner discussed the flooding in Parker's Creek and stated that nothing has been done to fix this issue. Borough Engineer Mr. Neff stated that it was his understanding that Councilman Pak was going to reach out to the school regarding this issue. Mr. Wollner asked Council to consider putting together an Ordinance that would protect existing farms and keep them safe from redevelopment. Mr. Wollner voiced his frustration with the dangerous situation at Hance and Sycamore Avenue and handed out a news article from the Asbury Park Press published in 2015. Mr. Wollner read from the news article where he was quoted saying that he travels this intersection daily and he worries about the safety of his family and the community; he asks if it will take someone losing their life to fix this intersection. He stated that he is very angry and upset to learn that there was a recent fatality as a result of the Hance/Sycamore intersection and implored Council to act and find a solution. Council President Baldwin responded by saying that he is constantly on record asking the county to do something to fix this road however they have yet to find a solution. He stated that he will continue to push the county until this intersection is made safe.

Tracy Buckley, 17 Helene Court- Ms. Buckley also discussed the ongoing issues at Hance and Sycamore and the meetings she has attended where she has asked County Engineer Joe Ettore for updates. Ms. Buckley addressed several ideas presented to the county and her overall concerns with making that intersection safe over the idea of less traffic. The County's main concern is level of service, which means free traffic flow, and not safety. She explained that she asked Freeholder Arnone to come back to the Borough for another presentation and he agreed to do so. The County is set to come out with another report around October. Councilman Manginelli stated that he will not send the County back to the drawing board, and he will vote for whatever plan they come up with. He suggested we wait for the report, hear what they have to say and move on to a solution. Councilman Siebert stated that he tends to contradict Ms.

Buckley's definition of "level of service". He stated that Level of Service is defined as the number of cars that flow through a traffic intersection per hour, or per minute, not necessarily free flowing. Councilman Siebert stated that in speaking with the County Engineer his concern with level of service, is that if you exceed a certain point of level of service, vehicles and operators begin to have irrational behavior which tends to lead to a higher incident of accidents.

Gerry Turning, 32 Periwinkle Circle- Mr. Turning also discussed the intersection of Hance and Sycamore and stated that this issue has been ongoing for about 15 years. He explained that the County is looking for the Borough Council to submit a Resolution in favor of the County moving forward with their plans to fix the intersection. Mr. Turning expressed his concern with the overall safety of the intersection, citing that it has gone from dangerous to deadly. He urged the Council to work with the County to finally find a solution to this serious situation.

Andy Aumack, 38 Stratford Road-Mr. Aumack introduced himself as a Borough employee in the Department of Public Works as well as a Tinton Falls resident, and he is here tonight to represent his fellow DPW co-workers. He stated that DPW received an MOA for their contract, and voted to accept and approve the contract. On June 18, the Borough passed a Resolution to accept and approve the terms contained in the MOA, however their contract still has not been settled. He inquired about the current status of the Contract and asked for an update. On behalf of Council and Administration Borough Attorney, Mr. Starkey thanked Mr. Aumack and all of DPW for all of their hard-work. He explained that the Labor Counsel had send a draft contract to the Union attorney and received no response.

Murray Guth, 30 Hazelwood Terrace- Mr. Guth inquired about the status of the Resolution the County has requested the Borough submit an order to move forward with intersection improvements at Hance and Sycamore. Council President Baldwin explained that the County has yet to present their final plan and Council will not produce a Resolution until the final plan has been submitted. Councilman Manginelli clarified that the County did present a plan however Council voted 3-2 against the plan, thus the County could not proceed. He reiterated his comments from earlier, that he will not permit Council to turn the County away, they must settle on a safe and acceptable plan. Councilwoman Fama explained why she was opposed to the County's initial plan and stated that she believed a simpler, less invasive strategy could have been put into place.

Frank Self, 20 Chelsea Court- Mr. Self discussed his concerns with the intersection at Hance and Sycamore and asked Council to simply submit a Resolution to the County stating that the Borough approves of the County moving forward. Council President Baldwin stated that the Council has not been able to get a majority vote in agreement with the County. Council will not give the County approval until they meet the Borough's requirements.

Carol Sills, Ms. Sills noted that Tinton Falls is home to many children who travel through Hance and Sycamore daily. This dangerous intersection is an emotional problem, and the safety of these children should be the Borough's main concern. Ms. Sills implored the Council to consider the consequences of inaction, no life is worth an intersection.

Gerry Turning, 32 Periwinkle Circle- Mr. Turning discussed the Resolution that the County has requested from the Borough and stated that it is simply a political issue, the County has an obligation to fix this road. During his years in office he has seen several reports and plans submitted, however the issue is not getting any better and a solution has yet to be found.

Mitch Kulberg, 21 Cedar Place- Mr. Kulberg discussed the library's recent fundraising event and was happy to see the community come together in such a wonderful way. He stated that while he enjoyed the event, he voiced his disappointment in the Borough's handling of the library. Councilwoman Fama responded to Mr. Kulberg's comments by clarifying that it was the Library Board's decision not to move forward with the funds that were in the budget. It was the Board's decision to apply for the grant and it is the State that has put this on hold, not the Council.

William DeVizia, 799 Sycamore Avenue- Mr. DeVizia stated that he has lived 300 feet from that intersection for the past 16 years and has heard numerous accidents. The residents want something to be done for the safety of themselves and their families. He believes that the County has been unable to fix this issue because there has been opposition. Mr. DeViza referenced similar intersections in neighboring towns and stated that the installation of traffic light was the solution. The Borough must hold the County responsible to make this intersection safe.

There being no further comments from the public Mr. Siebert offered a motion to close the Public Discussion, seconded by Ms. Fama.
