Borough Administrator Skudera stated that he would look into the matter. Mayor Perillo stated that he receives many compliments regarding Public Works but he would also address Mr. Garvey's complaint.

David Elko, 692 Tinton Avenue discussed the noise from the large trucks that travel on Tinton Avenue day and night. He asked if there are any laws governing the noise. Borough Administrator Skudera stated there are local and state laws governing the traffic and noise and stated that he will follow up with the Chief of Police and look into this matter.

Gerry Turning 32 Periwinkle Circle commented on the previous information presented regarding the ten acre farm on Tinton Avenue that is for sale and concurred that it is a great idea to have the borough investigate the possibility of purchasing the property. Mr. Turning inquired about the status of the Walz property. Borough Administrator Skudera stated that this property is still in contract negotiations and that he can't elaborate on the details. Mr. Turning asked for an update on the Fort Monmouth properties, in particular the pistol range and Myer Center. Council President Baldwin stated that the demolition of the Myer center has begun. Mr. Neff explained further that the demolition is being done from the inside out and all environmental concerns are being addressed with the complete demolition to be complete in the early part of 2019. Mr. Neff discussed the Pistol range stating that no formal application has been made to date. Council President Baldwin stated that plans have been made several times and each time FMERA must review. Mr. Turning inquired about the fire house property. Mr. Baldwin stated that the property has been purchased by Commvault and they will be moving forward with plans for usage. He also stated that Trinity Hall has begun the second of three phases the and also discussed the Lennar property which has planning board approval. Mr. Neff stated that Lennar is pretty close to breaking ground for parcel C1.

# ADJOURNMENT TO WORKSHOP

#### Discussion Hance-Sycamore Intersection

Mr. Pak offered a motion to adjourn to workshop, seconded by Mr. Siebert at 7:33 pm

ROLL CALL

AYES: All in Favor NAYS: None ABSENT: None ABSTAIN: None

Mr. Baldwin called the workshop meeting to order stated that speakers on the subject matter will be called from the signup sheet. Mr. Baldwin thanked the residents for their emails and letters and stated that no formal action will be taken tonight. Mr. Baldwin welcomed Joe Ettore and his staff from the Monmouth County Engineering Department. Mr. Baldwin asked if the council members had any questions. Councilwoman Fama inquired if residents could ask questions of the County representatives, Mr. Baldwin confirmed that is correct. Councilman Pak stated that the Council is looking for what is in the best interest of the borough and stated that he is happy to obtain more information from this forum.

William DeVizia, 799 Sycamore Avenue stated that his main concern is that this intersection be made safe and asked that a temporary light be considered, find a means to slow down traffic, enforce the weight limit and compile a speed study. County Engineer Joe Ettore explained that a speed study was done in 2017. Mr. DeVizia stated that he feels that the plan as proposed is intended to move large numbers of vehicles through the intersection and that the intersection can be made safe without major changes. He pointed out various municipalities that have similar intersection issues who have solved the same type of problem with installation of a traffic light. He urged that consideration be given to a temporary light to see the results.

Chris Colson, Counsel for Sycamore LLC introduced himself and stated that he represents many area residents that are concerned about safety and asked if he could set up a meeting with the County Engineers to present and share supplemental data that he has compiled. Mr. Ettore stated that the information to the county offices and they would share the information expeditiously.

Peter Karavites, 784 Sycamore Avenue thanked the Council members that attended the walking tour of the site, he discussed the impact of the changes on the homeowners in the area and thanked Mayor Perillo for his time and support. Mr. Karavites stated that the improvements need to be something that works with safety being the center of the concerns and that the borough needs to be in active negotiations. We need to find a solution that both sides are happy with and Tinton Falls Council needs to take an active role in this decision.

Richard Calanni, 1 Old Farm Road stated that there was a recent accident on Hope Road and he was grateful there were no fatalaties. He discussed the need for a review of safety issues, lowering speed limits particularly in and around schools and weight limit changes. Mr. Calanni stressed the need for a solution to this dangerous intersection. Mr. Ettore stated that the County does not have jurisdiction over weight limit, but it does have an obligation to provide a regional network of roads. Mr. Ettore stated that the statutes dictate to speed limits in school zones, just as they dictate that the county cannot regulate weight limits. He further discussed the speeding and the statistics for traffic incidents. Councilman Pak stated that many of the accidents happened when a vehicle tries to make a left hand turn onto Hance and onto Sycamore.

Ruth Rapkin, 717 Sycamore Avenue discussed the taking of property for the improvements and suggested that possibly a signal be placed before the blind curve to warn of an impending red signal ahead would help. County Engineer Joe Ettore stated that it is a measure of last resort and stressed the best solution would be to have a clear line of site. He further discussed the proposal as it relates to widening, turn lanes and traffic flow.

Janice Kulla, 340 Hance Avenue, discussed the slide presentation and inquired about pedestrian and bike safety. Mr. Ettore stated that for pedestrian safety there would be hand countdown signals and stated that bicycle traffic had not been taken into consideration and explained that if there were to be a bike lane the road would have to be wider. Ms. Kulla further discussed lighting, restricting turning movements, and collision diagrams. Ms. Kulla discussed several facts from the traffic manual. She felt that there had to be other alternatives to the proposed plan.

Nina Bell, 19 Majestic Drive stated that she has a deep concern for a safe and equitable solution and stated that this is not a quantifiable solution as presented.

Don MacNeal, 1 Edward Farm Road sated that safety is the primary issue and he urged the Council to vote for the least impactful, financially sound solution.

Greg Spicer, 12 Edwards Farm Road stated that he supports the traffic light but is very concerned about the bi-pass solution.

Frank Self, 20 Chelsea Court, stated that he understands the problem the property owners have with taking of property but stated this is a very dangerous intersection. He stated that he was in a serious car accident at this intersection and was almost killed. He urged a solution that makes this a safer intersection before a fatal accident occurs.

Deb McNally 793 Sycamore Avenue stated that she submitted her comments and that she analyzed the plans. She stated that she works at Rutgers on a planning and development team. Ms. McNally stated that she is in favor of a traffic light but not one that creates massive change. She stated that safety trumps all and she felt that the engineers have many other options that they can consider. Ms. McNally stated that the study is flawed and incomplete and needs to be reassessed.

Ken Walls, 798 Sycamore Avenue, voiced his concern of the dangerous intersection and urged enforcement of speed and weight limit restrictions.

Gerald Turning, 32 Periwinkle Circle, addressed the County Engineer, Mr. Ettore, regarding the history of this intersection which was investigated eight to ten years ago during which time he was Police Chief. He stated at that time it was a dangerous intersection and something needs to be done.

Lenny Paulin, 826 Sycamore Avenue stated that he thinks the plans presented are unclear and muddled. He commented on the left turn lane, the blind curve, and general all day backup of traffic along Sycamore in front of his home

Tracey Buckley, 17 Helene Court, stated that she submitted a letter on behalf of the Winding Brook Condo Association asking if a complete study could be done all the way to Shrewsbury Avenue intersection where speeding is an issue and impacts safety.

Ron Walder, 8 Green Meadow Drive stated that this is a dangerous intersection which should address safety first. He stated that he has empathy for those whose property would be taken but also asked if the Borough is liable if they do nothing and do not address a dangerous situation. Mr. Walder stated that his is in favor of improvements without taking of property. Mr. Starkey commented regarding liability and his role to protect the council and residents of Tinton Falls.

Amy Mallet, 14 Rebecca Ann Court thanked the borough and county officials for this forum and stated that the feedback is vital for making the correct decision regarding improving the intersection. She stated that the message is loud and clear that the interest of safety is a priority and improvements are necessary but there needs to be a solution without major impact. She urged that the lines of communication be kept open.

Mr. Baldwin invited Council's comments. Councilwoman Fama thanked the County Engineer's for their time this evening. Ms. Fama wanted to echo Mrs. Mallet's comments that this is a matter of safety. Ms. Fama stated that she feels this to be a very simple question, can a light be put in place and avoid taking of property? Ms. Fama asked if an interim measure can be put in place for some period of time to see if we can effectuate a solution. Ms. Fama suggested that it would need to be a measure that addressed reduction of speed limit, weight limit enforcement and a temporary light for a period of time with further evaluation to follow. Ms. Fama stated that every avenue needs to be considered before a final vote is taken on this matter.

Councilman Siebert stated that he has lived in Monmouth County all of his life and discussed the many similar intersections in this County where traffic congestion at intersections are a common place occurrence. Mr. Siebert stated that he has submitted ideas and suggestions and they were rejected. He stated that he feels strongly that the intersection changes do not need to be drastic and that there are comparisons to be made with other recently improved intersections in surrounding municipalities.

Councilman Pak stated his concerns are similar, something needs to be done and a solution needs to be found. Safety needs to be the first concern, another look needs to be taken of the whole scope and the feel of the area needs to be preserved. Mr. Pak stated that taking of property is permanent and that we can work together for a solution that will minimize the impact of the borough, residents and immediate area.

Councilman Manginelli stated that he feels this is dejavu from a few years back where we went through the same scenario. At that time we told the County that Council didn't want people to lose property and asked them to revisit the plan and return with a revision that [provides safety but minimally impacts the residents and property. We are back to square one and doing this all over again and peoples lives are being impacted.
