**Beverly Gruensfelder**, 36 Willow Road, Tinton Falls- Ms. Gruensfelder thanked the Council and Administration for re-opening the pickle ball courts at Wardell Park. Thank you to all that were responsive to our calls and emails regarding opening the park. Ms. Gruensfelder asked if consideration could be given to extending the evening hours at the park. She also stated that she was not in favor of using a reservation system and prefers open play.

Diane Lindy, 152 Jumping Brook Road, Lincroft- Ms. Lindy thanked everyone that returned her calls regarding the pickle ball closure, everyone was very helpful. She also agreed that the open play is great and supported using that system and asked that this be considered for the future. Mr. Fallon, Interim Borough Administrator thanked the speakers for their comments and suggestions, and stated that they will be taken into consideration. He stated that this park has been very successful and the borough is working to resolve all of the issues that have arisen. Mr. Fallon stated that he is anticipating the acoustical fence installation and hope that will help the noise issue.

John Echevarrieta, 6 Jake Drive, Tinton Falls- Mr. Echevarrieta stated that there is a park in Eatontown with pickle ball courts and the courts are almost adjacent to the residents back yard. He stated that noise doesn't seem to be an issue there. Mr. Echevarrieta inquired if this is really a quality of life issue. Mr. Fallon stated that any quality of life complaint needs to be addressed. Mr. Echevarrieta also asked if there is any plan on adding additional parking spaces in Rose Glen. Mr. Fallon stated since the Engineer wasn't present this evening he would take contact information and get back to him.

*Tom O'Hara*, *12 Preakness Court-* Mr. O'Hara commended the Borough for the installation of the pickle ball courts. He stated he also has concerns about the reservation system and felt that the open play is the best system.

**Beverly Gruensfelder**, 36 Willow Road, Tinton Falls- Ms. Gruensfelder stated that she played at the Courts at the park in Eatontown and she believes the court surface is different, and it seems to be quieter. She stated that the acoustic fence is a good choice as well.

*Lisa Weinfled*, *Ocean*, *NJ*- Ms. Weinfeld commended the borough for this amazing park and asked that they keep the open play system and asked the park be open another hour.

Council President Buckley asked the Clerk to read any written comments that were submitted. Ms. D'Annunzio read the first comment submitted:

Mary Danish. Saratoga Court, Tinton Falls- "My name is Mary Danish. I live on Saratoga Court and the back of my home faces the new Wardell Park. The park has pickle ball courts. The people start playing at daylight...usually around 5:30 - 6 am. The ball hitting the paddle is so loud and repetitive that it wakes me up every morning even with my windows closed and air conditioner on. This is unfair. I should be able to sleep in my own home and wake when I want to. This noise goes on all day long! Then, the music starts blaring and people shouting. I cannot even sit in my back yard and read or relax because it is too noisy. I no longer can relax in my own home. The noise/nuisance is causing headaches, lack of sleep, irritation, stress and frustration. I do not want to hear the bang, bang, bang of the ball all day long!!!! Did anyone even think about the quality of life for the people who live in the area before they put pickle ball courts so close to homes? I am a nurse and work well into the night. When I get home in the morning, I want to sleep. But it is no longer possible to sleep in my own home during the day. I had to leave my own home and go elsewhere just to sleep. This is not right. On weekends if not working, I would like to sleep past 5:30 am (now 6:30). If I am home sick, I would like to enjoy some quiet! It is no longer a quiet neighborhood! I can no longer enjoy my backyard or even my home without noise. The constant bang, bang is exasperating! Speaking with those playing paddle ball, they said they come here because the courts local to them were closed down due to noise complaints. So it is just not me. Some places required the paddles to be padded to help with the noise, and had to build tall sound barriers. Where are our sound barriers? I have lived here for 19 years, paid my taxes and had loved my home. It is just not fair what you have done to this peaceful community. What are your plans to help make this community livable and peaceful again? What is the city doing to control this noise/nuisance for local residents?"

Ms. D'Annunzio read the next public comment into the record:

Gary Eicken 31 Saratoga Court, Tinton Falls- "It was nice that the borough put this park on Wardell Road. There are a few issues that need to be addressed. No one gave it any thought that the noise from the park would emanate through the woods to Saratoga Ct and other nearby residents. The main noise is from the pickle ball courts, it is a constant popping noise and the loud players. With the nice weather the pickle ballers start at first light and continue into the evening. Once the lights come on the noise will continue later into the evening. I can't enjoy a cup of coffee on my patio or even sleep with my windows open due to the contestant popping and loud players. This park has negatively affected the way of life for numerous residents. A suggestion would be to install sound barriers and have the players use padded paddles. There are no signs stating any hours of operation for the park."

Mr. Fallon stated that both residents have been contacted and informed how the matter is being handled.

There being no further comments, Mr. Siebert offered a motion to close the Public Discussion, seconded by Mrs. Clay.
