### REPORT OF MAYOR/COUNCIL/ADMINISTRATION

# Public Hearing - FY 2020 Community Development Block Grant (CDBG) Application

Council President Buckley stated that the Borough is required to hold a public hearing on the submission of the 2022 Community Development Block Grant Application. She then turned the floor over to Borough Engineer Mr. Neff to discuss the details of the Community Development Block Grant (CDBG) application process. Mr. Neff stated he would like to give a brief overview of the grant and then he would ask Council President to open it up to the public at the end of his discussion for any public comments. Mr. Neff explained that this is the Public Hearing for the Monmouth County Community Development block grant which is released every year, but municipalities are only eligible to apply every other year. The last grant was for the 2017 funding cycle for Tinton Falls and was for the southern portion of Hope Road. He explained that this is not a matching grant and the maximum fund request is \$200,000. Mr. Neff stated that eligible projects must meet HUD regulations and serve an eligible population. He explained that most projects, such as roadwork must be located in a designated target neighborhood (DTN) to be eligible, most of which is located in the southeastern portion of Tinton Falls and is determined and identified on Census maps. Mr. Neff stated a review has been completed of eligible areas and the recommendation is for curb, sidewalk and drainage improvements to Wardell Road from Maywood Run south to inside the new Wardell Park. The final construction estimate for the cost needs to be finalized but it should be in the area of \$200,000. Mr. Neff stated that the goal is to provide an ADA accessible sidewalk route from the various Fox Chase neighborhoods off of Maywood Run and Appaloosa Run to the new park. Sidewalk currently exists along a portion of Wardell Road south of Appaloosa Run but is on the opposite side of the road from the park. Mr. Neff stated that a flashing beacon with signs and a crosswalk would be installed as well as new sidewalk extending inside the park to the playground area. The sidewalk would be extended north on Wardell Road where none currently exists to the southern portion of Maywood Run and new concrete curb would also be provided. Mr. Neff explained that because new curb would be required, a new drainage system would also be constructed with new inlets and pipes to connect to the existing system at Maywood Run. This would also address chronic ponding issues along the edge of the road.

Mr. Neff stated that the application is due to the County by Friday July  $2^{3rd}$ , presentation would be made to the CDBG Committee in September and hopefully by the end of the year we will be advised of the grant award.

Mr. Neff asked if there were any questions from Council.

Council President Buckley asked about the approximate amount of the grant. Mr. Neff stated that he estimates the grant could come in somewhere just under \$200,000 but he would have to work out the details for the final figure. Mr. Neff stated that this a very competitive grant and the other towns vote on the final grant application award.

Mr. Manginelli inquired about the restroom building for Wardell Park. Mr. Neff stated that the restroom building for that park would probably be a submitted through another grant application later this year.

Council President Buckley stated that she thought this was a good project for this grant. There being no further comments from Council she asked for a motion to open the public hearing.

#### **Borough Engineer - Thomas Neff**

Mr. Neff reported that under consent agenda there is a resolution authorizing the submission of the CDBG application and authorizes the Mayor and Clerk to execute the agreement if we were to get funded. Mr. Neff stated there is a similar resolution on this evening for the NJDOT municipal aid grant application just submitted for Gilbert Street Roadway Improvements and add sidewalks on the northern section of Gilbert Street North which would connect Greenbriar Falls to the new sidewalk to be installed on Shrewsbury Avenue. That funding was received last year.

#### Director of Finance/ Acting Borough Administrator- Thomas Fallon

Mr. Fallon reported that the 2020 Audit Report has been received from our independent auditor, Suplee, Clooney and Company. He stated it was an exemplary report with no comments or recommendations noted by the auditors, and no adjustment to the Borough's financial statements. He extended his congratulations to the borough employees on this audit, here hard work and attention to detail is evident. Mr. Fallon stated that the audit will be posted to the borough website for anyone wishing to review it. On tonight's agenda there is a resolution on the agenda verifying the Council's review of the Audit along with a group affidavit for their signature attesting to same.

# Mayor's Report - Mayor Vito Perillo

Mayor Perillo commended CFO Tom Fallon for his fine work on the audit.

# **Director of Law- Kevin Starkey**

Mr. Starkey stated he had no formal report but wanted to say that it is great to be back to in person meetings again.

# Borough Clerk – Melissa Hesler- No report

#### Council's Report

-Mrs. Clay echoed Mr. Starkey's comment that it is wonderful to actually be here in person and be able to see everyone. Mrs. Clay gave an update on Community Day which is scheduled for October 10<sup>th</sup> from 1 pm to 5 pm. There will be a 5K run beginning at 11 am. She stated it's exciting to be able to bring community day back. Mrs. Clay was excited to report there will be many activities for children and families.

-Mr. Manginelli reported that he attended a Historic Preservation Commission event, a very successful Juneteenth Celebration at the Crawford House. The Crawford house is a great place and suggest everyone stop by for a visit.

-Mr. Nesci reported the Planning Board recently had a meeting where they addressed one application for approval of a minor subdivision along Tinton Avenue. The upcoming Planning Board meeting has been cancelled. Mr. Nesci stated he was sorry that he could not attend the Soldier On tour of the Veteran's Housing complex but assured everyone he would take advantage when the next visit is available. Soldier On is a great organization, he stated he offered barber services to the facility when they open. Mr. Nesci discussed the recent workshop discussing backyard chickens, since then there has been collaboration to create a foundation draft ordinance mirroring surrounding towns and to build a stronger ordinance that is the best fit for Tinton Falls. He stated that he hopes the ordinance to be ready for introduction at the next meeting. Mr. Nesci extended his thanks to everyone involved in the creation of Wardell Park, especially Mr. Neff, it looks magazine quality. He stated he was unable to attend the ribbon cutting ceremony but recently visited the park with his family. Great job. Mr. Neff commended Dan Romanov and his IT department for successfully setting up the Borough's YouTube channel and allowing more residents the opportunity to attend Council meetings while being home.

-Mr. Siebert reported that the Tinton Falls Library Association will be holding a music festival on August 14th from noon to 8 pm with many activities for everyone. He stated that he attended the ribbon cutting for Wardell Park grand opening, he stated that it was a great event and he even learned how to play pickleball. Mr. Siebert also echoed the comments of his colleagues about being able to attend in person meetings.

-Ms. Buckley commended Mr. Fallon and all the departments on the audit report and thanked Mr. Romanoff for setting up the YouTube Channel for live streaming the council meetings. This enables residents to view the meetings at any time, both audio and visual. Ms. Buckley stated that she was able to attend the Wardell Park grand opening on a very hot day, it was a fantastic turnout and concurred that the description of "magazine quality" is a perfect way to describe the park. Ms. Buckley stated that she was able to attend the Soldier On facility tour, they have thought of every possible detail. She stated that the units will be completely furnished and they are looking for help from the community by way of donation of items listed on their Amazon wish list. Cappelli has been notified about this issue to put them on notice that this ordinance will be in place and enforced. They were instructed to notify all the users of the fields to park only in designated parking areas. Mr. Neff stated that there is also an issue with pedestrian crossing in areas that are not intended for crossing.

Mrs. Hesler read Ordinance 2021-1474 entitled: An Ordinance Prohibiting the Operation of any Class of Cannabis Business within the Jurisdiction of the Borough of Tinton Falls until Adequate Regulatory Guidance is Provided by the State's Cannabis Regulatory Commission

Council President Buckley stated that she would like the Director of Law to make a statement on behalf of the Council before opening the floor to public comment.

Director of Law, Kevin Starkey stated that his comments are on behalf of the Borough Council pertaining to this ordinance. He stated this ordinance is commonly known as a cannabis opt out ordinance and the purpose of it is driven by state law which says that if a town does not take action by August 21st then all types of cannabis businesses will be allowed in that town. The adoption here is not because the Council is opposed to cannabis, nor does it mean that the

Council would not consider allowing cannabis establishments to locate in the borough as we move forward. Mr. Starkey stated there will be a Cannabis Regulatory Commission that will be established by the State and they will promulgate final regulations. It is uncertain when those regulations will be finalized but it is certain they will not be available by our deadline of August 21. Those regulations will give needed guidance to towns. Mr. Starkey stated that in the interim what this Council intends to do is take a detailed review and begin to draft an opt-in ordinance to allow some businesses in some parts of town. The review will take a detailed look at the types of businesses and licenses, and their suitability within the different districts in town. Mr. Starkey stated the review will include input from the Planning Board, Borough staff and professionals. There is a resolution on the agenda for a vote this evening which will establish a Cannabis Sub-committee which will include two council members and professionals from the town to undertake that review. The ordinance being considered this evening has been drafted using a model ordinance prepared by the NJ League of Municipalities for use by all municipalities of the State because of the short timeline the state has set for towns to either opt in or out.

# **PUBLIC HEARING OPEN**

Jay Goldberg, 90 Glenwood Drive – Mr. Goldberg asked for someone to confirm that this ordinance is just for opting out but doesn't preclude us from adopting ordinances later allowing businesses in the Borough. Mr. Starkey confirmed that his understanding is correct.

Craig Gately, 10 Polo Club Drive- Mr. Gately asked if we take no action are the licenses then allowed in all industrial and retail zoning locations. Special Counsel Brian Nelson stated that it also locks you in for 5 years and there is no tax benefit, and all license classes are then allowed in all commercial zones and the borough basically relinquishes all zoning rights in the municipality. Mr. Gateley stated that if the ordinance is adopted the borough is going against the wishes of the constituents who voted in support of legal marijuana, this is an anti-business approach, and the businesses will go elsewhere.

Jefferey King, 24 Elizabeth Parkway, Eatontown- Mr. King stated he is a property owner in Tinton Falls and felt the subcommittee is a great idea but implemented a bit late. He stated that universities are offering majors with scholarships and an opportunity for high paying jobs in this field for botanists and chemists making six figures. Mr. King stated there are many areas that cannabis businesses could be allowed. The Borough is missing out on a great opportunity. The people voted for this legislation and local people should be running a dispensary here, not big corporate establishments. The borough needs organic, locally grown, craft cannabis in our community. He stated that he does not see the Borough heading in that direction.

Council President Buckley stated that previously there were two public discussions on this matter, each one approximately an hour and a half long. There were various proposals set forth, and unfortunately at the end of those meetings there were more questions than we had answers. Ms. Buckley stated that a list of 26 questions was submitted to the Cannabis Regulatory Commission which was a compilation of questions from all Council members. She gave an overview of some of the concerns and stated that if anyone would like a copy of the questions she'd be happy to email them. It is the consensus of this council to allow cannabis in the Borough, but the devil is in the details on how this zoning ordinance is prepared and how it would impact the Borough.

Denise Catalano, 11 Alpine Trail- Ms. Catalano stated that she wanted to make two clarifications, the first being that when we as voters cast our vote we were voting on whether to legalize marijuana, not whether we wanted to allow marijuana facilities in our town. Secondly, this is a stop gap ordinance that is necessary because the state hasn't defined how they want all of this to work yet. Ms. Catalano stated her understanding is that rather than risk doing nothing and being held to something we don't want for 5 years, then the Borough could opt back in once guidelines have been established by the State and do what is best for the town.

*Craig Gately, 10 Polo Club Drive-* Mr. Gately stated that his understanding is that if the Borough does nothing, they could later do everything they want to do down the line. Council President Buckley stated if we opt in the Borough is subject to everything the State proposes and there is no tax benefit. That is why this matter has to be delayed so the Borough can make the right decisions.

Special Council Brian Nelson clarified that if the municipality decides to opt in after the initial opt out, then you can add the tax later. Without the appropriate regulations and processes it is extraordinarily difficult for the governing body to take action or adopt ordinances establishing either zoning or licensing standards without the regulatory guidance from the State of New Jersey. Those regulations are due out sometime later this year and when those regulations come out, any actions we take could be preempted by those as well. Mr. Nelson stated the vast majority of municipalities are taking the same course of action, with a few exceptions. The State is not yet issuing licenses therefore the concerns regarding missing out on being granted a license are somewhat mitigated by that fact.

There being no further comments, Mr. Siebert offered a motion to close the Public Hearing on Ordinance No. 2021-1474, seconded by Mrs. Clay.

These questions were compiled and submitted to the Cannabis Regulatory Commission. The timeline for action is fierce, and as elected officials it was very difficult to make a decision without answers to those questions. Mrs. Clay stated that she believes the sub-committee will be effective and our professionals will provide the assistance needed. Mrs. Clay stated she has volunteered to be on this sub-committee.

Mr. Siebert concurred that there were more questions than answers after two workshop meetings on this topic. He stated without knowing the direction the State is going with the licenses and the regulations, it is very difficult to know where the licenses should be allowed in the borough. There is a community impact that needs to be considered and the sub-committee is the perfect venue to allow us to move forward.

*Craig Gately, 10 Polo Club Drive* – Mr. Gately stated that last months meeting there was some discussion about an ordinance which would allow chickens to be kept in the town. He stated that he is in favor of this ordinance and asked that the ordinance be made as simple as possible without making requirements for minimum lot sizes, licensing, and permits.

Councilman Siebert stated that was the intention for ease of access and ease of implementation.

Ellen Goldberg, 90 Glenwood Drive- Mrs. Goldberg echoed the previous comments about Wardell Park. She stated that she was very impressed at how beautiful the park turned out, and she complimented Mr. Fallon for the ceremony at the grand opening. It was a beautiful event. Mrs. Goldberg extended her thanks to Jill, Kaitlyn and Mark from Public Works for their help at the recent Webex Virtual Environmental forum in helping obtain information for her presentation. There were also presentations by the NJ Composting Council and the NJ Sierra Club. Mrs. Goldberg congratulated Mayor Perillo on the great job he has been doing over the past four years as Mayor.

Jerry Spumberg, 11 Alpine Trail- Mr. Spumberg stated he has lived in town for almost 30 years, and during that time there was a plan devised to upgrade and maintain the streets and roads in the Borough. He asked if that plan for bonding for the improvements is still being used today. Acting Business Administrator and CFO Tom Fallon stated that currently the Capital Improvement Program for roads is funded every other year so that we can get more efficiencies in the bidding process. The program is for a larger program every other year rather than funding a smaller program every year. Mr. Fallon stated the 2021-2022 program is about 2.6 million dollars, there are also additional funds available from previous road programs that may have come to bid under the appropriation amount. Mr. Fallon explained that regarding debt, the Borough is actually retiring a million dollars more per year than is authorized. Over the last 6 to 7 years debt is down about 9 million dollars, and the Road Program is the only program that is bonded. All other capital costs are funded directly in the budget. Mr. Spumberg stated in reality this is not really taxes being placed on the residents. Mr. Fallon concurred.

Jeff King, 24 Elizabeth Parkway, Eatontown- Mr. King inquired about the cannabis ordinance adopted this evening and stated that there was no reference to medical cannabis and suggested that it was also banned. He felt there was a need for these facilities. Mr. King stated he his happy that the borough has set forth a plan to address the opt in at a later date and not just kicking the can down the road. Discussion followed about the sub-committee and appointment of the members. Mr. King stated he was disappointed by the League of Municipalities that they lead the towns down the wrong road.

Councilman Siebert stated that the entire Council has pledged to move forward with this, if anyone has failed it is the State of NJ and the Cannabis Regulatory Commission because they are coming out with the regulations after the municipalities deadline. They are asking us to make a decision based on regulations that have not been presented to us. This Council has made it publicly clear that we will move forward at opting in once we know what the rules are.

*Keith Felder*, 22 *Gloria Court*, *Tinton Falls*- Mr. Felder commended the Borough officials for the great job on Wardell Park. He also commended the Police Department for the recent one-day camp, this was a great idea. Mr. Felder stated it is great for the kids to interact with the Police Officers and they will remember that. Kudos to everyone involved. Mr. Felder also commended the Council for their hard work and dedication.

Council President Buckley asked if there were any written comments submitted to be read into the record this evening. Mrs. Hesler stated there were none.
