Following the Pledge of Allegiance, roll call was taken with the following members present: Mike Murray, Travis Scholze, Lamont Kiefer, Donna Evans, Sue Holme, Shawn Zabinski, Jeff Cram, and Richard Yarrington. Absent: 1st Aldermanic District seat is vacant. Quorum present.

Also present: City Attorney Penny Precour, City Administrator Roger Gorius, and City Clerk JoAnn Cram. Gregg Hagen videotaped the meeting.

Motion by Scholze, second by Evans to adjourn to closed session pursuant to State Statute 19.85(1) (c) and (e) to Confer with Legal Counsel with Respect to Union Negotiations, Personnel Issues, and Purchase of Property. Motion passed with one negative vote (Yarrington). The meeting adjourned to Closed Session at 6:01 p.m.

Meeting reconvened to Open Session Pursuant to State Statue 19.85(2) at 6:49 p.m.

Anyone Desiring to Appear Before the City Council. No one desired to appear.

Mayor. Mayor Murray gave condolences to the family of Mary Ann Komiskey who has served faithfully on the City Council. The time she devoted to the City was done with compassion and desire and was truly appreciated. Mayor Murray also commended the EMS services for all that they do, especially during the holiday season.

City Administrator & Long Range Planning Committee Report. City Administrator Gorius provided a written report regarding current and ongoing activities. Winnebago Park, Flare Ave., Recreation Park and other projects will be worked on in the coming months.

Presentation by Cindy Zahrte, Supt. Tomah Area School District addressed the Council regarding various school activities and functions. The school district's mill rate went from \$7.45 to \$7.34 per thousand dollars of assessed value. The ranking of the school district is 27th lowest in the State for mill rate comparisons and the average is \$9.46. \$280,000 was distributed through school scholarships last year. The Board is currently conducting facility tours at all school district buildings. The school district is debt free. A spring primary will be held for three open seats on the school board. A survey will be available on the District website asking for the characteristics or the qualities that citizens would like to see in the next District Administrator.

Notice of Alderperson Vacancy. Due to the passing away of Alderperson Komiskey in the 1st Aldermanic District, there is a vacancy on the Council. There are two options: Leave the seat open until the November Election or appoint to fulfill the remaining term until April 2021.

City Clerk. City Clerk Cram provided updates on the Spring Election process, Compete Count Census Committee, Agenda and Minute software, levy limit for 2020 and the status of printing the budget books.

ORDINANCE NO. <u>2020-01-01-D</u>

Ordinance Amending Chapter 6, Sections 6-1, 6-8, and 6-9 (d) of the City of Tomah Municipal Code Regarding Amusements and Entertainment

SECTION ONE: Chapter 6 – Sections 6-1, 6-8 and 6-9(d) Amusements and Entertainment of the Municipal Code is hereby amended to read as follows:

Chapter 6 - AMUSEMENTS AND ENTERTAINMENT ARTICLE I. CABARETS Sec. 6-1.- Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Indoor cabaret means a place to which the general public is admitted and where dancing or live entertainment is permitted or furnished to patrons by the management with or without special charge therefor, and where liquid refreshment or foods are sold.

Outdoor cabaret means an outdoor area to which the general public is admitted and where dancing or live entertainment is permitted or furnished to patrons by the management with or without special charge therefor, and where liquid refreshment or foods are sold.

Special Event Outdoor Cabaret shall be permitted to conduct an outdoor cabaret; however, such license shall be for a period not exceeding one day, and may exceed the noise levels established in the City Code, provided the sounds emanating from the outdoor cabaret are reasonable under the circumstances, subject to Common Council approval. All property owners within 200 feet of the proposed licensed premises for a Special Event Outdoor Cabaret License shall receive written notice of the original application. Subsequent applications for similar events will require a general notice to the public, A license shall only be granted following approval by a two-thirds vote of the Common Council.

Sec. 6-8. - Investigation.

Each application submitted in accordance with the preceding subsection shall immediately be transmitted by the City Clerk to the Police Department, Fire Department, and Building Inspection Department for review, and said officers shall sign off on the application or report in writing to the City Council their recommendations on such application; and therefore said application shall be presented for action by the Council at the next or any subsequent meeting thereof. The Fire Department and Building Inspection Department shall inspect the premises (if applicable) for new applications only.

(d) All property owners within 200 feet of the proposed licensed premises for a special event outdoor cabaret license shall receive written notice of the original application. Subsequent applications for similar events will require a general notice to the public. A license shall only be granted following approval by a two-thirds vote of the Common Council.

SECTION TWO: All ordinances in conflict with the foregoing are hereby repealed. **SECTION THREE:** This ordinance shall take effect upon passage and publication.

Ordinance Repealing Sections 44-177 to 44-181, Recreating Sections 44-177 to 44-181, and Creating Sections 44-182 and 44-183 Regarding All Terrain and Utility Terrain

Vehicles. As instructed at the December Council meeting, Chief Nicholson and the City Administrator were directed to present an ordinance proposal for ATV/UTV regulation in the City limits of Tomah. Chief Nicholson has reviewed similar ordinances from communities with like populations and has prepared an ordinance that he feels meets the needs of the City and the Departments that will need to interact with these vehicles and their operators. This ordinance follows WI Statute on ATV/UTV use and is the recommendation of both Chief Nicholson and City Admin. Gorius. Costs to the City will be minimal as all signage is to be provided by Road Runners ATV UTV Club, Monroe County at no cost to the City. It is further recommended that Road Runners ATV/UTV Club of Monroe County be named as the responsible party for provision of signage, at no cost to the City, for placement by City Staff as needed and that Mike Pierce, Club President, or his designee, be assigned as liaison between the Club and the City Council. The overall ordinance basically adopts State Statute except that Section 44-181 adds additional stipulations. The proposed ordinance requires a driver's license, adherence to speed limits, routes would be open from 6 a.m. to 10 p.m., open container of alcoholic beverages are not allowed while operating, and proof of insurance would be required.

Motion by Kiefer, second by Scholze to waive the first verbatim reading of the Ordinance Repealing Sections 44-177 to 44-181, Recreating Sections 44-177 to 44-181, and creating sections 44-182 and 44-183 regarding All Terrain and Utility Terrain Vehicles as presented and Road Runners ATV TV Club of Monroe County be named as the responsible party for provision of signage at no cost to the City, for placement by City Staff as needed and Mike Pierce, Club President (or his designee) is assigned as liaison between the Club and the City Council.
