### LONG RANGE PLANNING COMMITTEE MINUTES

The City of Tomah Long Range Planning Committee (LRPC) met in session on **Tuesday**, **April 23**, **2024**, at 5:30 p.m. in the Municipal Building, 819 Superior Ave, Tomah, WI, and via Zoom teleconference. The meeting access information was provided on the posted agenda. The meeting agenda notice was posted at City Hall and on the City's website in compliance with the provisions of Section 19.84 Wisconsin Statues.

**Call to Order – Roll Call:** Eric Prise called the meeting to order at 5:30 p.m. Members present: E. Prise, Travis Scholze, Tina Thompson, Paul Dwyer. Absent: Jeff Holthaus, Pete Reichardt, and Shawn Zabinski. Quorum present. Also in attendance: Ben Rohr of Vandewalle & Associates and Deputy City Clerk Nicole Jacobs.

**Approval of March 23, 2024, Long Range Planning Committee meeting minutes:** Motion by T. Thompson, second by T. Scholze, to approve the minutes of the March 23, 2024, meeting. Motion carried.

**Nomination and election of officers (Chair and Vice-Chair):** T. Thompson nominated E. Prise for Committee Chairperson, second by P. Dwyer. There were no other nominations. E. Prise was duly elected Chairperson of the LRPC. T. Thompson nominated T. Scholze as Committee Vice-Chairperson, second by P. Dwyer. There were no other nominations. T. Scholze was duly elected Vice-Chairperson of the LRPC.

**Economic Development Workplan progress report:** B. Rohr of Vandewalle & Associates gave the committee a progress report regarding the City's Economic Development Workplan. City staff and Vandewalle met to discuss the desired approach to handling new development inquiries. It was determined that staff will handle all basic procedural steps and inquiries related to developments that simply require a site plan as well as smaller-scale projects. Vandewalle will handle larger-scale projects, annexations, and/or projects that require additional steps beyond a site plan. City staff began drafting ideas for a new economic development webpage for the city website. No action was taken.

**Economic Development Workplan funds update:** N. Jacobs gave an update that none of the allotted \$60K has been used from the economic development fund, which was confirmed by B. Rohr. No action was taken.

**Update regarding Comprehensive Plan:** B. Rohr took the committee through a review of the second draft of the updated Comprehensive Plan. Last month's meeting summary was added, as well as new maps, photos, and references to the City's Park Plan. Committee members discussed with Rohr the future land use map, and any additional changes needed at this time.

**Discussion of potential future agenda items:** The committee requested a continued agenda item regarding the funds each month.

**Next meeting date:** Tentatively scheduled for Tuesday, May 28, 2024, at 5:30 p.m.

#### **Public Draft Feedback**

- May 23rd June 24th: Draft Plan, survey, and video summary recording were posted to City website
  - 84 total survey responses
  - 160 total video recording summary views
- What we heard
  - o 77% of respondents agreed with the action plan priorities in the plan
  - Top action plan priorities = indoor rec facility, revitalize downtown/Superior corridor, expand economic development initiatives and opportunities, improve exiting property conditions
  - Top missing ideas = childcare and infrastructure maintenance
  - Top plan likes = mix of ideas, housing, recreation, downtown, and economic development
  - Top improvements needed in the plan = more focus on downtown, small businesses, and economic development
  - Other comments = liked public input opportunity, need to address downtown, desire for additional recreational opportunities

- Appendix A: added all public input received
- Appendix B: added percentages of existing land use breakdown in the City today
- Main Plan: added more about childcare connection to economic development and downtown revitalization being a high priority item
