This would be a great addition to the park system, by providing an accessible area closer to Lake Tomah and the n.a.s.a. pontoon and fishing pier.



The area to the left is the spot being considered for a cement slab for the Tranquility Oasis.

It would feature accessible picnic tables for sitting near the lagoon and looking out onto the lake.



The area inside the purple lines would be cemented under the plan. Picnic tables would be located there. The blue square represents the location of a granite slab memorial. Names of loved ones would be placed on it. Already several people have donated to nasa for a memorial.

## COMMISSION MEETING REPORT

Agenda Item: Act on Knowles-Nelson Stewardship Local Assistance Grants, Land and Water Conservation Fund Program and Federal Recreational Trails Program Combined Grant Application and authorization of resolution.

# Summary and Background Information:

The Wisconsin Department of Natural Resources provides grant opportunities for municipalities to apply for funding Recreational Trails. The Knowles-Nelson Stewardship Assistance Grants, Land and Water Conservation Fund Program and Federal Recreational Trails Program Combined Grant Application is 50/50 matching funds. The grant application is due annually on May  $1^{\rm st}$ . Town and Country Engineering is working on a grant application at no charge. To apply for the grant, a resolution (see draft example) by the city must complement the grant application. Director Protz is seeking Park Board approval to finalize the grant application by recommending to the City Council to sign a Resolution authorizing the City of Tomah to file the application to the DNR and to follow the guidelines of the Grant.

Fiscal Note: The cost for the trail project is estimated at a total of \$950,000.00 (see estimate and map). The City of Tomah match would be \$475,000.00. Currently in the City of Tomah Capital Improvement plan \$635,000.00 has been proposed for the 2026 budget for the proposed Recreation Trail.



THEREFORE, BE IT RESOLVED, that the City of Tomah has budgeted a sum sufficient to complete the project or acquisition and

Submit an application to the State of Wisconsin Department of Natural Resources for any financial aid that may be available.
Submit reimbursement claims along with necessary supporting documentation within 6 months of project completion date.
Submit signed documents; and
Take necessary action to undertake, direct and complete the approved project.
BE IT FURTHER RESOLVED that the City of Tomah will comply with state or federal rules for the programs; may perform force account work; will maintain the completed project in an attractive, inviting, and safe manner; will keep the facilities open to the general public during reasonable hours consistent with the type of facility; and will obtain from the State of Wisconsin Department of Natural Resources or the National Park Service approval in writing before any change is made in the
