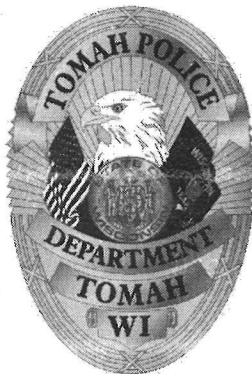

During the background investigation of Ms. Rouse, it was determined she was convicted of Possession of Heroin With Intent To Deliver in Racine County Circuit Court on April 29, 2015.

City of Tomah Ordinance 4-66 states that an Operator's License applicant cannot have "One or more felony convictions in the last ten years involving alcohol or drugs."

Accordingly, it is my recommendation to deny Ms. Rouse's application for an Operator's License for the City of Tomah.



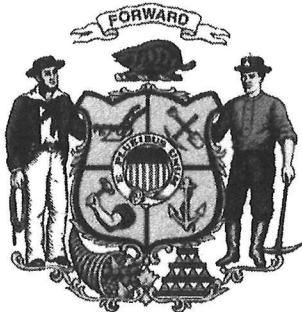

## **COMMITTEE OF THE WHOLE MINUTES, MONDAY JULY 18, 2022**

A Committee of the Whole meeting was held on Monday, July 18, 2022.

### **CALL TO ORDER – ROLL CALL**

The meeting was called to order by Council President Adam Gigous at 6:31 p.m. Present: Mike Murray, Adam Gigous, Richard Yarrington, Shawn Zabinski, Lamont Kiefer, Nellie Pater, and Dean Peterson Absent: John Glynn and Mitchel Koel. Also present for the meeting: Kirk Arity, Molly Powell, Becki Weyer, and Tim Adler. Shane Rolf appeared remotely.

### **APPROVAL OF THE MINUTES:**

Motion by Peterson, second by Zabinski, to approve the Minutes from June 20, 2022. Motion carried.

### **City Clerk Monthly Report**

Weyer provided a monthly written report. She gave an update on Clerk's office recruiting efforts and updated the Committee on the upcoming election on August 9, 2022.

### **Treasurer**

Powell presented the June 30, 2022 Cash and Investments Report and the May 31, 2022 Revenue and Expenditures with Comparison to Budget. There is currently a lot of cash as the City received the proceeds from the bonds which are earmarked for projects. Most of that money is being invested to earn additional proceeds. Some of the money that was previously in CD's has been moved into higher yield options.

Motion by Yarrington, second by Murray to recommend the Council approve the June 30, 2022 Cash and Investments report. Motion carried.

The Treasurer's office is currently recruiting and will be conducting interviews soon. Budget discussions with department heads will start beginning in August. Final property tax payments are due July 31<sup>st</sup>.

### **Parks & Recreation**

Protz provided the Tomah Parks and Recreation Program Monthly Report. In Coordination with CBS2 and the SET team, the City has applied for a grant for the Badger 5 project in the amount of \$8,500,000.

### **Public Works & Utilities**

Arity provided the Public Works and Utilities Director Monthly Report and covered the highlights with the Committee.

Street: They are currently painting white lines, and doing asphalt patches. New crosswalk signals should be installed soon. Appreciate Mecca Sportswear for preparing the flags for presentation during Military Appreciation Day.

Congratulations to Stuart Westphal on his retirement after 40 years with the City.

Sewer: The chip sealing is on schedule, bids were taken for the roof of the wastewater treatment plant

Water: Renewed wells permits at the VA and have replaced hydrants; one was destroyed by a hit and run.

Lake: The next meeting is scheduled Thursday 07/21 at 5:00 p.m. They will be discussing the vegetation survey.

### **Police Department**

Holum provided the June 2022 Police Department Monthly Report and covered the highlights with the Committee.

Holum gave a staffing update. The 2<sup>nd</sup> annual K-9 golfing event went well, thanks to all of the sponsors, volunteers, and participants. They raised about \$17,000. Thanks to the patrol staff for working extra hours during all of the summer events in the city.

### **Approval of Airport Hangar Contract between the City of Tomah and Timothy Schram**

Timothy Schram would like to lease Hangar No. 8 at Bloyer Field. City Attorney Precour has drafted the lease which provides \$120 per month rent. The terms of the lease are standard and in accordance with other airport rentals.

Motion by Murray, second by Yarrington, to recommend the Council approve the contract between the City of Tomah and Timothy Schram for Airport Hanger No. 8. Motion carried.

## **Committee of the Whole – July 18, 2022**

### **Approval of Resolution of Restatement of City of Tomah Special Pay Plan**

This resolution is needed to continue the Special Pay retirement plan adopted in 2016. Motion by Kiefer, second by Peterson, to recommend the Council approve the Resolution of Restatement of City of Tomah Special Pay Plan. Motion carried.

### **Vacation Policy Revision**

One of the major weaknesses in recruiting applicants to the City of Tomah is our current vacation policy. The SET proposed a change to the accrual of vacation hours to assist with recruiting and retention. Motion by Yarrington, second by Murray, to recommend the Council approve the vacation policy revision as presented and to allow the SET the latitude to make decisions for anomalies for employees falling in-between the accrual ranks. Motion carried.

### **Creation of AD Hoc Committee to Discuss Combining Fire and EMS departments**

The SET has identified multiple issues that need to be addressed: the potential of combining the EMS and Fire departments, disposition of current properties Fire and EMS properties after the safety building is completed, and other issues. The SET recommends the Committee of the Whole and Council approve the formation of an AD Hoc committee to research and determine a course of action in the potential combining of departments and disposal of current buildings after the new Public Safety building is finished. Other items could be addressed by this ad hoc committee. Motion by Murray, second by Yarrington, to recommend the Council approve the Mayor's creation of an AD Hoc Committee for this purpose. Motion carried.

### **Request from Kelsey's and Smoke's Elbow Room for extension of Class "B" Fermented Malt Beverage License and "Class B" Liquor License for Special Event on August 13, 2022 and closing of the alleyway**

Annually, Kelsey's and Smoke's Elbow room host a corn boil and wish to block off the alleyway for the day to allow for alcoholic beverages to extend to the outside-designated area for this event and will be fenced off with access only from inside each establishment. Motion by Peterson, second by Pater, to recommend the Council approve the closing of the alleyway and extension of the alcohol licenses on August 13, 2022. Motion carried.

### **Approval for City of Tomah Housing Assessment Vandewalle and Associates**

Vandewalle and the Long Range Planning Committee recommend the City conduct a housing assessment that will provide the city with an understanding of the existing housing situation and identification of key opportunities for strategic action. Motion by Murray, second by Zabinski, to recommend the Council approve spending \$7500.00 for the housing assessment to be completed by Vandewalle and Associates. Motion carried.

### **Resolution Authorizing Payment of Monthly Bills**

Motion by Kiefer, second by Zabinski, to recommend the Council approve the Resolution Authorizing Payment of Monthly Bills in the amount of \$1,670,124.62. Motion carried.

### **ADJOURN**

Motion by Peterson, second by Pater, to adjourn. Motion carried. Meeting adjourned at 7:46 p.m.

Finalized election numbers will be presented for acceptance at the September meeting.

It's hard to believe, but Open Enrollment for employee benefits is right around the corner. The 2023 health benefits open enrollment period is September 26 - October 21, 2022. Wisconsin Public Employer's Group Health Insurance premium rates will be available after the August 17 Group Insurance Board meeting. Once available, they will be posted on the ETF website and shared via ETF E-mail Updates. We will get the information to the Treasurer for budgeting purposes and out to employees as soon as the information is available.

## **Director of Public Works and Utilities Report**

**August 2022**

### **1) Street Department**

The new RRFB (Rectangular Rapid Flashing Beacon) at Holton & Superior Ave, Foster & Superior Ave., Clifton & Hwy 16 and the trail crossing just North of Arthur St. have been installed. The unit at Hollister & Hwy 16 is partially functioning and we are waiting on parts to fix the unit. The streets have been paved at Nott, Brownell, & Saratoga. W Juneau near the KC Hall is being worked on currently. The Williams/Benton Street intersection near the Amtrak will follow. Other items to complete are: installation of new informational signs for the Chamber at various locations within the parks and new traffic signal poles. Working on the budget and filling any vacant positions.

### **2) Sewer Department**

Operations are normal. Gerke Excavating has started the sewer installation on W Monowa. The sludge has been hauled out leaving us with an empty containment area for a short time. Various door replacements, chip sealing and tuck pointing are completed or in process.

### **3) Water Department**

Operations are normal. We have been notified we will be required to test for PFAS and Lithium in 2023. Also the water rates will see a 3% increase starting in 2023.

## **COMBINED TACTICAL UNIT**

No report.

### **K-9 REPORT**

The Tomah Police K-9 Unit consists of Officer Adam Perkins and his partner K-9 Viktor. Officer Perkins has been employed with the Tomah Police Department since September 2011 and was selected to be the K-9 handler in late 2016.

In March 2017, Officer Perkins traveled to the Jessiffany Canine Services LLC Kennel in Iron Ridge, Wisconsin to select a K-9 partner. Officer Perkins met with the head trainer and looked at numerous dogs, ultimately selecting K-9 Viktor. K-9 Viktor is a Czech Shepherd from the Czech Republic. Officer Perkins and K-9 Viktor trained for 5 weeks at Jessiffany Canine Services and certified through Jessiffany and the American Police Canine Association (APCA) in early April.

Officer Perkins and K-9 Viktor primarily work 3rd shift but are available off duty in an on-call capacity. Officer Perkins and Viktor are also members of the Monroe County Combined Tactical Unit (CTU). K-9 Viktor is a “dual purpose” patrol dog meaning patrol work and narcotics detection. “Patrol work” encompasses handler protection, criminal apprehension, tracking, building searches, and area searches. For narcotics detection, Viktor is trained to alert on the odors of Marijuana, Methamphetamine, Cocaine/Crack Cocaine, Heroin and MDMA.

Officer Perkins and K-9 Viktor train on a frequent basis to stay proficient in the numerous tasks Viktor is trained in.

### **UTILIZATIONS OF IMPORTANCE**

**Burglary Alarm** – An alarm was sounding at an empty school. Viktor was utilized on leash to assist officers in clearing the structure.

**Burglary Alarm** – A closed business received an alarm. Viktor was utilized to hold on an exterior door while an employee made their way to the front door. The employee was working and accidentally sounded the alarm.

**Training** – Attended one day of K9 training the Prairie du Chien area with other area K9 teams.

**Demonstration** – Conducted a demonstration at Squirrel Fest.

**Vehicle Sniff** – A vehicle with two suspicious subjects inside was left parked on a public street. The subjects exited the vehicle and walked on foot. They were later contacted by officers. A K9 sniff was conducted and no indication was obtained.

**Burglary Alarm** – A closed business received an alarm and motion sensors were going off. No point of entry was located. Viktor was utilized on leash to assist officers in clearing the building. Birds set off the alarms.

**Vehicle Sniff** – A vehicle with two suspicious subjects inside was left parked on a public street. The subjects exited the vehicle immediately upon seeing a Tomah Squad. A K9 sniff was conducted and a positive indication was obtained. A search of the vehicle yielded brass knuckles and paraphernalia. The passenger in the vehicle had a warrant and was arrested.

## **INVESTIGATIONS**

### **Theft of Motor Vehicle / Operate MV without Consent / Party to Crime**

A male arrived at a Kwik Trip and entered the store while leaving the keys in his vehicle. When the male exited the store he noticed his vehicle was missing. Officers watched surveillance video from Kwik Trip and observed a SUV park next to the victim's vehicle. A passenger exited the SUV and entered the victim's vehicle. Both vehicles were observed leaving the parking lot at the same time. The vehicle was entered as stolen. Later in the shift, Neillsville Police Department contacted the Monroe County Communications Center and advised they located the stolen vehicle and had arrested two subjects from the vehicle. The subjects were transported to the Clark County Jail.

### **Poss Meth / Poss Para / Bailjumping / Obstructing / Warrant**

Tomah officers were notified of two suspicious subjects at the Tomah Public Library before operating hours. The two subjects were reportedly arguing with each other. Officers responded and made contact with the subjects. The male identified himself, but the female refused. Officers repeatedly asked the female to identify herself as they were investigating the disturbance. The female eventually identified herself. Dispatch was provided with her information and they advised she had a Warrant for her arrest. The female was instructed to stand up and put down the items she had in her hands. The female refused. The Officers were able to control the female and secure in handcuffs. A search of the female's property yielded a pipe that later tested positive for Meth. The female was transported to jail on the above charges.

### **Substantial Battery / Battery to Police Officer / DC / CDTP / DOC Warrant / Bailjumping / Felony Bailjumping**

Tomah officers were dispatched to an address for a report of a disturbance. Officers arrived and were advised the suspect had fled the scene. The caller was the mother of the girlfriend who resided at the residence. The caller stated she came to her daughter's residence as her daughter just had a disturbance with her ex-boyfriend. The ex-boyfriend confronted the mother, got in her face and threw her glasses on the ground prior to fleeing the residence. The earlier disturbance was reported to our agency but the ex-boyfriend had fled from the scene at that point as well. During the first disturbance, the ex-boyfriend got intoxicated and refused to let the female exit the residence. They fought with each other but the female was able to leave the residence with her child. The ex-boyfriend remained at the residence and damaged multiple items inside to include the fridge, walls, chairs, doors and he threw items all over the residence. Approximately two

hours later, Tomah officers located the ex-boyfriend in a vehicle in the driveway. He was removed from the vehicle and placed under arrest. Once in the back seat of the squad he began to kick the partition. Officers secured his legs in shackles and during that time he kicked a squad door which struck an officer in the head. The male was transported to the Jail on the above charges.

### **OWI 3<sup>rd</sup> / OAR-OWI Related / Poss Marijuana**

A Tomah officer was on routine patrol and observed the vehicle in front of them commit a traffic violation. The officer conducted a traffic stop and the driver refused to identify himself. The officer advised the male he was the driver and was required to identify himself or he would be arrested for obstructing. The male eventually identified himself. The male showed signs of impairment and nervousness. The male exited the vehicle upon the officer's request, but he refused to perform the Standardized Field Sobriety Tests. The male was arrested for OWI 3<sup>rd</sup> and was secured in handcuffs. A search of the vehicle yielded empty beer cans and suspected THC wax. The male consented to a legal blood draw. The male was later released to a responsible party. The male was cited and referred to the DA's Office for various offenses.

### **Retail Theft / Felony Bailjumping / Poss Fentanyl / Poss Para / Warrants X3**

Tomah officers were dispatched to Walmart for a report of a theft. Asset Protection provided a vehicle description as the suspects left the parking lot. Officers were not able to immediately locate the vehicle. However, approximately an hour later a vehicle matching the description was observed behind a seldom used storage shed. A female was observed with the vehicle, but the male that was in the area moments before was now gone. The storage unit shed building was searched with owner permission, but the male was not located. K9 announcements were given and officers heard noises coming from the woods nearby. More K9 announcements were given and the male complied with commands and exited the woods. The male was identified and had several warrants for his arrest. The female was standing with officers and dropped drug paraphernalia. She was arrested and more drug paraphernalia was located. They were both transported to jail. Walmart will request restitution for the stolen property.

### **Poss Meth**

Tomah officers were dispatched to a Kwik Trip for a report of an employee locating suspected drugs near the bathrooms. Officers determined the baggie that was dropped contained Methamphetamine. Officers watched surveillance video and observed a female drop the baggie. The female was known to officers and was a habitual offender. The female was later located, arrested and transported to jail.

### **Poss Meth / Poss Prescription Drugs without Prescription / CCW / Probation Hold**

A Tomah officer was on routine patrol and observed a vehicle being operated by a male who matched the description of a male who did not have a license. The vehicle was stopped and upon making contact the officer determined the driver was not who they thought they were. During the contact a baggie with white powder was observed on the floor and the powder appeared to be dumped. The driver stated the powder was a type of medication. The driver was ordered out of the vehicle, but kept one hand clenched closed.

The officer told the driver to open his hand. The driver then dropped small baggies that contained pill capsules and crystalline substances. Officers searched the vehicle and located an unlabeled pill bottle full of prescription pills. The crystalline substance later tested as Methamphetamine. Two capsules also contained Methamphetamine. A pair of brass knuckles were also located. The male was arrested on the above charges and was transported to jail.

**Battery / DC / Threaten Battery to Police Officer / Probation Hold**

Tomah officers were dispatched to a disturbance at a residence. Officers arrived and made contact with the reporting parties. The female stated she was in her house watching television with her child when she heard loud knocking on the door. The female stated her boyfriend woke up and they were both walking towards the door. She answered the door and found her Uncle standing there. Her Uncle then walked passed her without permission. A physical confrontation occurred between the Uncle and the male. They were wrestling and punching each other. The Uncle then left the residence and went to a camper that was on the property. Officers made contact with the Uncle at the camper. Officers determined the Uncle would be placed under arrest. The Uncle became angry and threatened to fight Officers. Due to the aggression shown and the threats, a CEW was utilized to control the Uncle. The CEW was effective and the Uncle was taken into custody. He was transported for medical clearance and then taken to jail.

Under general supervision of the Mayor and Council, the Treasurer is responsible for the preparation and maintenance of the City Budget, investment of city funds, bond issues, related state and federal reports, purchasing, city computer programs, related policy and procedures, claims against the City and the bid specification and process. This position also monitors insurance policies, workers compensation and liability claims and assists the department heads in writing and administering the grant applications. The treasurer performs the responsibilities of the office of the City Treasurer as set forth in Wisconsin Sections 62.09(9).

**ESSENTIAL DUTIES AND RESPONSIBILITIES:**

1. Responsible for the preparation, planning, and implementation of the annual City Budget. Coordinates these efforts with all city departments.
2. Establishes and maintains a central accounting system for city government and departments in a manner consistent with the accepted municipal accounting principles and practices.
3. Collects all real estate, personal property and mobile home taxes and reconcile, file and pay said taxes to appropriate taxing authorities.
4. Administer room tax reporting and collecting.
5. Administer the collections through the TRIP program and through Credit Management Control.
6. Assist the public in requests regarding property valuations and tax related questions. Assists with the day to day operations of the assessor's office in their absence.
7. Billing and maintenance of special assessment records including tax roll transfers.
8. Collects funds for ambulance payments, police department, library, court, building inspections, water and sewer, licensing, and parks and recreation programs and events.
9. Reconciliation of accounts receivables.
10. Prepares monthly and year to date financial statements for distribution to all city departments and public officials.
11. Supervises the city payroll. Responsible for all state and federal requirements and compliance issues in reporting earnings from information for the City.
12. Manages and invests the city's funds (on regulation of the State Statutes).

24. Administers disciplinary grievance processes within the treasurer's department.
25. Administers outstanding Community Development Block Grant loans, including but not limited to the servicing and collecting thereof.
26. Performs other duties as needed or assigned.
27. The City of Tomah has adopted rules and regulations established for the safety of its employees in the performance of their jobs. It shall be the direct responsibility of the department heads and the first line supervisors to be sure all employees of the City of Tomah comply with the safety rules and regulations. Department heads and first line supervisors shall establish procedures to ensure enforcement of said rules and regulations.

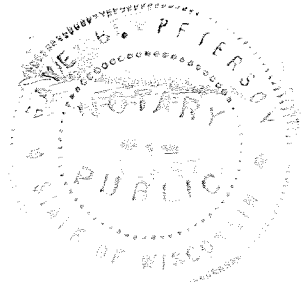

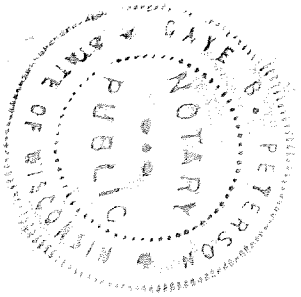

## LEASE AGREEMENT

THIS LEASE made by and between the **CITY OF TOMAH**, a Municipal Corporation, hereinafter called **LESSOR**, party of the first part, and **JOSEPH BOHM** hereinafter called **LESSEE**, party of the second part.

### WITNESSETH:

WHEREAS, the **LESSOR** owns and operates an airport known as the Bloyer Field and said **LESSEE** is desirous of leasing from the **LESSOR** a certain parcel of land on the said airport, hereinafter more fully described, for the purpose of aircraft storage; and

WHEREAS, the **LESSEE** will use the below described property for the purpose of storing aircraft and shall conduct only such aircraft maintenance on its own aircraft.

NOW, THEREFORE, for and in consideration of the rental charges, covenants, and agreements herein contained, **LESSOR** does hereby lease, demise and let unto **LESSEE** the following described premises located at Bloyer Field in the City of Tomah, Monroe County, Wisconsin, to wit:

Lot 4, Bloyer Field Airport property a/k/a Hangar No. 9

upon the following terms and conditions:

**TERM:** This Lease shall be for a term of three (3) years commencing on the 1<sup>st</sup> day of January, 2022. At the expiration of said three-year term this Lease shall automatically renew itself on the same terms and conditions, rental rate excluded, unless either party provides thirty (30) days notice prior to the date of expiration of its intent to terminate.

**RENT:** **LESSEE** agrees to pay to **LESSOR** the sum of Two Hundred Twenty and 00/100 (\$220.00) Dollars per year. **LESSOR** reserves the right to change the rental rate on the demised premises at any time provided **LESSOR** gives **LESSEE** thirty (30) days written notice

of the change.

**MAINTENANCE OF BUILDING:** LESSEE shall maintain the structures occupied by LESSEE and the surrounding land premises in good order and make such repairs as are necessary. In the event of fire or any other casualty to structures owned by the LESSEE, the LESSEE shall either repair or replace the building or remove the damaged building and restore the leased area to its original condition; such action must be accomplished within 120 days of the date the damage occurred, weather permitting.

**NON-EXCLUSIVE USE:** The LESSEE shall have the right to the non-exclusive use, in common with others, of the airport parking areas, appurtenances and improvements thereon; the right to install, operate, maintain and store, subject to the approval of the LESSOR in the interests of safety and convenience of all LESSEE'S aircraft, the right of ingress to and egress from the demised premises, which right shall extend to LESSEE'S employees, guests, and patrons; the right, in common with others authorized to do so, to use common areas of the airport, including runways, taxiways, aprons, roadways, and other conveniences for the take-off, flying and landing of aircraft.

**INSURANCE:** LESSEE agrees to provide LESSOR with a policy of comprehensive liability insurance. Such policy shall be issued by a company licensed to do business in Wisconsin and shall insure the LESSEE against loss from liability for property damage and for injury or death of any person, in an amount agreed to by the parties. LESSEE shall further be responsible for providing insurance on any property owned by LESSEE located within the demised premises.

**NON-LIABILITY OF LESSOR FOR DAMAGE:** LESSOR will not be liable for any liability or damage claims, for injury to person or property from any cause relating to the

occupancy of the premises by LESSEE. LESSEE shall indemnify LESSOR from all liability, loss or other damages, claims or obligations resulting from any injuries or losses of any nature.

**COMPLIANCE:** LESSEE shall comply with all Federal, State and local laws, regulations and ordinances.

**SIGNS:** LESSEE shall not erect any signs or advertising matter without the consent of LESSOR.

**CARE OF PREMISES:** LESSEE agrees to keep the premises in good repair and reasonably clean at LESSEE'S expense. LESSOR shall have the right to inspect the premises at all reasonable times. It is understood that LESSEE may store an airplane and related items on the premises. Storage of any other items shall not be permitted absent written consent by LESSOR.

**TAXES.** The LESSEE shall pay all taxes or assessments that may be levied against the personal property of the LESSEE or the building erected on the leased property.

**ABANDONMENT OF PREMISES:** If LESSEE shall abandon or vacate the premises, LESSOR may re-let the premises for such rent and upon such terms as LESSOR may deem fit.

**DEFAULT:** The LESSEE shall be deemed in default upon:

- a. Failure to pay rent within 30 days after due date;
- b. The filing of a petition under the Federal Bankruptcy Act or any amendment thereto including a petition for reorganization or an arrangement;
- c. The commencement of a proceeding for dissolution or for the appointment of a receiver;
- d. The making of an assignment for the benefit of creditors;
- e. Violation of any restrictions in this Lease, or failure to keep any of its covenants after written notice to cease such violation within thirty days.

Default by the LESSEE shall authorize the LESSOR, at its option and without legal proceedings, to declare this Lease void, cancel the same, and re-enter and take possession of the premises.



**TITLE:** Title to the building erected by the **LESSEE** shall remain with the **LESSEE** and shall be transferable. Notwithstanding the foregoing, in the event the Lease is terminated, title to said building shall automatically transfer to **LESSOR** at no cost.

**SNOW REMOVAL:** The **LESSOR** agrees to provide snow removal services to the **LESSEE'S** leased premises in the hangar area except within three (3) feet of hangar door. Such snow removal shall be accomplished only after all runways, apron, and primary taxiways have been first cleared.

**LEASE TRANSFER:** The **LESSEE** may not, at any time during the time of this Lease, assign, hypothecate or transfer this agreement or any interest therein, without the consent of the **LESSOR**, which consent will not be unreasonably withheld.

**AIRPORT DEVELOPMENT:** The **LESSOR** reserves the right to further develop or improve the airport as it sees fit, regardless of the desires or views of the **LESSEE**, and without interference or hindrance. If the development of the airport requires the relocation of the **LESSEE**, the **LESSOR**, in its sole option, agrees to either (1) provide a compatible location as determined by **LESSOR** and agrees to relocate the building to that location at no cost to the **LESSEE**, or (2) pay **LESSEE** the fair market value for the **LESSEE'S** building, at which time the Lease shall immediately terminate.

**AIRPORT ABANDONMENT:** If the airport is abandoned, the **LESSOR**, in its sole option, agrees to do either of the following:

- A. Provide a compatible site as determined by **LESSOR** at a new location and agrees to relocate the building to said location at no cost to the **LESSEE**, or
- B. Terminate the Lease and pay the **LESSEE** an amount determined as follows:
  - (1) If owned by an individual or business entity and not subject to depreciation or business write off:

(a) Payment of 100% of the original construction cost if abandoned within the first ten (10) years after construction;

(b) Payment of 75% of the original construction cost if abandoned within years 11-20 after construction;

(c) Payment of 50% of the original construction cost if abandoned after the 20<sup>th</sup> year after construction.

(2) If owned by an individual or business entity and hangar is subject to depreciation or business write-off:

(a) Payment of 100% of the depreciated value if abandoned within the first ten (10) years after construction;

(b) Payment of 75% of the depreciated value if abandoned within years 11-20 after construction;

(c) Payment of 50% of the depreciated value if abandoned after the 20<sup>th</sup> year after construction.

(3) Sale/Transfer:

(a) In the event an owner of a non-depreciated hangar sells or transfer the hangar to a third party where no depreciation, the new owner shall continue with the same schedule of the then existing owner with the original construction date controlling;

(b) In the event a depreciated owner sells or transfers to a non-depreciated owner, the new owner's schedule shall commence at the original construction date and at the original construction cost;

(c) In the event a non-depreciated owner sells or transfers to a depreciated owner, the new owner's schedule shall commence on the date of sale with the purchase price controlling.

**SUBORDINATION CLAUSE:** This Lease shall be subordinate to the provisions of any existing or future agreement between the **LESSOR** and the United States or the State of Wisconsin relative to the operation or maintenance of the airport, the execution of which has been or may be required as a condition precedent to the expenditure of federal or state funds for the development of the airport. Furthermore, this Lease may be amended to include provisions required by those agreements with the United States or the State of Wisconsin.

**SUB-LETTING:** LESSEE may not assign or sub-let this Lease without the express written consent of LESSOR.

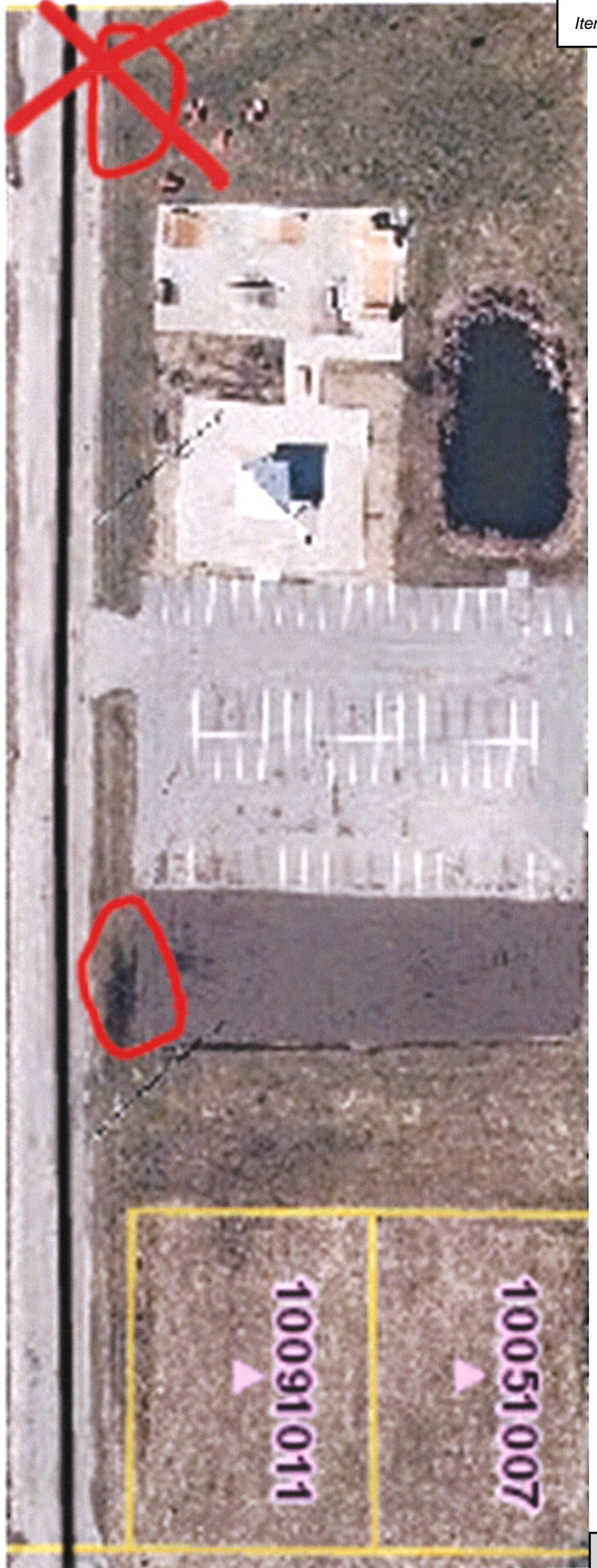
