Lake Committee

Call to Order/Roll Call: The Lake Committee met in regular session on Thursday, May 19, 2022, the meeting was called to order by Chairman Kiefer at 5:02 PM. Roll call was taken with Commissioners, Lamont Kiefer, John Rusch, Kim Mello, Hal Burnham, Duane Chapman, Kevin Arkeketa and Lee Lang. Also present, Director Kirk Arity and Warden Patrick Seybert.

Motion made by Chapman, seconded by Lang to approve minutes from previous meeting. All ayes. Motion passed.

Elect Chairman – Motion made by Lang and second by Burnham for Lamont Kiefer to remain chairman. All ayes. Motion carried. Elect Vice chairman – Motion made by Chapman and second by Burnham to elect Kim Mello. All ayes. Motion carried.

Adaptive management update: Still moving forward and working on items. May have another property that is interested in sampling.

Warden Update: Signs around the lake are now updated with new regulations. Fish kill around Butts park last week. Mostly pan fish were affected.

Weed Management: in a holding pattern for weed analysis to be done, first week of June. Kiefer and Mello are in constant contact with Golden Sands. Kiefer says he has not seen any weeds on the lake yet.

Goose Management: Mello will be going out tomorrow to check on status of nests. Found a total of 21 nests and 101 eggs.

2022 DNR fish survey: Report is not complete yet. Electro shock was successful.

Summer water testing: Burnham is continuing to take water samples and sending them to DNR for analysis.

Winnebago Park phase 1: Motion made by Chapman second by Lang to transfer \$91,000 from lake district to the City for the Winnebago Park phase 1. All ayes. Motion carried.

Additional costs for observation deck and bench area are \$3,500. This cost is to stamp concrete like barn boards to make it look like a dock. Motion made by Lang and second by Chapman. Motion carried with one negative vote (Rusch).

Tree removal process: Mr Ritter will no longer go on ice to cut trees due to liability reasons. Committee will need to think of other avenues for tree cutting in the future. Will bring agenda item back at a later date.

Lake information sign boards: Signs around the lake are less than stellar. Committee looked at different type of boards for signs around the lake. Motion made by Rusch second by Mello to move forward with the project. All ayes. Motion carried.

Discussion on monitoring water quality. Committee needs guidance from DNR and/or science departments on when water testing should be done.

Lake Committee

No boat dock approvals.

Chapman is the rep for climate change task force and he stated there is no update. Agricultural update: Spring is about 2 weeks late and causing a little stress on planting.

Chairman updates: no updates.

Future agenda items: Monroe County Land Steward donation and tree removal.

Next meeting date: July 21, 2022

Motion made by Rusch second by Lang to adjourn at 6:56 PM. All ayes. Motion carried.
