#### MEETING MINUTES - CITY OF TOMAH

The City of Tomah **Parks & Recreation Commission (PRC)** met on Monday Mar 4, 2023 at 5:45p.m. in Recreation Station, Arthur St. location. The meeting notice was posted at City Hall in compliance with the provisions of Section 19.84 Wisconsin Statutes.

Call to order and roll call; present: Dir. Joe Protz, Oak Moser, Dustin Powell, DeDe Nelson, Josephine Piper, Dean Peterson, Travis Scholze

The following members were absent: Donna Evans, Shirley Galstad-Roh

Others in attendance: Heather Wilcox

- 1. Act on Minutes of January 2024 regular meeting. A motion by Peterson, second by Scholze, to accept the minutes of the January 2024, regular meeting. Motion carried.
- 2. Act on request for use of Recreation Building to host a benefit: Heather Wilcox was present and addressed the PRC requesting a reduced rental rate to hold a benefit in the Progress Building at Rec Park, on behalf of the families and businesses impacted by the recent fire in downtown Tomah. Heather has a history of running benefits and is working with Ann Schleicher, one of the business owners impacted by the fire. The event may include auctions, sales, children's activities. Motion by Scholze, second by Nelson, to reduce the rental rate by 50% to \$275 for the requested date of April 21, and to waive the security deposit, with possibility of set up for the event on April 20 if the building is not rented for that date. Motion carried.
- 3. Request use of Veteran's Park Dog Park and Shelter for a SAAPM (Sexual Assault Awareness and Prevention Month) event: Christopher Carlson MSG USArmy has requested use of Veteran's Park Dog Park to promote SAAPM. The public is invited, the Park will remain "open" during the 8AM -3PM event. Other allied groups may participate and set up games/activities for attendees. The request includes asking for to use the nearby pavilion and for the \$60 fee to be waived for this event. Motion by Moser, second by Piper, to approve use of the Park and waiving the pavilion fee. Motion carried.
- 4. Request use of Impact Fees to repair Irrigation System at Veteran's Park Soccer Complex: Dir Protz asked the PRC to approve use of Badger Coulee Impact Fee Funds to replace/repair the irrigation system at Veteran's Park Soccer Complex. The system is 15+ years old and in need of maintenance/repair. Estimate is \$6000. Badger Coulee Fund balance stands at approx. \$37,000. Motion by Scholze, second by Nelson, to approve use of Badger Coulee Impact Fee Funds to repair irrigation system at Veteran's Park Soccer Complex as requested. Motion carried.

- 5. Request use of Impact Fees to purchase equipment for new Disc Golf Course adjacent to Firemen's Park: Dir Protz requested use of Badger Coulee Impact Fee Funds to purchase and install equipment (tee boxes, baskets, etc...) for a disc golf course adjacent to Fireman's Park. Approval is requested for up to \$15,000. Motion by Nelson, second by Piper, to approve use of Badger Coulee Impact Fee Funds for purchase of equipment to establish the disc golf course. Motion carried.
- <u>6.</u> Tomah Parks and Recreation Program Report: Dir Protz reviewed the monthly Program report.

### Memorandum of Understanding for Room Naming Rights and Facility Usage

The Tomah Lion's Club, being a civic organization with a mission of serving and giving to the community, wishes to support the Tomah Parks and Rec Department and their goal of creating community spaces in the building known as the "Recreation Station" located at 316 Arthur Street in Tomah, Wisconsin.

To help Tomah Parks and Rec achieve their goals, Tomah Lions Club will donate \$15,000 to Tomah Parks and Rec for the purpose of creating community spaces in the Recreation Station. Tomah Parks and Rec may spend the \$15,000 in any way they deem appropriate for the space.

The donation of \$15,000 will be made in equal increments of \$5,000 over the course of three years.

In exchange for the donation, Tomah Lions Club requests naming rights for the meeting room off of the kitchen at the Recreation Station and for the room to be called the "Tomah Lions Community Room". Tomah Lions also requests first right of refusal, should a situation arise in which the room would be requested to be called anything other than the "Tomah Lions Community Room".

Tomah Parks and Rec will also allow the Tomah Lions Club to decorate the "Tomah Lions Community Room" tastefully in a "Lions Club" branded fashion which may include Lion Club logos, photos, plaques, and emblems. Final decorations would be submitted for approval to the Director of Parks and Rec prior to installation.

The Tomah Lion's Club also proposes to utilize meeting space in the new "Recreation Station" to host both their monthly board meetings and their monthly membership meetings. The Tomah Lions Club meetings are on the 2<sup>nd</sup> and 4<sup>th</sup> Wednesday of each month and would utilize the room from 5:30 PM until 10:30 PM. Access will also be granted to the kitchen area and a secured storage area outside of the meeting room. Tomah Lions Club will be provided access to the secured storage area with a key or code provided Tomah Parks and Rec.

Tomah Parks and Rec will "rent" the room to Tomah Lions Club at no charge and in good faith for the foreseeable future.
