MEETING MINUTES - CITY OF TOMAH

The City of Tomah Parks & Recreation Commission (PRC) met on Monday June 24, 2024 at 5:45p.m. in Recreation Station, Arthur St. location. The meeting notice was posted at City Hall in compliance with the provisions of Section 19.84 Wisconsin Statutes.

Call to order and roll call; present: Dir. Joe Protz, Oak Moser, Dustin Powell, DeDe Nelson, Josephine Piper, Dean Peterson, Donna Evans, Shirley Galstad-Roh

The following members were absent: Travis Scholze

Others in attendance: Jeff Cram, Tina Thompson

- 1. Act on Minutes of Mar 4, 2024, regular meeting. Motion by Peterson, second by Nelson, to accept the minutes of the Apr 24, 2024, regular meeting. Motion approved.
- 2. Request the use of cell tower fees for pavement and sidewalk at Recreation Station: Dir Protz recommended use of funds from the Cell Tower Fees account for repair and paving of the parking and sidewalk areas at Recreation Station, up to \$35,000. The account currently is at \$75,875 and collects monthly deposits. Rec Station has been actively used and is experiencing rentals. The funds would be for the material, labor provided by Public Works dept. Motion by Moser, second by Peterson, to approve use of Cell Tower Fees up to \$35,000 for the pavement and sidewalk work at Recreation Station. Motion carried.
- 3. Discussion on Tomah Aquatic Center: Dir Protz reviewed the current condition of the Aquatic Center and its' extensive use this season. Currently the two large water slides are not functional, there remain some leaks underground and other concerns. This season over 300 people are enrolled in swim lessons and the Center is experience heavy use. Dir Protz is planning to contact entities that may be provide proposals to evaluate the current condition and suggest necessary repairs, maintenance, improvements in infrastructure, etc... that may ensure continued function and use of the Aquatic Center. No action taken.
- $\underline{4.}$ Tomah Parks and Recreation Program Report: Dir Protz reviewed the monthly Program report.
- <u>5.</u> Discussed any affairs and business of the Tomah Parks and Recreation Department. None presented.


