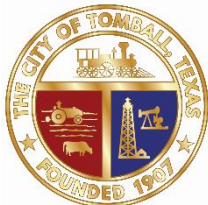


## **MINUTES OF CHARTER REVIEW COMMISSION CITY OF TOMBALL, TEXAS**

Motion made by Commissioner Kelley, seconded by Commissioner Clepper to approve Proposed Amendatory Language for Certain Provisions in Articles VI – VIII of the City of Tomball Charter as is.

Motion carried unanimously.

Motion made by Commissioner Kelley, seconded by Commissioner Degges to leave section 6.02 (D) in Article VI as is.
