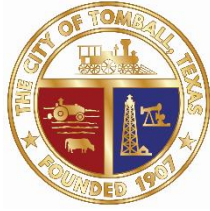


**MINUTES OF SPECIAL JOINT CITY COUNCIL AND PLANNING &
