In October 2013, City Council passed an ordinance requiring towing operators to seek a license to operate within the city; currently, ten such businesses are licensed to operate in Tualatin. One of the licensed towing operators, has requested a review of the rates previously set by the City Council, which have not been altered since they were first established. At the September 8, 2025 meeting, the City Council discussed the matter and asked that staff return with more information on what our neighboring cities and other regional comparator cities are doing to regulate private property impoundment rates.
