Work Session

- 5:00 p.m. (20 min) Tualatin Moving Forward Final Report. In 2018, Tualatin voters approved a \$20 million transportation bond to pay for projects that improve traffic flow, neighborhood safety, and provide safe access to schools and parks citywide. This Final Report reviews the projects constructed in 2023 and summarizes the program.
- 5:20 p.m. (50 min) Transportation System Plan Update. Staff and the consultant team will provide a briefing on the current process to update Tualatin's Transportation System Plan (TSP). This update will include details on the TSP goals, engagement summary, existing conditions overview, and upcoming TSP tasks.
- 3. 6:10 p.m. (20 min) Prohibition and Regulation of Camping on Public Property Ordinance Check-In. The City Council adopted Ordinance 1475-23 in June 2023, which prohibited and regulated camping on public property in Tualatin. As part of the City Council's discussion, they requested an update on implementation of the ordinance after

approximately six months' time. Staff is looking for direction from the City Council as to whether there is a desire for any changes to the ordinance at this time.
