Special Reports

1. Outside Agency Grant Awardee- Love Inc

Love Inc. Executive Director Ken Caron thanked the Council for their contributions to the organization. He shared client impact stories.

2. Summer Programs Preview

Recreation Manager Julie Ludemann and Public Services Manager Sara Jesudason presented the summer program preview. Manager Ludemann announced that Blender Dash will be held on June 8th at Tualatin Community Park, expecting to host between 800-1,000 youth. Manager Jesudason detailed the Library's summer kickoff weekend from June 14-16, themed "Read, Renew, Repeat." They will feature Maker in Residence workshops, sound baths, and music in the library, alongside their regular programming. Manager Ludemann mentioned that Viva Tualatin will take place on July 13th at Tualatin Community Park. She also noted that youth summer camps, spanning eight weeks, will accommodate over 500 kids. Additionally, Concerts in the Parks will be held on Fridays throughout July and August.

Manager Jesudason highlighted the involvement of library and event volunteers in various summer programs and events, such as Blender Dash and Viva Tualatin. She also mentioned that Parks volunteers, including TEAM Tualatin, Hug a Park/Trail/Tree, and DIY Volunteer programs, will be actively participating throughout the summer.

Manager Jesudason stated that the Police Department will be hosting four week-long HEROES Summer Camps and National Night Out on the first Tuesday in August. Manager Ludemann added that the Juanita Pohl Center will be offering wellness and longevity activities, as well as trips and travel events, from June through August.

Manager Ludemann also mentioned that they will be partnering with additional recreation programs such as Skyhawks Sports Camp, Tualatin Youth Sports Leagues, Tualatin Historical Social, and Tualatin Pickleball Club.

Councilor Brooks inquired about the locations of the evening concerts in the parks. Manager Ludemann responded that the concerts will be held in Community Park and several neighborhood parks, and she encouraged everyone to check the website for exact locations.

Council President Pratt asked how someone can volunteer. Manager Ludemann stated that information on how to volunteer is available on the website.
